Introduction

The year 2022 marks the beginning of the mandate of a new IUSSP Council and the gradual return to in-person events after a 2-year hiatus due to the Covid pandemic. Several IUSSP Panels organized in-person meetings including a 3-Panel mini-conference held in Madeira, Portugal. Virtual meetings remained important, however, for conducting Council business and Scientific Panel working meetings, and the IUSSP continues to promote webinars to reach out regularly to IUSSP members and the broader public interested in population issues. The new Council began its four-year mandate by launching a call to members for new scientific activities, organizing a membership survey, reviewing the virtual International Population Conference of 2021, and beginning the planning for the 2025 International Population Conference that will take place in Brisbane, Australia 13-18 July 2025.

New Council

The 2022-2025 Council held several virtual meetings to start off its mandate and launched a call to the members for new Scientific Panel proposals. Joining initiatives from the international scientific community, the Council drafted statements opposing the Russian invasion of Ukraine and drawing attention to the negative global impacts on women's health of the US Supreme Court's overturn of Roe vs. Wade granting women access to legal abortion. <https://iussp.org/en/iussp-statement-restricting-access-abortion>.

New IUSSP Scientific Panels

The Council approved the creation of seven new Scientific Panels which started their activities between the end of 2022 and the beginning of 2023. The panels include:

- Armed Conflict and Demographic Impacts, with a special focus on the war in Ukraine,
- COVID-19, Fertility, and the Family,
- Declining Mortality and Multi-morbidity at Death,
- Epidemics and Contagious Diseases: The Legacy of the Past,
- Lifetime Migration,
- Population Dynamics under Global Conflict and Climate Change,
- Rethinking Family Planning Measurement with a Reproductive Justice and Rights Lens

In addition, the Council established a Panel on [Early Career Perspectives](#), composed of early career members, to increase the inputs of the next generation of population experts in the activities of the IUSSP.

International Population Conference

IPC 2021

The report and evaluation for the virtual IPC 2021 was completed in early 2022 providing the Council useful information on attendance in the virtual sessions and views of the conference recordings, which were available for all of 2022, as well as information on the experience of those participating in IUSSP's first fully virtual conference. Access to the IPC 2021 Conference platform came to an end in 2022, but recordings of a selection of sessions have been posted to [IUSSP's Youtube channel](#). Planning for the 2025 International Population Conference

The IUSSP Council began preparations for the 30th International Population Conference, which will take place in Brisbane, Australia, 13-18 July 2025. A call for session proposals was sent out to the membership to increase the number of members involved in creating the scientific programme for the 2025 conference.

Given the location of the venue in Australia, this will be an in-person conference as the time zone of the venue limits virtual participation from other regions, making it difficult to justify the costs of hybrid facilities, especially as virtual attendance in sessions for IPC2021 proved to be disappointingly low. The organizers plan, however, to live-stream some sessions such as the plenaries.

IUSSP officers and Executive Director travelled to Australia to visit the venue in Brisbane and meet with the future organizers and national host for the Conference. IPC 2025 will convene at the Brisbane Convention and Exhibit Centre (BCEC), a state-of-the-art conference facility located in the South Bank Parklands along the Brisbane River. The conference will be held in July to enable participants to combine the trip with vacation. The national organizers are planning to offer several pre-conference workshops the week preceding the conference to offer more opportunities for participants to hone new skills and develop networks with Australian colleagues and those from other regions. The pre-conference programme will make the (long) trip to Australia even more attractive!

Scientific activities

IUSSP Scientific Panels organized 13 in-person and virtual meetings in 2022 involving over 359 participants, 198 of whom are from a low- or middle-income country. IUSSP provided travel funding to 116 participants from grants earmarked for these activities. Activities included one cyber seminar¹, one virtual seminar, three training workshops, three webinars, one in-person mini-conference, and four in-person sessions organized at conferences of other organizations and disciplines. In addition, the Panels on FAIR Vocabularies and Contraceptive Transition Theories conducted bi-weekly and monthly virtual meetings to carry out their panel's work. ¹ A cyber seminar is conducted via an email list serve or Google group; communications and comments on the seminar topic take place asynchronously over a period of a week to 15 days. Concept papers drafted by experts in the topic are shared prior to the cyber seminar. A moderator starts off the email discussion thread with questions to the authors. Usually, 10 to 30 people exchange messages which go out to all who are in the Google group (approximately 400 to 600 individuals).

IUSSP special projects

The IUSSP has four special funded projects, three funded by the Bill and Melinda Gates Foundation that focus on contraception, family planning and unwanted pregnancy and another one on Civil Registration and Vital Statistics funded by IDRC Canada. IUSSP has also partnered with the Committee on Data (CODATA) of the International Science Council on a project to develop FAIR vocabularies to link demographic data.

IUSSP Initiative on Population Registers, Ethics and Human Rights

International Development Research Centre (IDRC), Canada

The [IUSSP Scientific Panel on Population Perspectives and Demographic Methods to Strengthen CRVS Systems](#) (2019-2022) received a new two-year follow-up grant from the International Development Research Centre (IDRC, Canada) to advance the Panel's work on ethics, human rights and civil registration systems. The overall purpose of this initiative is to infuse interdisciplinary perspectives, drawing from law, history, economics, public policy, demography, and public health, to address emerging ethical and human rights challenges as population register systems are modernized and digitized.

The grant provides one-year residential fellowships to three early-career researchers and practitioners. The fellows were selected through an open call for applications in 2022. They will be hosted at the Wits Institute for Social and Economic Research (WiSER) in South Africa and the Initiative for Social and Economic Rights (ISER) in Uganda. The project draws on new interdisciplinary collaborations between these institutions, IUSSP, and the University of Southern California Institute on Inequalities in Global Health.

IUSSP-CODATA Working Group on FAIR Vocabularies

The [IUSSP-CODATA Working Group on FAIR Vocabularies](#) is a joint initiative with CODATA, the Committee on Data of the International Science Council. This IUSSP Panel was set up as a response to the growing movement to make data "Findable, Accessible, Interoperable, and Reusable" (FAIR). In 2022 the Panel engaged with more than 25 scientists

and representatives from academia and international agencies through biweekly virtual meetings to investigate the potential to create a FAIR vocabulary for demography and the population sciences. At the end of 2022, they finished a draft of their recommendations, which will be shared in 2023.

Elevating Family Planning in Urban Development (The Bill & Melinda Gates Foundation)

The Bill & Melinda Gates Foundation provided a grant to IUSSP in 2018 to produce policy-relevant evidence on the effects of family planning and fertility change on urban welfare. The grant supports fellowships to 15 early-to-mid career researchers in sub-Saharan Africa to conduct research and is overseen by the [IUSSP Panel on Family Planning, Fertility and Urban Development](#). The Grant has also funded ancillary research by post-docs. The African Population and Health Research Centre (APHRC) partnered with IUSSP to provide training and support for policy engagement and communication. Two key objectives of this grant were to bridge intersectoral gaps between policy and research and between family planning and urban policy, and create a network of early career researchers working on these issues who were well trained in policy communication and engagement.

The Covid pandemic hampered fellows' research progress and greatly limited opportunities to network in 2020-21, but in 2022, as many fellows were completing their research, the project was able to support their participation in several in-person workshops and conferences. Fellows published 6 articles in peer-reviewed journals. The Panel organized a mini-conference and several training workshops to develop the fellows' policy engagement and communication skills. They also participated in conferences on urban policy, urban health, and family planning including the Africities Summit 2022 in Kisumu, Kenya organized by the United Cities and Local Governments of Africa (UCLGA), the 18th International Conference on Urban Health (ICUH), in Valencia, Spain 25 October and the 6th International Conference on Family Planning (ICFP), which took place in Pattaya, Thailand 13-18 November. The project received a no-cost extension to 30 June 2023 to enable fellows to complete their research analysis and policy engagement activities with urban policy makers and community stakeholders.

Contraceptive Transition Theories: Models for Contemporary Patterns of Use (The Bill & Melinda Gates Foundation)

The Bill & Melinda Gates Foundation grant for this project ended in 2022. The grant provided funding for the [IUSSP Scientific Panel on Contraceptive Transition Theories: Models for Contemporary Patterns of Use](#) to articulate and critique theoretical perspectives on the forces driving historical change in the prevalence of contraception. In 2022, the Panel prepared the final drafts of articles for a special issue to be submitted to *Population and Development Review*. These final drafts were presented and discussed at the 3-Panel mini-conference in Madeira, Portugal held 11-15 July. The Panel organized a session on Contraceptive Transition Theory: Critique and Reformulation at the Sixth International Conference on Family Planning (ICFP), in Pattaya City, Thailand, 15 November. This panel's work has mostly been carried out through monthly virtual zoom meetings with Panel members and authors.

Catalyzing Innovation in Measurement of Unintended Pregnancy and Fertility Intentions (The Bill & Melinda Gates Foundation)

The IUSSP Panel on Abortion Research completed their summary report based on the presentations at the IUSSP virtual workshop on "Measurement of pregnancy intention and unintended pregnancy and birth", held in May 2021. The publication, [Methodologies for Measuring Pregnancy Intention and Unintended Pregnancy and Birth](#), is available on the

IUSSP website. The Panel and authors met for an in-person seminar at the 3-Panel mini-conference in Funchal, Madeira, 12-15 July where the authors and panel members had the opportunity to meet to discuss the panel's work with members of other IUSSP Panels working on reproductive health issues as well as ideas for future work in the areas of abortion research, fertility, family planning and sexual and reproductive health.

IUSSP publications

N-IUSSP

The IUSSP magazine N-IUSSP disseminates scientific findings from demographic research carried out by IUSSP members and other population researchers from across the world and is available to all IUSSP members. In 2022, N-IUSSP published 48 articles. The N-IUSSP website received 114,031 page views from 70,951 users. Subscriptions to the N-IUSSP newsletter increased from 745 on 1 January to 1,898 subscribers on 31 December. All N-IUSSP articles and “Did you know?” features are available at: <http://www.niussp.org/>. In addition, N-IUSSP began an eBook series in 2021 with several eBooks to be published in 2023.

IUSSP communications and website

The IUSSP website is regularly updated by the Secretariat with information on IUSSP activities and events, as well as those of other organizations in the population field or in related fields: information on forthcoming conferences, calls for papers, fellowships and job announcements, and members' recent publications and activities. In 2022, the Secretariat sent 241 email announcements to members and produced 4 newsletters.

In 2022, the IUSSP website (<https://iussp.org>) saw a 37% decrease in the number of visits and users, bringing totals back to slightly higher levels than 2020, which is to be expected in the year following the International Population Conference, which draws a large number of visitors to the IUSSP website. In 2022, there were **210,665 page views** versus 333,333 page views in 2021 and 205,428-page views in 2020. The number of users decreased by 12% from 106,450 users in 2021 to **93,342 users in 2022** (compared with 63,010 users in 2020). The top ten country origins for website visits in 2022 were the United States, India, China, Philippines, United Kingdom, Germany, France, Nigeria, Canada, and the Netherlands. The most popular pages were "What's New" (44,482 views) and the IUSSP Home Page (10,022 views), the "What is Demography" page (16,317 views), and the IUSSP membership directory profile (12,866 views). The IUSSP Tools for Demographic Estimation website had 62,240 views and 37,940 users in 2022.

Twitter: In 2022, the Secretariat sent 76 tweets. The IUSSP has 4,165 followers on Twitter and 1,600 on Facebook.

Website overhaul

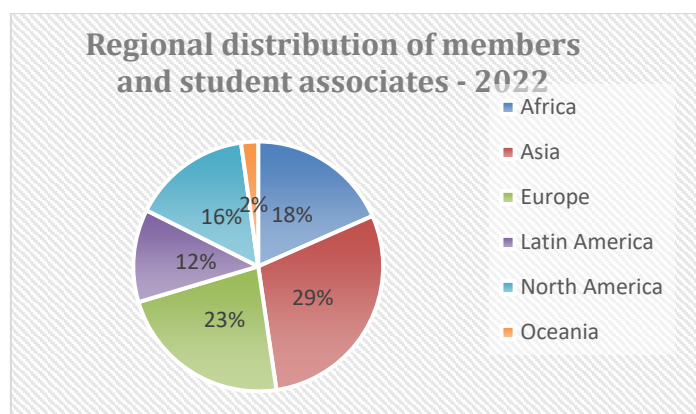
In 2022, the IUSSP Secretariat began an overhaul of its website with Fuzion to upgrade to Drupal 9, as the current version, Drupal 7, will no longer be supported. The overhaul will be completed in 2023. As part of the overhaul the website will be moved to a new server managed by Fuzion. We hope the upgrade will result in improvements for members and the Secretariat.

IUSSP outreach to international and regional partners

In 2022, the IUSSP reinforced partnerships with a broad range of organizations and institutions. Ties with national and regional Population Associations (ALAP, APA, EAPS, PAA and UAPS) were reinforced by initiating an Early Career Award for five world regions. The IUSSP Panel on [International Migration: Strengthening the Knowledge Base for Policy](#) participated in the 77th Session of the United Nations General Assembly delivering a statement on International Migration and Development. Through the work of IUSSP Panels the IUSSP has developed new partnerships and initiatives with the International Science Council, CODATA, the Global Partnership for Sustainable Development Data, African Population and Health Research Center, the Wits Institute for Social and Economic Research (WiSER) in South Africa, the Initiative for Social and Economic Rights (ISER-Uganda), and the University of Southern California Institute on Inequalities in Global Health.

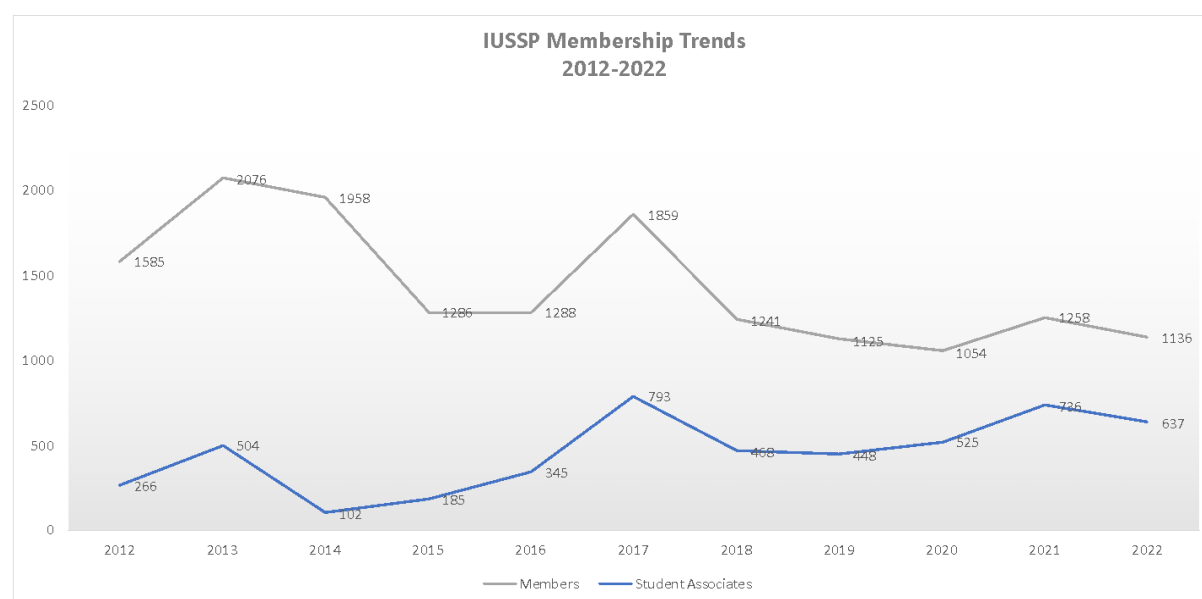
Membership

As of 31 December 2022, the IUSSP had 1,136 full members and 638 student associates from 113 countries representing 121 nationalities. IUSSP members and student associates are relatively balanced across the globe.



Membership trends show a decrease compared to 2021, which was to be expected in the year following the International Population Conference. It is a much smaller drop than in 2018 after IPC 2017 in Cape Town. Of greater concern is that Covid and a virtual IPC 2021 hindered the recruitment of new members that usually takes place in the year of the International Population Conference.

In 2022, 21 new regular members and 94 new student associates joined the Union. Women comprise 46% of the full members and 52 % of the student associates. The IUSSP special Covid membership rate was changed to a hardship rate so that all members wherever they are located could opt for a low dues rate if experiencing financial difficulties; 10 members took advantage of this reduced rate in 2022.



In preparation for the website overhaul, the Secretariat sent a survey to 4,143 current and former (since 2017) IUSSP members and student associates; 930 people responded to the survey that covered membership and the website. Most respondents reported that they joined the IUSSP either to attend an IPC conference or to be part of the network. They provided many suggestions for improvements to the website as well as many requests for regionally centered activities or features. The survey also asked about their potential participation in the 2025 International Population Conference in Brisbane, Australia: 57% indicated that they plan to attend IPC 2025.

IUSSP Laureate award

The IUSSP Council elected Peter McDonald as its 32nd IUSSP Laureate. The award was bestowed during a virtual award ceremony that took place on 30 June 2022 with over 100 attendees. Tributes from Peter McDonald's colleagues and former students highlighted his many contributions to the advancement of population science under four categories: original contributions to demographic research and demographic theory; service to the scientific discipline of demography; contributions to the training of demographers; and service to governments in relating demographic theory and research to policy and planning issues. He is best-known for his work applying gender equity theory to fertility and for his research on nuptiality and culture in developing countries. He was instrumental in establishing a master's degree program in demography in 1976 at the Australian National University. His talent to communicate research to policymakers influenced Australian government policy and programmes on international migration, workforce, family, social inclusion, fertility and ageing policies. He served 12 years on the IUSSP Council (from 2001 to 2013), as a Council Member and as Vice-President and President, where he contributed to making the Union's activities more open and accessible.

Secretariat

IUSSP activities, membership, website and projects are supported by the Secretariat based at the French National Institute for Demographic Studies (INED) on the Campus Condorcet in Aubervilliers, France. In 2022, due to declines in core grant funds from donors and revenues from membership fees, the Council made the difficult decision to restructure the Secretariat eliminating the post of membership officer and webmaster. Those tasks were reassigned to other staff. The Secretariat currently has 3 full time staff members.

Management and finances

In 2022, IUSSP income totalled €2,102,307 while the operating budget was €2,105,743; this resulted in a small net negative balance of €3,436. The following provides information on activities for 2022 from **the IUSSP Statement of Activities and Changes in Net Assets for the years 2018-2022 (Annex 1)**.

Income

Grants: IUSSP received €329,661 in grants from private foundations and governments to support scientific activities and operational costs in 2022, distributed as follows: €234,661 in grants for special projects and €95,000 in grant funds for general operating costs or activities. In addition, €1,537,663 in tied funds for multi-year grants awarded in previous fiscal years was available for the Urban Family Planning, Civil Registration and Vital Statistics (CRVS), Contraceptive Transitions, and Unwanted Pregnancy project activities carried out in 2022. Included in this amount were funds to cover direct staff costs and overheads. The IUSSP received a core support grant from the William and Flora Hewlett Foundation for 2022-2025; €80,000 of this grant is included in the 2022 accounts as grant income and €401,371 is held as prepaid revenue to be included in future fiscal years.

IPC registration fees, membership dues, gifts, investment income, and exchange rate gains

The IUSSP received €20,534 in revenue for 2022 membership dues, €1,438 in gifts and €327 in royalties. IUSSP also earned €180,625 in exchange rate gains on accounts held in USD;

these gains were offset by €147,584 in exchange rate losses, which resulted in a net exchange rate gain of €33,041. In 2022 the IUSSP earned €32,029 from investments.

In addition to the direct financial support received from donors and institutions for operations and scientific activities, the IUSSP leverages additional "in-kind" support through Panel members and other member volunteers and their institutions, which we have not included in our accounts. The French National Institute for Demographic Studies (INED) provides IUSSP with office space and services which were evaluated at € 18,968 in 2022.

Expenses

The IUSSP operating budget for 2022 was €2,105,743. Expenses include:

Scientific Activities: IUSSP spent €916,106 on direct scientific and training activities (excluding IUSSP staff time inputs for those projects), including the following special projects: Urban Family Planning Project, the Panel on Contraceptive Transitions, the project on Unwanted Pregnancy and the project on Strengthening Civil and Vital Registration Systems. The IUSSP paid €47,492 to cover publications including costs of N-IUSSP, and other costs associated with the IUSSP website and the IUSSP webinar series. IUSSP spent an additional €11,250 on remaining expenditures associated with organizing and hosting the virtual International Population Conference in December 2021.

General operations and salary cost: The IUSSP spent €322,018 on Secretariat salaries and related taxes and social security costs; this included compensation costs for the departure of a secretariat employee. IUSSP spent €22,985 on accounting and auditing services, €28,957 on office supplies, legal and banking fees, website update, internet and diverse software fees, and miscellaneous office expenditures.

IUSSP governance costs came to a total of €11,250 covering expenses associated with IUSSP Council and Bureau meetings and outreach to regional associations.

Foreign Exchange Loss and investment services and taxes: IUSSP incurred €147,584 in exchange rate losses on transactions in other currencies and US dollar accounts, though overall we had a net gain of €33,041. The IUSSP incurred \$22,386 in charges on investment services on its US and Euro mutual fund investments and paid €484 in taxes on investment earnings.

Tied funds: €575,247 has been set aside from grant funds received in 2022 and previous years as dedicated (tied) funds to cover future expenditures for the following special projects: Urban Family Planning and Contraceptive Transition Theories (funds from the Bill & Melinda Gates Foundation), and the IUSSP Initiative on Population Registers, Ethics and Human Rights with funds from the International Development Research Centre (IDRC), Canada.

Reserves

As of 1 January 2023, the total IUSSP reserves stood at €2,039,625, with €311,405 in general reserves and €1,131,656 in project reserves earmarked for specific activities. €596,594 has been set aside for contingencies.

Investments

IUSSP has assets in several investments. At the end of 2016, the IUSSP opened two mutual funds managed by CIC Banque Transatlantique: one in USD (US\$ 150,000) and one in Euro (€400,000) for a combined value of €511,902 at the end of 2022. The capital investment with Finaveo (life insurance), subscribed at the end of 2010 (€500,000), had a total estimated value of €630,233 at the end of 2022.

Secretariat headquarters

The French National Institute for Demographic Studies (INED) hosts the IUSSP Secretariat in its offices on the Campus Condorcet located just north of Paris, at 9, cours des Humanités – CS 50004, 93322 Aubervilliers Cedex, France.

The Secretariat currently has three permanent staff members and one who works part-time to coordinate IUSSP scientific activities and publications, communicate with IUSSP members, donors and the public, maintain a website, and coordinate fundraising and reporting to IUSSP donors. In addition to the Secretariat staff, IUSSP has also engaged short-term consultants to assist in managing activities related to funded projects.

Auditor

The IUSSP 2022 audited accounts were prepared by our external accountant, Florence Reboul at 3A-FR, and were verified by our auditor, Mazars. For further details on IUSSP revenue and expenses in 2022, see the Statement of Activities and Change in Net Assets for the year ended 31 December 2022. The table includes comparable data for 2018-2022. The Statement of Financial Position as of 31 December 2022 shows IUSSP's total assets and liabilities for 2018-2022.

Donors

In 2022, the IUSSP received support from governments, private foundations and other agencies, including the Bill & Melinda Gates Foundation, the William and Flora Hewlett Foundation, IDRC-Canada, and the French National Institute for Demographic Studies (INED) and other donors. In addition to its financial support, INED also provides office space and numerous services to the IUSSP, for which the Union is very grateful. Several members of the IUSSP made generous gifts to the organization in 2022. IUSSP gratefully acknowledges the financial and in-kind support of all institutions and individuals.
