Background

The Panel on *International Migration: Strengthening the Knowledge Base for Policy* was constituted in 2018 to meet the articulated need for scientific theory, evidence and analysis of current and future trends and patterns of international migration, and also of the causes and consequences of these movements in population, in order to inform policy and programmatic responses to migration and migrants. The work of the Panel was extended in 2023 with a more cogent title: *Priorities in International Migration Research*. The general charge of the Panel remained the same but with specific objectives:

- i. Preparation of working documents to continue the advancement of a world migration survey:
- ii. Completion and development of training materials for international migration analysis and research;
- iii. Following a consultative process, preparation of an agenda of priorities, opportunities and strategies for international migration theory and empirical research for the near future.

Documents prepared by the Panel:

The paper, "The Case for a World Migration Survey," authored by Panel members, Marcela Cerrutti, Philippe Fargues, Mariama Awumbila, was published in the IUSSP Policy and Research Paper series in 2021 (No. 25) Their analysis addresses the need and rationale for an initiative to generate international comparable analysis of the causes and consequences of international population movements, analogous to the conceptualization of the World Fertility Surveys of the 1970s and complementary to the extant program of Demographic and Health Surveys. Also addressed and illustrated were key methodological issues, including challenges, in both survey instrumentation and sampling design.

To complement this conceptual analysis of a world migration survey, the Panel requested a paper addressing technical dimensions of generating nationally representative data survey methodologies. In 2025 the working paper, "The Potential of Household Surveys for Studying International Migration, was prepared by Marcela Cerrutti and David Glejberman. The paper reviews principles of research design vis a vis international migration, sampling design, measurement, questionnaire organization and modules, and field implementation. Cerrutti and Glejberman seek provide practical perspectives on migration estimation – in the form of strategies - for the collection of data on international migration within extant national household and labor force surveys.

Guy Abel, Jamed Raymer and Ellen Percy Kraly continue their preparation of training materials on the measurement and estimation of migration using R. Building on his international program of training workshops, Guy Abel and colleagues are expanding his workshop materials to become an open-access teaching manual. Collaborating at Australian National University as well as virtually, the authors continue to make progress finalizing the manual "Handling, Measuring, Estimating and Visualizing Migration Data in R." Publication of the manual is anticipated in 2026.

The work of IUSSP and the Panel on Priorities in International Migration Research was highlighted in the UN ESCAP *Asia-Pacific Migration Report 2024 Assessing Implementation of the Global Compact for Migration* (p. 113) (prepared by Ellen Percy Kraly).

Training Activities:

Throughout the tenure of the scientific Panel, Guy has conducted training workshops on the analysis of international migration using R. The inaugural workshop (two days) was held in 2019 at the Asian Demographic Research Institute at the University of Shanghai. Since that time Professor Abel has conducted workshops at the International Population Conferences in 2021 and 2025, as well as at the 2nd International Forum on Migration Statistics in Cairo. Interest in these workshops has been robust, with often over 50 registrants at each workshop.

Summary and recommendations

The activities of the Panel on Priorities in International Migration Research have advanced the literature of the population sciences concerning the significance and implementation a world migration survey. In both papers and presentations before professional and governmental audiences, contributors to the Panel have addressed both the conceptual dimensions of migration measurement within the context of survey methodologies as well as issues and challenges of measurement of migration flows, stock and characteristics. Kraly discussed the working paper on the use of national household surveys for the estimation of international migration at the 4th International Forum on Migration Statistics which lead to requests to receive the paper from international statisticians and migration researchers.

The fact that the work of the Panel on advancing a world migration survey is placed within the context of new UN recommendations on international migration and refugee statistics and thus creates linkages between the population sciences and international efforts to promote comparability in international migration, mobility and displacement analysis. *In this regard, advocacy for the pilot of an international migration module within extant national household surveys in two countries is warranted.* IUSSP should pursue funding for two national statistical offices from countries share share bilateral migration flows to collaborate on a project of comparative migration analysis using national sample survey methods and adopting definitions of international migration recommended by the United Nations Statistical Commission.

A very significant contribution of the Panel on Priorities in International migration Research has been the focus on training graduate students and national statisticians in the fundamentals of migration research – conceptualization, measurement and analysis. Engagement of the next generation of population scientists in migration studies is critical to both the future of demography as a scientific endeavor as well as for building an empirical and rigorous foundation for migration policy analysis. *The recommendation for the IUSSP to expand curricula for migration studies derives from the instructional work of the Panel*.

Finally, members of the IUSSP should be encouraged to continue the work of the Panel of Priorities in International Migration Research to communicate the fundamental relevance of the demographic analysis of migration for public policy across a wide range of policy sectors: migrants and immigration, displacement, human rights, social and economic development, health and the environment, <u>The case for evidence based population and migration policy should be made throughout the initiatives and publications of IUSSP. Whenever possible and appropriate, we – the IUSSP - should be fully present and vocal "at the table" within international and regional convenings – articulating and demonstrating the essential role of a demographic perspective on migration for the crafting policies and programs concerning sustainable development at all scales - global, regional and local - in this 21st century,</u>
