REPRODUCTIVE HEALTH AND RIGHTS



REPRODUCTIVE **HEALTH**

Reproductive health refers to the direct servicing of an individual's reproductive needs



REPRODUCTIVE RIGHTS

Reproductive rights are the individual legal rights to reproductive health care services with a focus on keeping abortion legal, standardizing sex education, and increasing access services.

REPRODUCTIVE JUSTICE

Complete physical, mental, spiritual, political, economic, and social well-being of all people, and will be achieved when people have the economic, social and political power and resources to make healthy decisions about our bodies, sexuality and reproduction for ourselves, our families and our communities in all areas of our lives.

O2 FRAMEWORK

REPRODUCTIVE JUSTICE FRAMEWORK

Every individual has the human right to:

- Maintain personal bodily autonomy;
- Have a child;
- Not have a child;
- Parent the children we have in healthy, safe, and sustainable communities.

KEY CHARACTERISTICS

Reproductive Justice:

- Centers the lived experiences of marginalized people
- Uses a human rights framework and is grounded in Black feminist theory
- Includes an analysis of the effects of intersecting forms of oppression, or intersectionality
- Identifies reproductive oppression as the primary problem

defined as the control and exploitation of individuals through our bodies, sexuality, and reproduction (both biological and social) by families, communities, institutions, and society **Economic**Justice


"Reproductive Justice addresses the social reality of inequality, specifically, the inequality of opportunities that we have to control our reproductive destiny."
