Introduction

In 2012 the International Union for the Scientific Study of Population continued its work to promote population science, foster international networks of population scientists worldwide and support interaction between research and policy. The major activities of 2012 included the installation of a new website, membership management software, and Conference software to manage submissions to the Call for Papers for the 27th International Population Conference. In addition the IUSSP maintained an active programme of seminars and workshops. Several distance training projects begun in 2010-2011 are also nearing completion and materials are now available on the IUSSP website.

This annual report highlights recent outcomes of training activities and investments in the website and provides information on IUSSP scientific panels and seminars and the organisation of the 27th International Population Conference, which will be held in Busan, Korea 26-31 August 2013.

Website developments

The new website, membership management software, and online Conference abstract submission and review software were open for use in October 2012, just in time for authors to submit abstracts to the Call for Papers for the International Population Conference. The system which was customized and installed by Actualys, a Paris web development company, modernizes the IUSSP website and membership management systems. All Secretariat staff will now have access to administration interfaces and dashboards that provide access to membership and Conference information and permit staff to edit information and add notes as required.

The Conference software in addition to allowing the online submission and review of submitted abstracts will link for the first time authors of papers on the scientific programme with their IUSSP membership status, Conference registration, and applications for travel support. Linking these databases will enable IUSSP to better manage travel support requests, and, more importantly, anticipate attendance at conferences by showing authors who have registered to attend as well as those authors who have requested travel support.

The new website offers a more modern and attractive layout and can be easily updated by all Secretariat staff. This will make it possible to update the website more frequently and provide more information. The use of Drupal for the website should also make it possible to add new features in the future.

There are also new features for members. Members now have their own detailed member profile page which they can update to include a short professional biography, information on publications, grants and awards, as well as an uploaded file containing a curriculum vitae, and even a photo. An advanced search feature enables any member to search the membership database by area of research or specialization, language, institutional affiliation, country of residence, etc. These features should facilitate networking between members who are looking for those with expertise in a particular topic or work in a particular region or country.

The implementation of association management software completes a shift begun several years ago from annual membership to date-to-date or rolling membership. Members will now have access to membership services and benefits via the IUSSP website for a period of one year beginning with the date of payment. Late payments will automatically cover back-owed dues up to 6 months. This will result in an initial decrease in the numbers of members listed

in this year's report (1,585 members) as members whose membership expired in 2012 are no longer included in 2012 membership figures. In the long run the system should regularize membership payments by closely linking membership status with access to online benefits.

Implementing the new website and associated software, especially the development of Conference software, was far more time consuming than expected due to the complexity of the project. There were also delays on the part of the developers due to a loss of key team members early in the project. The delivery of features was initially planned in two stages with a first set of features delivered in November 2011 and the final set of features delivered in March 2012. In the end, the new website, association management software and part of the Conference management software were only partially complete when the new website opened in October 2012 so that authors could submit their abstracts to the Call for Papers for the 27th International Population Conference. The Conference software was not entirely completed until the end of 2012 and there are still a number of bugs to be repaired. The bulk of the work of updating the website and adding pages in French remains to be done by the Secretariat in 2013.

XXVII International Population Conference

Preparations for the Conference to be held in Busan, South Korea 26-31 August 2013 began in earnest with the announcement of the Call for Papers, which included 21 themes and 164 session topics. Authors based in 128 countries submitted a record of 4,048 abstract submissions. The Theme Conveners and Session Organisers reviewed the papers and created a total of 257 regular sessions and 20 poster sessions which altogether include 1,800 scientific communications. Over 3,000 authors from 115 countries will be represented on the Conference Programme. The International Organising Committee for the Conference met in early 2013 to approve the Scientific Programme and the preliminary Conference programme is available to the public on the IUSSP website.

Following the Korean National Organising Committee announcement that they could not raise funds to cover simultaneous translation between French and English in 2011, the IUSSP Council voted to support simultaneous translation of presentations at the Conference from French to English to maintain the multilingual character of the International Population Conference. The French National Committee of the IUSSP in collaboration with the Association Internationale des Démographes de Langue Française (*AIDELF*) are seeking funding for translation and have recruited a translation company in France to hire translators and manage translation from French to English. The IUSSP Council agreed to provide 50,000 euro in matching support for translation in addition to covering the costs of translation booths for 9 of the 15 meeting rooms.

IUSSP Seminars, meetings and training activities

In 2012, IUSSP Scientific Panels and collaborating institutions organised eighteen scientific meetings including ten seminars, three training workshops, a cyber-seminar, three meetings to promote IUSSP distance learning materials in demography at regional conferences, and a planning meeting. Approximately **440 individuals directly participated in IUSSP scientific activities delivering 160 papers and communications**. Another 664 registered for PERN cyberseminars and received cyberseminar postings by email. In order to facilitate the participation of students and scholars from developing countries the IUSSP provides some travel support when funding is available. In 2012, the IUSSP provided **direct support for travel to 81 IUSSP members from developing countries** to attend an IUSSP seminar or training workshop. Panel members and the IUSSP Secretariat raised and managed funds from

seven donors to provide travel support and collaborated with 23 institutions in the organisation of the following seminars, workshops and meetings:

Training activities

In 2012 IUSSP made progress toward the completion of two distance learning projects funded by UNFPA: "Tools for Demographic Estimation" and "Population Analysis for Programmes and Policy". The IUSSP Council also integrated Demopaedia as an IUSSP scientific activity. The IUSSP Scientific Panel on Strengthening Demographic Training in Francophone Africa received a two-year grant from the William and Flora Hewlett Foundation to expand its training activities.

Tools for Demographic Estimation

A preliminary version of the materials was made available on the IUSSP website at http://demographicestimation.iussp.org/. At the end of 2012, 600 users had registered to use the material. Two experts carried out an external review and sent feedback and suggestions for change. The development team based at the University of Cape Town in South Africa is

now carrying out the final revisions and plans to create printed and CD-Rom versions to be distributed to UNFPA offices and at the International Population Conference. Updated online materials will remain available on the IUSSP website as an open source learning and teaching tool that can be revised and modified in the future. The next step is to create French and Spanish language versions of the online materials.

Population Analysis for Programmes and Policies

This project is being carried out by the London School of Hygiene and Tropical Medicine with funding provided by UNFPA. The team has completed writing 3 modules for the project, which will be transformed by learning technologists into interactive online educational material that will be ready for the public in 2013. It is hoped that UNFPA will honour a promise to fund the development of a fourth module in 2013.

Demopaedia

In 2012 the IUSSP Council also approved Demopaedia as an official IUSSP scientific activity. Demopaedia is a project begun in 2005 by the French National Committee of the IUSSP to make accessible on the web the Multilingual Demographic Dictionaries produced by the United Nations and IUSSP between 1953 and 1987. The project's current objective is to update and standardize all the language versions and create new language versions. The project now covers 18 languages: Arabic, Chinese, Czech, English, French, German, Indonesian, Italian, Japanese, Korean, Malay, Nepali, Polish, Portuguese, Russian, Spanish, Thai, and Vietnamese. Currently anyone can create a multilingual index of terms in up to 10 languages or a dictionary in up to 18 different languages at the following website http://www.demopaedia.org/tools/. Ultimately the goal is to create an Open Population Encyclopaedia where members can add and update information on demographic and population related terminology.

Strengthening Demographic Training in Francophone Africa

The William and Flora Hewlett Foundation renewed a grant to support a second phase of the project in 2012-2013 to be guided by the IUSSP Panel on Strengthening Demographic Training in Francophone Africa. The panel organised two training workshops and set up a center, CARE-IFA, based at IFORD in Yaoundé, Cameroon to support data analysis and database management in the region. They also organised several meetings to work on publications and prepare future training workshops to take place in 2013.

Publications

The IUSSP disseminates the scientific results of its activities through its website, in scholarly peer-reviewed journals and in the IUSSP-Springer series International Studies in Population (ISIP). In 2012, one edited volume was published in the ISIP collection, another was published by the principal Korean population research institution. Two special issues of peer-reviewed journals were devoted to papers from IUSSP seminars. Seminar papers are made available to IUSSP members and all seminar reports are available to the general public on the IUSSP website (www.iussp.org).

In 2012, the IUSSP Secretariat published and widely disseminated the English and French versions of the Call for papers for the 2013 Conference.

Membership and Governance

As an association based on individual membership, the IUSSP's principal strength is its members. The majority of IUSSP activities are carried out through members' voluntary contributions of their expertise and time. At the end of 2012, IUSSP included 1,585 full members and 266 student associates from 128 countries around the world. In 2012, 72 new members and 97 new student associates joined the Union. Women comprise 43 per cent of full members but more than half of student associates.

IUSSP Laureate Award

Each year the IUSSP honours one of its outstanding members by bestowing its Laureate Award. The 2012 IUSSP Laureate Award was presented to Professor Graziella Caselli at the European Population Conference in Stockholm on Thursday 14 June. Graziella Caselli is known for her numerous contributions to the field of demography as a researcher and teacher, her enthusiastic and active participation in the Union, and her untiring service to a large number of demographic institutions. Her research interests include health, longevity and ageing and her specific contributions to the discipline include the development of mathematical models for the analysis of socio-economic differences in mortality; the analysis of the role of socio-demographic factors on the future of the welfare state; the study of elderly health and survival; and the elaboration of models to disentangle the impact of demographic variables on ageing. She has proposed methods for forecasting mortality by cause and devised demographic models for longitudinal analyses.

2013 IUSSP Council Elections – Meeting of the Committee on Nominations

The Committee on Nominations met in December 2012 to begin its selection of candidates for the 2013 Council Elections. For budgetary reasons, it was decided to conduct the nominations process by email and a telephone conference rather than by a meeting at IUSSP headquarters as on previous occasions. The final list of candidates was not completed until early January 2013 and will be publicized in 2013. Members will also be asked to propose additional candidates.

To increase the involvement of the membership in the selection of the Committee on Nomination Members, the Council decided to request suggestions from the membership to include in the list of Committee Members the Council presents to the General Assembly.

Management and Finances

In 2012, IUSSP income totalled 1,016,593 €. Income sources include grants from private foundations and governments to support scientific activities and operational costs, membership dues, and income from interest earned on investments and exchange rate gains. In addition to the direct support the IUSSP receives from donors and institutions for operations and scientific activities, the IUSSP leverages additional funds through IUSSP Panel members and their institutions, which are not included in our accounts.

The IUSSP operating budget for 2012 was 1,133,491 €. Expenses include:727,592 € to directly support IUSSP scientific and training activities including 458,805 € for the development of distance learning materials for demographic training and IUSSP Scientific meetings, 132,710 € for publications and the website, the majority of which was spent on the IUSSP website, membership and conference management software, and 136,076 € of unspent grant funds mainly from the William and Flora Hewlett Foundation that were set aside as tied funds for future activities of the Panel on Strengthening Demographic Training in Francophone Africa.

The IUSSP spent 267,945 € on salary costs and related taxes and social security costs and an additional 51,706 € to pay for accounting and auditing services, office furnishing and supplies, depreciation on assets and other office expenditures. IUSSP governance costs, essentially expenditures associated with IUSSP Council and Bureau meetings and the meeting of the Committee on Nominations, came to a total 27,503 €. The IUSSP also incurred costs of 56,214 € in exchange rate and exceptional losses. Finally as IUSSP is required to pay the corporation income tax on investments (10% of investment earnings), a debt for corporation income tax has been recorded of 2,531 € related to IUSSP 2010 capital investments and a 2011 investment in a bond subscription.

The IUSSP operating budget exceeded IUSSP income by $116,898 \in$, the bulk of which was paid to cover the costs of the new website, membership and conference management software for which the IUSSP Council had created a reserve fund in 2010. A much smaller amount covered costs associated with the printing and dissemination of the Call for Papers for the International Population Conference. The IUSSP covered these expenses by drawing on special reserves set aside for the International Population Conference (15,131 \in) and for Technological Innovations (101,767 \in).

As of 1 January 2013, IUSSP reserves stand at 1,593,797 €, of which 563,463 € are held in general reserves, 243,883 € are in a reserve for contingencies, and 786,451 € have been set aside in special project reserves. The special project reserves include funds set aside for the 2013 International Population Conference (466,690 €), the 2013 IUSSP General Assembly (30,000 €), IUSSP Policy and Research Papers (43,134 €), a Teaching Materials Project (10,000 €), Scientific Activities (93,543 €), Technological Innovations (118,084 €) and US 501(c)(3) Status (25,000 €).

The assets of the IUSSP are held in several secure investments. In 2011, the IUSSP subscribed to a bond issued by BFCM for a total of 250,000 €. This bond has an annual coupon of 4,10% and a maturity of 5 years. In addition, the capital investment subscribed at the end of 2010 (500 000 €uros) resulted in interest earnings in 2012 of 15,037 Euros. The remaining assets have been placed in a tax exempt Euro SICAV account with Banque Transatlantique. The IUSSP also has U.S. dollar account with Banque Transatlantique and with Tompkins County Trust Bank in New York, USA.


The Secretariat currently has four permanent staff members who coordinate IUSSP scientific activities and publications, communicate with IUSSP members, donors and the public, maintain a website, and coordinate fundraising and reporting to IUSSP donors.

The IUSSP 2012 audited accounts were prepared by the accounting firm ARICE and approved by auditors Mazars & Guérard. For further details on IUSSP revenue and expenses in 2012 see the Statement of Activities and Change in Net Assets for the Year Ended 31 December 2012 below. Comparable data for 2009-2012 are shown in that statement. The Statement of Financial Position as of 31 December 2012 shows IUSSP total assets and liabilities for the period 2009-2012. In compliance with article D.441-4 of the French *Code du Commerce*, a table showing the balance of debts to suppliers for 2012 can be found on page 14.



Annex 7: Summaries of 2012 Scientific Meetings

More detailed information on meetings and workshops organised by the IUSSP in 2012 is presented below by date of occurrence.

Seminar on Pathways to Health: How intermediary life conditions mediate or modify early life effects, Berkeley, United States, 1-2 May 2012

This seminar was organised by the IUSSP Scientific Panel on Pathways to Health, in collaboration Berkeley Population Center, and the Institute for the Study of Societal Issues, University of California, Berkeley, with financial support from these institutions. The seminar brought together 22 participants from various disciplines, mainly demography, economics, anthropology, epidemiology, sociology, and public health. The seminar included 13 papers which addressed the pathways that link early life conditions and adult outcomes from various complementary perspectives. Several papers found support for the indirect mechanism that postulates that adverse early life conditions influence later health mainly through compromised adult socioeconomic attainment. These findings are important for the understanding of various pathways to health and for the planning of interventions, in particular because education, which is amenable by policy, often emerged as a strong mediator. However, several seminar papers also found that the association between early life conditions and adult health is robust to adult characteristics, thus supporting a direct rather than an indirect link. Further work is needed to better understand the conditions under which adverse early life conditions are likely to result in direct scarring of health, and the conditions under which the influence on adult health might run through modifiable, potentially socioeconomic, pathways. Cyberseminar on Bringing the Population-Sustainable Development Debate to a Higher Level, 7-14 May 2012.

This cyberseminar was organised by the Population-Environment Research Network (PERN), in collaboration with the International Institute for Applied Systems Analysis (IIASA), Austria, and The Royal Society in London, UK, to bring population considerations into the debate at the United Nations Conference on Sustainable Development held in Rio in June 2012 (Rio+20). Two background documents, the Laxenburg Declaration on Population and Sustainable Development and the report People and the Planet, served as a basis for discussions. The cyberseminar aimed to go beyond a merely Malthusian approach, with a focus on population size and growth rates and a policy emphasis on efforts to curb population growth rates. Research indicates that size is usually not even the most important dimension for sustainable development prospects. Other dimensions—among them age distribution, household composition, place of residence, migratory and consumption patterns, gender considerations, and educational structure—have arguably more important and more predictable implications for people's ability and willingness to engage in mitigation of environmental challenges, their effectiveness in adapting to such challenges, and their success in developing and adopting new approaches and technologies across the spectrum of daily life. Forty-two researchers posted a total of 115 contributions, which were accessible to the 664 subscribers to the PERN-Seminars list. Seminar on Demographic Perspectives on Refugee and Forced Migration, Tehran, Islamic Republic of Iran, 13-15 May 2012

This seminar was organised by the IUSSP Scientific Panel on Demography of Refugees, in collaboration with the University of Tehran, Population Association of Iran, University of

Adelaide, the Australian Demographic and Social institute of the Australian National University. The seminar was funded by the Australian Department of Immigration and Citizenship, United Nations High Commissionaire for Refugees (UNHCR), United Nations Population Fund (UNFPA), the University of Tehran, and the IUSSP. The main objective of the seminar was to prepare a reference book on demography of Refugee and forced migration. Around 20 distinguished scholars with significant background on the field of refugees as well as representatives from the UNHCR, Australian Department of Immigration and Citizenship, and Internal Displacement Monitoring Centre attended a two-day seminar and presented their findings on cutting edge issues on refugee migration. Participants also discussed how demography can contribute toward developing relevant policy and programme recommendations for providing protection for forced migrants, the solution of refugee and other forced migrant problems and maximising the benefits of such migration to origin and destination areas. Selected papers will be published in 2013 in a book entitled *Demography of* Refugees in the IUSSP collection published by Springer. Seminar on First Union Patterns around the World, Madrid, Spain, 20-22 June 2012

The Seminar was organised by the IUSSP Scientific Panel on Nuptiality, with the financial support from Madrid's Institute for Economy, Geography and Statistics of the CSIC (Spanish National Research Council), the Fund for Complementary Activities of the National Research and Development Plan of the Spanish Ministry of Economy and Competitiveness, and a contribution from El Colegio de México. Thirty-three researchers from sixteen different countries attended the seminar as speakers, special guests, observers and Panel members. The 21 papers presented used all types of currently available sources (census series, vital statistics and surveys) and addressed the different ways of entering into first conjugal unions and how they vary in timing and quantum, and according to geographical location (country, regions, rural/urban), socio-economic characteristics (education, occupation, gender, etc.) and cultural and ideational aspects. Seminar on Increasing Use of Reproductive Health Services through Community-based and Health Care Financing Programmes: Impact and Sustainability, Bangkok, Thailand, 23-25 August 2012.

This seminar was organised by the IUSSP Scientific Panel on Reproductive Health, in collaboration with the Institute for Population and Social Research (IPSR), Mahidol University. The financial support for the Seminar was provided by the IUSSP, IPSR, UNFPA, Wellcome Trust, and the Department of Reproductive Health and Research (RHR) of the World Health Organization (WHO) while Population Council and Marie Stopes International (MSI) supported their staff in attendance. The Seminar was attended by 36 participants from all over the world and included research scientists but also policy makers, programme managers and representatives of two donor agencies. Twenty papers were presented, including two papers systematically reviewing the evidence on reproductive health vouchers programmes and on the private sector engagement in sexual and reproductive health (SRH) and maternal and neonatal health. The other 18 papers covered the evidence on innovative programmes for expanding access to and utilization of SRH services in 12 countries in Africa and Asia. Models and interventions covered in the papers included community-based distribution of services, outreach services by community-based workers, community

mobilization activities, private sector engagement, pay-for-performance, vouchers and health insurance schemes. The papers addressed the complex issues of measuring the impact and sustainability of programme interventions but some questions remained unresolved, in particular regarding the evaluation of programme interventions. Seminar participants also pointed out the complexity and methodological challenges of establishing impact and scaling up of interventions. Seminar on Violence in Adolescence and Youth in Developing Countries, New Delhi, India, 9-11 October 2012.

This meeting was organised by the IUSSP Scientific Panel on Young People's Life Course in Developing Countries, in collaboration with the Population Council, India, which hosted the meeting. Funding was provided by UNFPA and DFID-India. There were 26 participants from all regions of the world, including two representatives of the funding agencies. The programme included 17 papers distributed in eight sessions: macro and general approaches, violence within dating and marriage, non-consensual sexual experiences, reproductive health outcomes of violence, violence among adolescent and young males, intergenerational aspects of violence, and perceptions of violence. The last session was devoted to a general discussion and policy implications. The discussion pointed out that it is necessary to explore innovative research related to issues such as morbidity and mortality resulting from violence, involvement of adolescents and youth in peer violence (as in gang wars) and conscripted in armies, delinquency as well as a need to focus also on other populations such as homosexuals and transgender, migrants, women as perpetrators. Seminar on Population Dynamics and the Human Dimensions of Climate Change, Canberra, Australia, 27-29 November 2012.

This Seminar was organised by the IUSSP Scientific Panel on Climate Change, in collaboration with the Australian Demographic and Social Research Institute (ADSRI) at the Australian National University. Financial support was provided by the Australian Government Department of Sustainability, Environment, Water, Population and Communities the Australian National University and IUSSP. There were 22 participants, researchers from all regions of the world, and 5 PhD students who attended as observers. The main objective of the Seminar was to bring together key researchers working in the new field of population dynamics and climate change in order to take stock of what progress has been made to date and assess future prospects. Part of the discussion was devoted to assessing the strengths and weaknesses of emerging population-based research paradigms for climate policy. A secondary aim was to explore the potential use of population perspectives to help integrate insights into the causes and consequences of anthropogenic climate change from across the social sciences and to facilitate understanding across the natural science-social science divide. The most important outcome from the seminar discussion was the identification of an exciting window of opportunity for population research on climate change, which lies in positioning population research vis-à-vis the next generation of climate scenarios, specifically the Shared Socioeconomic Pathways (SSPs) currently under development.
