2. Events

Over the past 4 years, the IUSSP pursued its scientific activities, both in person and online, or in hybrid format.

Based on the four years for which there are reports (2021-2024), the IUSSP organized 72 activities which brought together 6,167 participants. These 72 activities included: 2 conferences, 12 seminars or workshops, 2 expert meetings, 11 training workshops, 16 public webinars, 3 cyber seminars, 4 virtual workshops, 2 hybrid sessions, 13 side meetings or sessions at conferences, and 7 other meetings or events of various kinds. In addition, several Panels meet once or twice a month to carry out their activities.




7. Membership


Overall membership has declined over the past decade, reflecting broader challenges faced by professional associations. Reduced attendance at IPC2021, held virtually due to the COVID-19 pandemic, and at IPC2025 in Brisbane, affected by travel budget restrictions in Europe and U.S. government funding freezes, contributed to reduced recruitment. With about 1,300 participants in each of those conferences (when about 2,000 were expected), recruitment of IUSSP members was not as high as usual the year of an IPC.


The number of student members increased in 2021 and 2025 but their numbers also did not rise to past levels. This is also related to the decision, in January 2024, to end the free student membership, replaced by a low-cost, four-year student membership option.



Encouragingly, the gender balance among full members has improved over time. While men remain a slight majority of full members (54.2% in October 2025), women now represent the majority of student members (57.0%), indicating positive trends for future membership diversity.

The current distribution (October 2025) of full members (regular) and students in each main region is in part a reflection of the last two International Population Conferences, which were to be held in India (and became fully virtual) and in Australia. The proportion of members residing in Africa has continued to increase over the years while the proportion of members from Europe and North America is slightly lower than in the past.

IUSSP-Mattei Dogan award:

The IUSSP Mattei Dogan Award for Comparative Research in Demography was awarded to **Bruno Schoumaker in 2021** and to **KG Santhya in 2025**. Both awardees gave keynote addresses at the Closing Ceremony of the International Population Conference.

Early-Career awards:

The IUSSP Early Career Awards were established by the IUSSP Council in 2023 to recognize and celebrate outstanding contributions by early-career scholars across the world's regions—Africa, Asia and the Pacific, Europe, Latin America and the Caribbean, and North America.

Each regional awardee is selected in collaboration with the respective regional population association: the Union for African Population Studies (UAPS), the Asian Population Association (APA), the European Association for Population Studies (EAPS), the Latin American Population Association (ALAP), and the Population Association of America (PAA).

The Awards are conferred biennially, with the first recipients honored in 2023 and the second cohort in 2025.

9. Institutional affiliation

10. International Population Conference 2025

This report for the 2025 General Assembly will focus on the most recent International Population Conference, in Brisbane, in July 2025. For information on the 2021 International Population Conference, which was initially to be held in Hyderabad, India and which was converted into a fully virtual conference as a result of the COVID-19 pandemic, please read the report on the IUSSP website (https://iussp.org/en/ipc2021).

The 30th International Population Conference (IPC2025) was held at the Brisbane Conference & Exhibit Centre (BCEC) in Brisbane, Australia, from 13–18 July in collaboration with the Australian Population Association. The Conference brought together approximately **1,300** participants from **98** countries for six days of scientific exchange, training, and networking.

Regional distribution of participants: Asia-Pacific (46%), Europe (21%), Africa (16%), Northern America (13%), and Latin America and the Caribbean (5%). Women accounted for **51%** of attendees, and nearly half of the participants were **under the age of 40**.

Scientific Programme

The scientific programme featured **over 950 oral presentations** and **205 posters** covering **24 thematic areas** of population research, along with plenary sessions, research leader sessions, side meetings, and **13 pre-conference workshops**.

The final scientific programme (ipc2025.popconf.org) included **204 oral sessions** (90 minutes each) across **11 parallel streams**, comprising:

- 190 regular sessions
- 14 invited and research leader sessions
- 4 poster sessions
- 4 plenaries
 in addition to the Opening and Closing Ceremonies.

The programme—based on **over 2,300 paper submissions** to **24 themes** and **72 member-proposed session topics**—was created from the call for papers launched in **September 2024**. Authors were limited to **one submission as presenting author**. All long abstracts were **peer-reviewed and scored, each by two IUSSP members**.

The IUSSP Council thanks the **320** anonymous volunteer reviewers, as well as the **24** theme conveners and **85** organizers and co-organizers of member-organized sessions, for their invaluable work in creating the sessions.

Attendance Challenges

The conference experienced an unusually high number of author withdrawals, due to budget cuts, funding freezes, project cancellations, and visa difficulties. Approximately 282 people (22% of registered participants) were unable to attend—significantly higher than in previous in-person conferences.

Many accepted authors also withdrew their presentations. This required the steering committee to adjust the programme by combining sessions, adding replacement papers from

posters, and relaxing the one-presentation-per-participant restriction. The latter was done to encourage registration, as some local funding was tied to the number of registered participants.

Financial Support

Financial support, provided by IUSSP with funding from UNFPA, the Gates Foundation, and IUSSP reserves, enabled **207 participants**—mostly from **LMICs and early-career scholars**—to attend. All grants provided **partial funding**.

The **Population Council–India** assisted in funding **66 participants from India** with a grant from the Gates Foundation. Unfortunately, **60 of the 270 funded participants** were unable to attend, with more than half unable to **obtain an Australian visa**.

Participant Feedback

A post-conference survey, completed by **about 35% of participants**, provided valuable insights:

- **79%** rated the scientific quality as *excellent* or *very good*.
- 76% cited international networking as a primary reason for attending.
- **Mentoring and practice sessions**, especially for early-career scholars, received high praise.
- **Organization and logistics** were rated highly overall, though participants raised concerns about **visa delays** and **high registration fees**.
- 78% said they would recommend participating in IPC2029.

Overall, the survey confirmed that **IPC2025** was a successful and highly valued event, while also highlighting areas for improvement to enhance accessibility and inclusiveness.

IUSSP Conference Revenues and Costs





Figure 1. Preliminary IUSSP Expenses for IPC2025

A frequent question in the survey concerned how **registration fees** are used. Although final accounting for IPC2025 is not yet complete, most IUSSP-related expenses and revenues have been entered. **Preliminary estimates** of IUSSP expenses and revenues are presented in **Figures 1 and 2**.

Registration fees covered 48% of IUSSP costs for organizing the event and supporting LMIC scholars' participation.

Due to lower attendance and challenges in securing donor funding in a difficult financial year, IUSSP is likely to incur a loss of up to €183,572, which will be covered by running costs and reserves.

Final IPC2025 revenue and expenditure figures will be included in the **2025 Annual Report** and in the **final Conference Report** to be published in **early 2026**.

11. Financial Overview

The IUSSP's finances remained stable over the 2021–2024 period. Total expenses amounted to €6,800,856, while income totaled €7,049,524. The IUSSP set aside €248,938 in reserves—mainly from net exchange rate gains (€135,585) on its US dollar accounts and interest earned (€110,626) on reserve fund investments.

The accounts were prepared by IUSSP's external accountant, Florence Reboul at 3A-FR, and audited by Forvis-Mazars. Their audit report for 2021–2024 is included in the annex: IUSSP/UIESP Statement of financial position for the years 2021 to 2024 & statement of activities and change in net assets for the years 2021-2024 (euro). The IUSSP uses accrual accounting, which records income and expenses when they are earned or incurred, rather than when cash is received or paid. As a result, financial statements include grant funds committed for future activities in the annual revenue and expense figures.

Income

As shown in Figure 3, 78% of IUSSP revenue during this period came from grants—primarily for scientific activities, but also including core grants. Within this total, 25% came from new grants, gifts, and donations, while 53% represented tied funds (earmarked grant funds carried forward from the previous fiscal year).

Other income sources included membership dues, IPC registration fees, and sponsor contributions (8%), project overheads from grants (4%), interest on investments (3%), and exchange rate gains (7%).


Expenses


As shown in Figure 4, scientific activities accounted for 73% of IUSSP's direct expenses:

- **35%** for scientific meetings, the International Population Conference, the IUSSP website, and publications.
- 38% for tied funds—grant funds set aside for future or earmarked scientific activities.

Secretariat staff salaries and related social security and employee taxes made up **16**% of total expenses, while **governance costs** (Council meetings and travel, accounting, audit, and other operational expenses) represented **4**%.

Finally, exchange rate losses on US dollar accounts constituted 5% of total expenses, though these were more than offset by exchange rate gains, which exceeded losses by €135,585 over the period.
