Introduction

In 2014 the International Union for the Scientific Study of Population continued its work to promote population science, foster international networks of population scientists worldwide and support interaction between research and policy. The newly elected Council established their priorities for the 2014-2017 period and decided on the location of the next International Population Conference. In addition the IUSSP maintained an active programme of seminars, workshops and publications, and continued with the work of updating the new website. The IUSSP also embarked on a new project to involve demographers and population specialists in discussions about the need for a data revolution as an integral part of the post-2015 development agenda. This annual report highlights recent outcomes of these activities.

Incoming Council and 2014-2017 Priorities

The new IUSSP Council met 30-31 January 2014 at IUSSP Secretariat headquarters at the French National Institute for Demographic Research (INED) in Paris. The meeting was an opportunity to meet and define the new Council's priorities for its mandate. In addition to continued support for IUSSP scientific panels and seminars the Council thought the Union should explore other types of structures and activities to maximize the participation of members in IUSSP activities to reach out to many who are unable to participate in seminars and conferences. IUSSP would continue to promote its training activities. Ties with regional population associations would be further reinforced by giving them greater visibility on the IUSSP website. Council thought the IUSSP should make greater use of its special consultative status with the United Nations Economic and Social Commission (ECOSOC). Many other subjects were discussed at this first meeting including the new website, publication policy, and new potential funding sources to assure the continuation of IUSSP activities. For maximum efficiency, the Council members were assigned to serve on one of seven committees: Publication, Fundraising, Training, Website, Constitutional Amendments, New Panel Proposal Guidance Committee and the Steering Committee for the 2017 International Population Conference:

IUSSP Scientific Seminars

In 2014, the IUSSP and its Scientific Panels, in collaboration with partner institutions, organized four scientific seminars, one cyberseminar and one expert meeting. Five of these meetings were organized on the basis of a call for papers. IUSSP received 319 abstract proposals. Approximately 705 individuals directly participated in IUSSP scientific activities including 418 cyberseminar participants and 97 seminar participants. A total of 96 papers were presented at these seminars.

In order to facilitate the participation of students and scholars from developing countries the IUSSP provides some travel support when funding is available. In 2014, the IUSSP provided direct support for travel to 25 participants from developing countries to attend an IUSSP seminar. Panel members and the IUSSP Secretariat raised and managed funds from nine donors to provide travel support and collaborated with 18 institutions in the organisation of the following scientific seminars and meetings:

Future seminars and meetings

In 2014, the IUSSP and IUSSP Scientific Panels were actively preparing the following activities for 2015:

Training Workshops and Resources

In 2014, IUSSP groups organized four training workshops that provided training to 114 participants primarily based in Francophone Africa. The IUSSP received 190 applications for two trainings workshops advertised in 2014; the participants from the other two workshops were recruited from local training institutions and applicants from workshops held in 2013. The IUSSP provided direct travel support to 78 participants, 68 of whom were from developing countries and 10 of whom were trainers. The workshops focused on developing population scientists' methodological and analytic skills as well as their ability to effectively communicate population research and trends to policy makers.

Open Educational Resources

IUSSP now offers access to three open educational learning resources on its website: Tools for Demographic Estimation, Population Analysis for Policies and Programmes, and Demopaedia.

[Tools for Demographic Estimation](#) is an online manual and set of tools (in the form of excel spreadsheets) for demographic estimation from limited, deficient and defective data developed with funding from UNFPA. A total of 609 PDF versions of the manual were downloaded in 2014. The top ten countries for new users in 2014 include in order of importance the United States, India, the United Kingdom, South Africa, Brazil, Kenya, Indonesia, Canada, Nigeria and the Netherlands. In 2014, IUSSP commissioned a French translation of the online manual. A third of the French manual has been posted and the

remainder should be online by April 2015 and can be accessed by clicking on [Outils d'estimation démographique](#). In 2014, the website recorded 19,277 sessions and 11,684 new users in 2014 from countries in all regions.

[Population Analysis for Programmes and Policies](#) is an online course providing an introduction to methods demographers use to analyse population data, the sources of this data, and the methods used to collect this data. The modules include: 1) Introduction to Demographic Analysis; 2) Demographic Data–Sources, Collection and Evaluation; 3) Demographic Analysis–Further Methods and Models, which includes life tables, population dynamics and projections and advanced fertility analysis; and, 4) Applications and Extensions of Demographic Analysis. The website recorded 40,289 sessions and 29,452 users in 2014. The top ten countries using the materials include in order of importance the United States, the United Kingdom, India, Canada, the Netherlands, South Africa, Kenya, Tanzania and Nigeria.

[Demopaedia](#) is an open-source online multilingual encyclopedia of demographic terminology based on a series of multilingual demographic dictionaries published in the 1980's under United Nations and IUSSP auspices. Demographers can participate in updating the online encyclopedia via a wiki. Those who need to translate terms from one language to another can create their own multilingual indexes via an online [Multilingual Demographic Dictionary](#) that will generate a dictionary in 14 languages or multilingual index in any combination of 11 languages (Arabic, Czech, English, German, French, Italian, Polish, Portuguese, Russian, Spanish, and Serbo-Croatian). In 2014, the English language version of the encyclopedia was updated. The site received 50,000 to 60,000 unique visitors per month in 2014 (based on statistics from <http://www.awstats.org/>).

Publications

The IUSSP disseminates the scientific results of its activities through its website, in scholarly peer-reviewed journals and edited volumes. In 2014, one Springer volume and four special issues of peer-reviewed journals were devoted to papers from IUSSP seminars. Papers from IUSSP seminars were also published individually but these are more difficult to track. Seminar papers are made available to IUSSP members and all seminar reports are available to the general public on the IUSSP website (www.iussp.org). Policy statements the IUSSP has made can also be found on the website. In 2014, the IUSSP decided to publish its bilingual Bulletin as an electronic newsletter and was able to produce three Bulletins in June, September and December. In the future the IUSSP Bulletin will be published quarterly.

Demography and the Data Revolution

The William and Flora Hewlett Foundation approached the IUSSP with a project to bring IUSSP members into ongoing discussions about the need for a data revolution to accompany the post-2015 development agenda and monitor progress towards a new set of goals and indicators, the Sustainable Development Goals, which will replace the MDGs in 2015. The first activity was an expert meeting in Paris organized in collaboration with the Population Association of America (PAA), with the assistance of the Overseas Development Institute (ODI). The meeting brought together 22 prominent population scientists to discuss how demographers, and demographic skills, could contribute to a data revolution. The meeting was organized around plenary and brainstorming sessions designed to bring participants to a general consensus of what a data revolution might entail and how demographers could best contribute. One immediate outcome of the meeting is a statement and recommendations that emerged from the discussions, [Defining and successfully accomplishing the Data Revolution: The perspective of Demographers](#), that was sent to the UN Secretary-General's Independent Expert Advisory Group on the Data Revolution for Sustainable Development (IEAG). The statement was also disseminated to IUSSP members and regional associations and posted on the IUSSP website. A revised version will appear in *Population and Development Review* in March 2015. With UNFPA funding the IUSSP also commissioned a review of the indicators being proposed for the Sustainable Development Goals to replace the MDGs in 2015.

IUSSP Participation in meetings organized by the United Nations

The IUSSP has Special Consultative Status as an NGO with the United Nations Economic and Social Commission (ECOSOC). This status gives IUSSP the privilege of participating in United Nations-sponsored meetings. In return organizations are expected to contribute to and support the development aims of the Economic and Social Council and the United Nations. On 9 April 2014, IUSSP President Anastasia Gage presented a statement at the Forty-Seventh Session of the Commission on Population and Development in which she listed some of the key messages emanating from the 2013 International Population Conference in Busan.

Looking ahead at the post-2015 agenda she called for adequate funding to be made available for training and research in population, in particular for West Africa. The statement is available at:

IUSSP participation in Regional Population Conferences

- **2014 European Population Conference:** The IUSSP held a booth and organized a special session devoted to the IUSSP Laureate Ceremony at the 2014 European Population Conference, which took place in Budapest, Hungary from 25 to 28 June 2014, organized by the European Association for Population Studies (EAPS) and the Hungarian Demographic Research Institute (HDRI).
- **2014 ALAP Conference:** The IUSSP organized a special session at the Sixth Congress of the Latin American Population Association (ALAP) in Lima, Peru from 12 to 15 August 2014 to present the distance training course Population Analysis for Policies and Programmes, implemented with UNFPA support. The Latin American participants hoped a Spanish version of the materials could be developed.

International Population Conference

IUSSP received two proposals to host the 2017 Conference: South Africa and India. Taking into consideration the formal proposals submitted in December 2013, the Council decided to accept the proposal from South Africa to host the XXVIII International Population Conference in Cape Town in 2017. Cape Town is one of the most highly rated cities for tourism with excellent accommodations. The Cape Town International Conference Centre (CTICC) is a state-of-the-art facility that can accommodate the 2,300 expected participants with generous exhibit space and meeting rooms for up to 12 simultaneous sessions. Statistics South Africa will be the principle host country institution supporting the Conference.

Call for session suggestions:

The IUSSP issued a call for suggestions for members to provide session topics to be considered during the first meeting of the International Organizing Committee (IOC) in early 2015. A total of 164 session suggestions were submitted by IUSSP members. These suggestions will be reviewed at the first IOC meeting in 2015.

Future Conferences

The Council decided to move the decision for the 2021 Conference host to early 2017 as 4 years is now the minimum amount of time required to adequately organize such a meeting and assure the availability of conference facilities. Bid proposals will be requested for December 2016.

IUSSP Laureate Award

The IUSSP elected **Thérèse Locoh**, an active member of the IUSSP since 1965, as the 2014 IUSSP Laureate in recognition of her important contributions to demographic research on family, fertility, and gender in Africa. She was one of the first French-speaking demographers to perceive the key role of gender relations in demographic behaviour. She served as a member of the IUSSP Committee on the Comparative Analysis of Fertility and to organize a major conference and co-edited an IUSSP volume with Ordina editions on the Onset of Fertility Transition in Sub-Saharan Africa (1994). She also played key roles in the establishment of population studies in Francophone West Africa and elsewhere notably

setting up the Unité de recherche démographique (URD) at the University of Benin, in Lome, Togo and helping establish the Union for African Population Studies (UAPS). The 2014 IUSSP Laureate Award was presented to Thérèse Locoh at the European Population Conference, in Budapest, on 28 June 2014. Membership

As an association based on individual membership, the IUSSP's principal strength is its members. The majority of IUSSP activities are carried out through members' voluntary contributions of their expertise and time. At the end of 2014, IUSSP included 1,958 full members and 102 student associates from 124 countries and 134 nationalities around the world. In 2014, 75 new members and 22 new student associates joined the Union. Women comprise 43% of full members and 53% of the student associates.

Discounts for multiple year dues payments

In an effort to reduce the quadrennial drop in membership that takes place between IUSSP International Population Conferences, the IUSSP Council decided to implement two measures to encourage members to maintain their membership: 1) IUSSP members will have the option to pay up to 4 years of dues in one payment at a discounted rate. This will help those who forget to renew or have difficulties making international payments to remain current members. Members who are paying the full dues rate will receive a discount of €10 euro for 2 years of dues payments, €20 euro for 3 years, and €40 euro for 4 years. For those qualifying for low and middle-income country and retired member dues, the discount will be proportional to their dues rate. 2) Members who maintain their IUSSP membership during the entire interval between conferences will be able to pay a reduced registration rate at the subsequent International Population Conference. Thus, those planning to attend the 2017 IUSSP conference in Cape Town will need to have paid their dues in 2014, 2015, 2016 and 2017 to be eligible for this discount.

Option to pay UAPS dues

To help the Union for African Population Studies (UAPS) collect their membership dues, the IUSSP has set up an option for IUSSP members to pay membership dues to UAPS – or even join UAPS – when joining or renewing their IUSSP membership.

Management and Finances

In 2014, IUSSP income totaled 849,765 €. Income sources include grants from private foundations and governments to support scientific activities and operational costs, membership dues, income from interest earned on investments and exchange rate gains. In 2014, IUSSP USD income from grants and the value of reserves in US dollars benefited greatly from the rapid valuation of the US dollar against the Euro at the end of 2014. In addition to the direct support received from donors and institutions for operations and scientific activities, the IUSSP leverages additional funds through Panel members and their institutions, which are not included in our accounts.

The IUSSP operating budget for 2014 was 811,620 €. Expenses include: 338,460 € to directly support IUSSP scientific and training activities, 22,785 € for publications and the website, and 69,186 € of unspent grant funds mainly from the William and Flora Hewlett Foundation that were set aside as tied funds for future activities supporting demographic training in Francophone Africa.

The IUSSP spent 260,724€ on salary costs and related taxes and social security costs. Accounting and auditing services, office furnishing and supplies, depreciation on assets and other office expenditures amounted to 46,884€. IUSSP governance costs, essentially expenditures associated with IUSSP Council and Bureau meetings came to a total 41,065 €. The IUSSP also incurred costs of 29,334 € in exchange rate and exceptional losses. Finally as IUSSP is required to pay the corporation income tax on investments (10% of investment earnings), a debt for corporation income tax has been recorded of 3,182 € related to IUSSP 2010 capital investments and a 2011 investment in a bond subscription.

The IUSSP income exceeded the IUSSP operations budget by 38,145€, all of which was the result of a positive balance on exchange rate gains and losses of 95,983 € due to the increase in the Euro value of our bank accounts in US dollars. This amount has been added to the IUSSP general reserve fund.

As of 1 January 2014, IUSSP reserves stand at 1,801,579 €. Given a concern with a tight funding environment especially for core funding, the Council decided to restructure the IUSSP reserves. General reserves have been reduced to 226,817 € and reserves for contingencies have been increased to 570,000 € in order cover at least 18 months of IUSSP operational costs and charges associated with staff terminations and moving costs if Secretariat headquarters were to move elsewhere. The Council also decided to simplify the special project reserves into four broad project reserves for 1) Scientific and Training Activities (156,677 €) that would cover training materials, publications and seed funding for scientific panels; 2) General Operating costs (130,000 €) which includes costs associated with fundraising, participation in international meetings, and holding a general assembly; 3) Technological Innovations (118,084 €) to cover costs of software and improvements and upgrades to the IUSSP website, and 4) a general fund to cover any future International Population Conference (600,000€). These reserves replace the following project reserves: 2017 IUSSP General Assembly (30,000 €), IUSSP Policy and Research Papers (43,134 €), a Teaching Materials Project (10,000 €), Scientific Activities (103,543 €), Technological Innovations (118,084 €), US 501(c)(3) Status (35,000 €), Fundraising Activities (25,000 €) and Outreach Activities (40,000 €).

The assets of the IUSSP are held in several secure investments. In 2011, the IUSSP subscribed to a bond issued by BFCM for a total of 250,000 €. This bond has an annual coupon of 4.10% and a maturity of 5 years. In addition, the capital investment subscribed at the end of 2010 (500,000 €) resulted in interest earnings in 2014 of 13,480 €. The remaining assets have been placed in a tax exempt Euro SICAV accounts with Banque Transatlantique. The IUSSP also has U.S. dollar account with Banque Transatlantique and with Tompkins County Trust Bank in New York, USA. Total interest earned on investments in 2014 is 23,702 €.

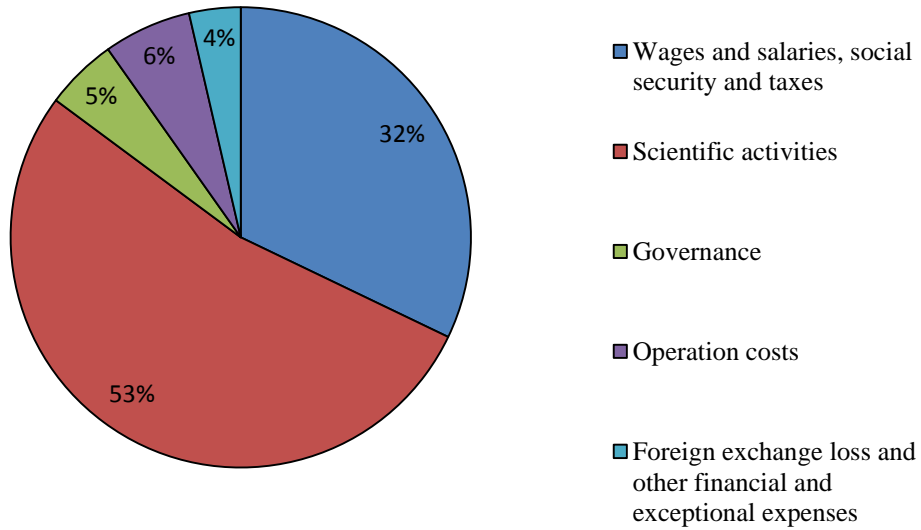
The Secretariat currently has four permanent staff members who coordinate IUSSP scientific activities and publications, communicate with IUSSP members, donors and the public, maintain a website, and coordinate fundraising and reporting to IUSSP donors.

The IUSSP 2014 audited accounts were prepared by the accounting firm ARICE and approved by auditors Mazars & Guérard. For further details on IUSSP revenue and expenses in 2014 see the Statement of Activities and Change in Net Assets for the Year Ended 31 December 2014 below. Comparable data for 2011-2014 are shown in that statement. The Statement of Financial Position as of 31 December 2014 shows IUSSP total assets and liabilities for the period 2011-2014. 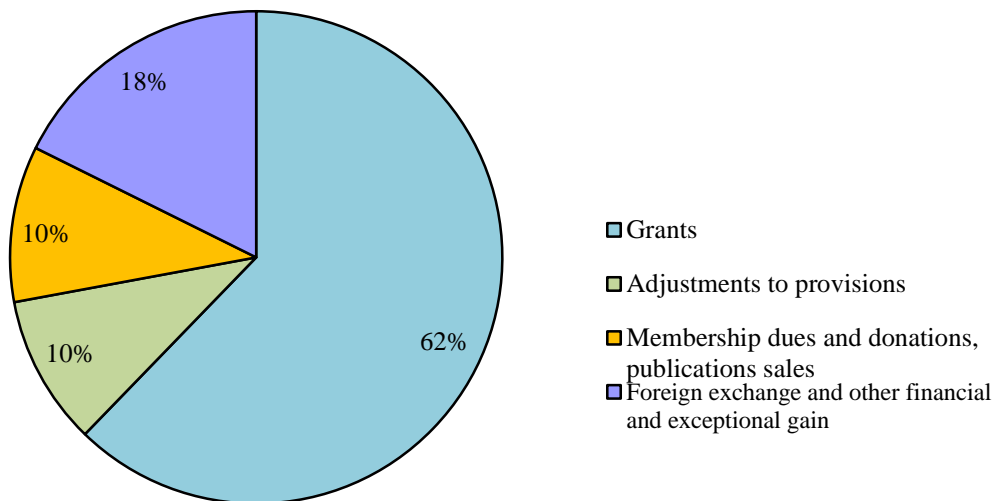

Annex 7: Summaries of 2014 Scientific Meetings and Training Meetings

Cyberseminar on Family Demography: Advancing Knowledge about Intergenerational Relationships and Exchanges in Low and Middle-Income Countries, 9-10 January 2014

This cyberseminar was organised by the IUSSP Panel on Family Demography in Developing Countries, in collaboration with the University of Southampton and INDEPTH Network and funded by the Economic and Social Research Council (ESRC). It is the first of three planned international cyberseminars entitled 'Family demography: Advancing knowledge about intergenerational relationships and exchanges.' It was organized around three broad strands: 1) Concepts and methods; 2) Family demography; 3) Demographic datasets. Twenty papers were presented and there were 2,438 'reads' of material from 418 people from around 30 countries. Training workshop on Using "Quantum GIS" (QGIS) Software to Present Census Data, Yaoundé, Cameroon, 24-28 March 2014

This workshop was organized by the IUSSP ~~Scientific Panel~~Network on for Strengthening the demographic training in Francophone Africa, the Observatoire démographique et statistique de l'espace francophone (ODSEF), Université Laval (Canada) and the Réseau des Institutions de Formation Forestière et Environnementale de l'Afrique Centrale (RIFFEAC), in collaboration with the Agence universitaire de la Francophonie (AUF) and with financial support from the William and Flora Hewlett Foundation. The objective of this workshop was to provide training to use QGIS software to a group of Francophone African population specialists (demographers, sociologists, geographers, etc.) and a group of agro-forestry students. The workshop brought together 25 participants (5 women and 20 men) from 7 Francophone African countries: Cameroon, Chad, Congo, Congo DRC, Côte d'Ivoire, Guinea, Mali. International Conference and Symposium on the Demographic Dividend in Africa, Yaoundé, Cameroon, 31 March-4 April 2014

The conference was jointly organized by the Cameroonian Ministry of Economy, Planning and Regional Development (MINEPAT), the United Nations Population Fund (UNFPA) and the Institut de Formation et de Recherche Démographiques (IFORD) in parallel with a training workshop organized by the IUSSP Network for Strengthening Demographic Training in Francophone Africa, whose work the conference was based on. Approximately 200 national and international participants attended the conference and including representatives of various ministries, representatives of civil society working in the field of population and development, international experts and students at IFORD. Plenary sessions devoted to theoretical and methodological aspects of the demographic dividend were followed by more technical work carried out in break-out sessions. Throughout the conference emphasis was placed on the need to increase knowledge on and promote awareness about the value the demographic dividend theory; on the opportunity for African countries' development constituted by the demographic dividend; and strategic orientations that African countries – and Cameroon in particular – would need to take to take advantage of the demographic dividend. International Seminar on Demographic Vulnerability to Natural Disasters in the Context of Climate Change Adaptation, Kao Lak, Thailand, 23-25 April 2014

This second Seminar sponsored by the IUSSP Panel on Climate Change, was hosted jointly by the College of Population Studies, Chulalongkorn University, Bangkok, and the Wittgenstein Centre for Demography and Human Capital (IIASA, VID/ÖAW and WU) (WIC), Vienna. Financial support was provided by the European Research Council and the Chula Global Network. There were 42 participants, including three speakers in the roundtable discussion representing local stakeholders. The participants, mainly researchers and doctoral students, came from across the globe. Twenty-one papers were presented. The main objective of the Seminar was to bring together researchers working in the area overlapping between population dynamics, response to natural disasters, and adaptation to climate change to strengthen the application of analytical tools in demography in studying demographic and socio-economic differentials to the field of risk, vulnerability and climate change. A selection of papers presented at the Seminar should be published in the journal *Vienna Yearbook of Population Research* in December 2015. International Seminar on Decision Making Regarding Abortion—Determinants and Consequences, Nanyuki, Kenya, 3-5 June 2014

This seminar was organized by the IUSSP Scientific Panel on Abortion, in collaboration with the Population Council's Nairobi office. Technical and financial support was provided by STEP UP (Strengthening Evidence for Programming on Unintended Pregnancy) Research Consortium. Additional financial support was provided by Bixby Center for Population Health and Sustainability, University of California, Berkeley; Centre Population et Développement (CEPED, France); Ipas; Venture Strategies for Health and Development (VSHD); and Venture Strategies Innovations (VSI). The seminar brought together 29 participants from all regions of the world and included both senior and junior scholars. Twenty-four papers presented mainly focus on countries or contexts where access to abortion is restrictive due to legal conditions, high stigma, or poor quality of health systems. Training Workshop on the Demographic Dividend, Ouagadougou, Burkina Faso, 15-24 September 2014

This training workshop was organized at the Institut Supérieur des Sciences de la Population (ISSP), Université de Ouagadougou, by the IUSSP Network for Strengthening Demographic Training in Francophone Africa (FraNet) in collaboration with the ISSP and the Cellule d'Appui à la Recherche et l'Enseignement des Institutions Francophones d'Afrique (CARE-IFA) based at IFORD (Cameroon), with financial support from the William and Flora Hewlett Foundation. This third workshop on the Demographic Dividend brought together forty participants from a dozen countries in Africa: Algeria, Benin, Burkina Faso, Cameroon, Chad, Congo DR, Côte d'Ivoire, Madagascar, Morocco, Niger, Senegal. The workshop had three main objectives: 1) Take stock of current knowledge on the prospects and conditions for a demographic dividend in Africa and its potential role in the emergence of African countries; 2) Introduce participants to several methods to analyse the dividend; 3) Produce a collaborative report assessing the current extent of the dividend in various African countries. As part of the workshop, the organizers held a formal meeting with presentations to members of the Parliament belonging to the Burkina Faso Network on Population and Development, in which a dozen Burkinabe MPs took part. Expert Group Meeting on Demography and the Post-2015 Data Revolution, Paris, France, 9-10 October 2014

This expert group meeting was organized by the IUSSP in collaboration with the Population Association of America (PAA), with the assistance of the Overseas Development Institute (ODI) and with the support of the William and Flora Hewlett Foundation, ~~convened~~. The meeting brought together 22 prominent population scientists to discuss how demographers, and demographic skills, could contribute to a data revolution. The meeting was organized around plenary and brainstorming sessions designed to bring participants to a general consensus of what a data revolution might entail and how demographers could best contribute. One immediate outcome of the meeting is a statement and recommendations that emerged from the discussions, which were sent to the UN Secretary General's Independent Expert Advisory Group on a Data Revolution for Sustainable Development in mid-October. International Seminar on Early-life Determinants of Late-life Employment, Ill Health and Early Death, Lund, Sweden, 20-21 October 2014

This seminar was organized by the IUSSP Scientific Panel on Pathways to Health, in collaboration with the Centre for Economic Demography, School of Economics and Management, Lund University. It brought together 20 researchers working at the intersection of labour market participation, retirement, and health to shed light on the life-course processes that influence labour market performance and older-age health. Ten papers were presented. Priority had been given to contributions based on prospective data suitable for analysing unhealthy ageing in a full life-course perspective. International Seminar on Promoting Postpartum and Post-abortion Family Planning: Challenges and Opportunities, Cochin, India, 11-13 November 2014

This meeting was organized by the IUSSP Scientific Panel on Reproductive Health, in collaboration with the Population Council, India and the Department of Reproductive Health and Research, World Health Organization. Financial support for seminar was provided by the WHO's Department of Reproductive Health and Research, the Wellcome Trust, the David and Lucile Packard Foundation, and the Strengthening Evidence for Programming on Unintended Pregnancy (STEP UP) Research Program Consortium, Population Council. The seminar brought together 24 scientists, policy makers, and programme managers to present and discuss a range of issues relating to postpartum and post-abortion family planning. A total of 18 papers were presented, including one paper that provided an overview of the evidence base on postpartum and post-abortion family planning in developing countries. The papers presented at the seminar sought to answer several key questions pertaining to postpartum and post-abortion contraception, including: (1) How to measure unmet need for contraception in the postpartum period and what is its magnitude? (2) Is unmet need for contraception in the postpartum period higher than at other times in women's reproductive life? (3) What is the optimal time for postpartum contraceptive uptake? (4) What is the extent of postpartum and post-abortion contraceptive uptake? (5) What methods are used by women who initiate contraception post-partum or post-abortion? (6) What is the method use continuation rate among women who initiate postpartum or post-abortion? (7) What are some of the barriers to improving postpartum and post-abortion contraceptive uptake and strategies to overcome those? (8) What types of intervention have had most impact on postpartum contraceptive uptake? The full seminar report posted on the IUSSP website describes how seminar participants sought to answer these questions and point to a certain number of policy

Training Workshop on Demographic Analysis for Decision Making: Trends and Inequalities in Death and Fertility in Francophone Africa, Dakar, Senegal, 1-5 December 2014

This workshop was organized under the auspices of the IUSSP Network for Strengthening Demographic Training in Francophone Africa in collaboration with the Agence universitaire de la Francophonie (AUF), the Observatoire démographique et statistique de l'espace francophone (ODSEF), and the Institut de Recherche pour le Développement (IRD) and with financial support from UNFPA. Participants included 24 trainees, mostly analysts based at national statistical offices from ten countries in the region, six trainers, and two training assistants. The objectives of the workshop were to: improve the capacity of data analysts in national statistical offices and other organizations to analyze and use census data; improve communication of population data to policy makers and the public using formats that maximize the impact of population data analyses for policy and programmes; and improve the use and value of census data, which, because of its exhaustiveness, is particularly suitable for disaggregated analyses of population trends. The workshop focused on child mortality and fertility in Africa demonstrating how demographic methods of estimation can be used to understand population trends and inequalities. Particular attention was paid to the analysis of disaggregated data at the regional level to tease out inequalities in child mortality, life expectancy and fertility by mother's educational status, geographic location, urban or rural residence. The workshop offered a mix of lecture and exercises drawing on demographic estimation methods for use where data is limited or incomplete. These methods are covered in the French translation of the online manual Tools for Demographic Estimation developed by an IUSSP working group with funding from UNFPA that is available on the IUSSP website at <http://demographicestimation.iussp.org/fr>. The workshop also included an introduction to QGIS, an open source data mapping software that enables the spatial representation of data trends, greatly improving the potential impact of population analyses for policy making.
