New Council

First meeting of the 2014-17 IUSSP Council. *Report by France Meslé.*

The new IUSSP Council met 30-31 January 2014 at IUSSP Secretariat headquarters at the Institut National d'Études Démographiques (INED) in Paris. The Council tackled a packed agenda for its first meeting. As incoming Secretary General and Treasurer and first time member of the IUSSP Council, I was aware of the enormity of the task that awaited me and fully appreciated the implication and dynamism of the Council members and the Secretariat. Under the firm and attentive chairmanship of Anastasia Gage, the Council members deliberated for two full days. The first order of business was for the new council members to get acquainted and familiarize the new "green" Council members with the association's multiple activities. Among the many points on the agenda, IUSSP research and training activities were at the center of the discussion.

After listening to the very positive report about the Busan International Population Conference (2,100 participants, 268 sessions, 984 oral presentations, 485 posters), we were tasked with deciding the venue for the 2017 Conference. Two countries proposed to host the 2017 Conference during the Busan Conference: South Africa and India. Taking into consideration the formal proposals submitted in December 2013, the Council decided to accept the proposal from South Africa, contingent upon a successful site inspection tour (see related article). The proposal from India also received much interest and the Council actively encouraged the Indian members to resubmit their project in 2016 for the 2021 Conference. The decision for the 2021 Conference host will be made in early 2017. The Council decided to move up the dates for bids by one year, as 4 years is now the minimum amount of time required to adequately organize such a meeting and assure the availability of conference facilities.

The second item on the agenda concerned the Scientific Panels. Three new panels were created on spatial demography, historical demography and language and population studies, and the mandates of six panels created by the previous Council were extended by one to two years. At the end of 2014, seven panels will complete their mandate. The Council, therefore, decided to send out a call for new panel proposalsaddressing nine priority themes (link to call for panel suggestions here). In early 2015, the Council will select several new panels from the suggestions received from the membership.

Seminars organized by the IUSSP Scientific Panels are irreplaceable as a venue for discussion and exchange on population research and policy questions. These meetings, however, can only include a small number of researchers. The Council has thus begun to think about other types of structures and activities that will enable a maximum number of members to be informed about and participate in debates of interest to demographers and those working in the population field. For instance, the IUSSP website could host forums or blog pages dedicated to topics of particular interest to members. As a pilot, it was decided to start a forum on population ageing. We will keep you informed of future developments.

The Council also reviewed the past training activities the IUSSP has undertaken with funding from UNFPA and The William and Flora Hewlett Foundation. Open distance learning materials-- Tools for Demographic Estimation and Population Analysis for Policies and Programmes--developed with funding provided by UNFPA are now available on the IUSSP website. The IUSSP has also collaborated on a project to reinforce demographic training in

Francophone Africa, organizing training workshops on advanced statistical methods and Q-GIS in Dakar, Marrakech, Ouagadougou, and Yaoundé. This project has been refinanced by the William and Flora Hewlett Foundation to continue on through to 2015.

Reinforcing ties with regional population associations (ALAP, APA, EAPS, PAA, UAPS) was next on the agenda. The Council decided that IUSSP should have a more regular presence at conferences organized by these associations. IUSSP will set up a stand to present IUSSP activities and IUSSP Scientific Panel's will be asked to organize a special IUSSP session at these conferences. The regional associations will in return be given a dedicated page on the IUSSP website to advertise their activities and they will be asked to organize sessions at the IUSSP general Conference in 2017.

The Council strongly encouraged the IUSSP officers to make use of IUSSP's special consultative status with the United Nation' Economic and Social Council (ECOSOC). This status gives IUSSP the right to participate in and present statements on issues concerning population questions at meetings organized by the United Nations and associated UN bodies. Using this prerogative, Anastasia Gage made a statement at the most recent meeting of the Commission on Population and Development this past April.

Finally the Council had the pleasure to bestow the 2014 IUSSP Laureate on Thérèse Locoh.

Many other subjects were discussed at this first meeting: the new website, publication policy, new potential funding sources to assure the continuation of IUSSP activities, and the 2013 accounts, which were formally approved by email in May. For maximum efficiency, the Council members were assigned to serve on one of seven committees (list and membership below). These committees have already begun their work. Future issues of this newsletter will enable you to keep abreast of each committee's progress.

Members


Important sections of the IUSSP website are restricted to members in good standing: the membership directory, member profile pages and working papers from IUSSP seminars. Some features will only appear when you are logged in. As members you should therefore always log in to benefit from the full website and keep membership up-to-date so you can always access these features.


How to log in?

To log in, click on the green "Login" button at the top right of the home page and type in your email and password. Once you have successfully logged in, a welcome notice with your name appears at the top right of the website. If you have forgotten your password, use the "forgot your password" link to reset your password. If your email has changed, please do not create a new account – login with the email you used in the past and modify your email address in your profile.

Accurate personal data

It is important for members to update their personal data as this information appears in other areas of the IUSSP website. For instance a member's institutional affiliation will be displayed for paper authors in the online





seminar or conference programme and in the membership directory.

Profile page

The new website provides members with a much more complete profile page... *provided members take time to complete it*. This profile can include a short biography and description of your current research interests, your publications, fields of study and specializations, regional focus, language skills, etc. as well as a downloadable CV, a photograph and links to personal or professional websites. Members' profiles are accessible to other members through the Directory search tool.

To complete your profile, log in and go to "Membership" in the horizontal menu bar and click on "Edit my profile".

The information in the first section, "My details", is already filled in. If it is incorrect or no longer current, this is the moment to update this information.

You can also choose how you want your name to be displayed in the Directory profile. By default it is First-Middle-Last Name.

To select an institution from the reference list, type a key word for your institution in the autocomplete field and then select your institution from the list.



If your institution is not on this list, please remember to keep the name short and choose the largest entity e.g. the university or ministry rather than the department. When necessary, please indicate the country as well, e.g. Ministry of Health (Uganda). If you want to include your department, add it in the "current function/position" field, e.g. "full Professor and Chair, Department of Demography."

Do not forget to click "save" at the bottom of the page before moving to another page.

The other fields of the member profile can be filled by going to the headers in the right-hand column. For instance, you can update your mailing address in "My contact information"; select your areas of specialization, regional focus or working languages in "My areas of specialization"; in "My CV, you can upload a curriculum vitae, but we also encourage you to post a short biography and list your main publications.

For a better looking profile page, please copy-paste your text into Notepad to remove all formatting, then copy the plain text into the "WYSIWYG" text field and use the formatting options in the Tool Bar to italicise, bold, or underline text.

Find a member

The Directory search is accessed by clicking on "Find a member" in the quick links of the home page. This tool allows you to search for specific individuals, by typing their name or part of their name, or to search for a list of members who meet one or more of the search criteria. The results of your search will appear in a table where you can access members' profiles by clicking on their last name (left column).


Here are some of examples illustrating the features of the search tool:

*You can type in "legrand" and click search. Tom LeGrand will appear in the table and you can access his profile and contact information.

*You can also simply type "Legr" and then click search and find all the members whose name (first or last) contains the sequence "legr".

*You can search for student members based in Burkina Faso, anthropologists who speak Arabic, Ageing specialists who focus on East Asia, Population Council staff, or graduates of University of Pennsylvania.

The search tool will only find current members and only if they have accurately filled out the fields in the profile. So please complete your profile and keep your membership current!



Site Visit to Cape Town

XXVIII International Population Conference: Site Inspection Tour of Cape Town, South Africa

At the January 2014 IUSSP Council meeting, the Council accepted South Africa's proposal to host the XXVIII International Population Conference in Cape Town the week of **29 October to 4 November 2017**, contingent upon a successful site visit. **Anastasia Gage**, IUSSP President, and Mary Ellen Zuppan, IUSSP Executive Director, joined Council member Tom Moultrie in Cape Town, South Africa on 14-18 April 2014 to tour the Cape Town International Conference Centre (CTICC) and meet with host country organizers. Statistics South Africa will be the primary organization hosting the Conference, with support from many other IUSSP members and their institutions in South Africa.





The site visit was a resounding success. Cape Town offers excellent facilities and accommodations that meet the Conference requirements and which will ensure an enabling environment for scientific exchanges, professional networking, and social interactions for all who attend the 2017 International Population Conference – the first IUSSP General Conference to be held in sub-Saharan Africa. The Cape Town International Conference Centre (CTICC) is a state-ofthe-art facility with two auditoriums that together can accommodate up to 2,100 participants for the opening and closing ceremonies, a large ballroom and exhibit space with natural lighting and views of Table Mountain, and meeting rooms for up to 12 simultaneous sessions.

The **CTICC** is within walking distance of the Victoria and Albert Waterfront as well as being close to the downtown area with many hotels and restaurants. Participants can easily get around Cape Town using reliable public transportation and the Cape Peninsula using hop-on-hop-off tour buses.





Cape Town, set against the backdrop of Table Mountain, offers a uniquely beautiful setting for the XXVIII International Population Conference with something for everyone. For those interested in learning more about South African history and the legacy of apartheid, there are trips to Robben Island, guided tours of Cape Town's city center and neighborhoods as well as nearby **townships**, and museums chronicling the Cape's history. For nature lovers there is the **Kristenbosch National Botanical Garden**, hikes up to **Table Mountain** or a gondola ride for the less athletically inclined, and whale watching along the coast. And of course there are beautiful beaches, vineyards and tours of the wineries. Plenty to keep accompanying family members, partners and friends entertained during the day, and for participants to enjoy in the evenings and before and after the Conference.





After touring Cape Town, Mary Ellen and Anastasia travelled to Pretoria to meet with Pali Lehohla, Statistician General for South Africa and his team at Statistics South Africa. Pali Lehohla sees the Conference as an excellent opportunity to emphasize the importance of population data and the population sciences for their role in providing the knowledge base for policy making and planning to assure a better future for all South Africans. He hopes the conference will encourage young South Africans to study population sciences and statistics.

We look forward to working with **Statistics South Africa** and the **Cape Town International Convention Centre**on the Conference. IUSSP and **Statistics South Africa** are currently negotiating the terms of the final contract. Soon we will be issuing a call for suggestions to you, the members, for session topics to be considered during the first meeting of **International Organizing Committee (IOC)** in early 2015.

Busan Conference Report

The 2013 Busan Conference

The XXVII International Population Conference was held in Busan, Korea, from 26 to 31 August 2013. Over 2,100 population scientists, students and policy makers from 106 countries attended the conference to present and share their research and/or exchange on population issues in formal and informal events planned during the Conference. The IUSSP is very grateful to the Korean National Organizing Committee (NOC) for their extraordinary hospitality and the efforts they made to organize this Conference.

A survey of participants conducted shortly after the Conference showed that the Conference was a very positive experience for a large majority of respondents. Results show in particular that respondents appreciated the scientific quality of the Conference as well as their stay in Busan.

Side meetings and exhibit booths

Conference participants could visit booths set up by 32 institutions, publishers, research institutes and other organizations working in the population field. Twenty-five side meetings were organized during the Conference. The Conference evaluation conducted after the conference indicated good attendance with 89% of respondents visiting the exhibit booths and 56% attending at least one side meeting.

Social and cultural activities

In addition to the Welcome Reception hosted by the Mayor of Busan Metropolitan City on Monday 26 August, the Korean NOC organized a special banquet dinner for all delegates of the Conference on Wednesday 28 August.

Participants

Based on the 1,264 participants who registered online before the conference, the gender distribution was fairly balanced on the whole: 628 women (49.7%) and 636 men (50.3%). The proportion of women was higher for participants under 34. Participants younger than 34 accounted for 33% of all participants.

Participants hailed from all regions of the globe, but more than half the participants were from Asia; not a surprise given the location of the conference.

Most participants were scholars and researchers (45%) or students (32%), but there were also many who worked for national governments, international and national NGOs (19%).









Laureate 2014 Thérèse Locoh

The Laureate Ceremony took place at the European Population Conference, Budapest, Saturday 28 June 2014.

Thérèse Locoh, an active member of the IUSSP since 1965, has been elected the 2014 IUSSP Laureate for her important contributions to demographic research on family, fertility, and gender in Africa. She was one of the first Frenchspeaking demographers to perceive the key role of gender relations in demographic behaviour. As a member of the IUSSP Committee on the Comparative Analysis of Fertility, she helped to organize a major conference and co-edited with Veronique Hertrich, The Onset of Fertility Transition in Sub-



Saharan Africa (OE, 1994). She also played key roles in the establishment of population studies in Francophone West Africa and elsewhere notably setting up the Unité de recherche démographique (URD) at the University of Benin, in Lome, Togo in 1975, and later she was involved in establishing the Union for African Population Studies (UAPS). In France, she worked mainly for the French Population and Development Research Centre (CEPED) and the French national institute for population studies (INED). Thérèse Locoh retired in 2003 but continues to contribute to research and scientific publications and serves as a scientific consultant for the URD and as a member of the "Culture, Gender and Development" scientific committee of UAPS.
