2021 International Population Conference

5-10 December **Hyderabad, India**

The 2021 International Population Conference (IPC2021) will be organized around 25 general themes (see list below). The International Organizing Committee selected conveners with the aim of ensuring topical expertise, efficiency, geographic and gender balance and selecting members who were not already chairs of IUSSP scientific Panels or conveners for the last IUSSP conference.

Unlike previous conferences, there will be no call for session suggestions. The Conveners will create sessions by relying on the evaluations and comments reviewers have provided on abstract submissions; they will select session chairs and discussants from the list of reviewers who volunteer for these roles. Reviewers thus play a critical role in the creation of the scientific programme.

The IPC organizing committee plans to recruit up to 300 reviewers with expertise in a broad range of thematic and topical areas to assure 2 reviews for each abstract submitted to the Call for Papers. In the coming months we will be sending out invitations to qualifying IUSSP members to be reviewers. The Council will select members from the IUSSP database who have demonstrated experience.

Reviewers will have the opportunity to be considered to chair a session in one of the conference themes. We hope as many of you as possible who receive the invitation to be a reviewer will say yes. Even those who do not plan to attend the Conference can of course participate in the review of abstracts. Involving as many members as possible will enable a much broader range of members to participate in the creation of the conference programme for the International Population Conference.

If you have colleagues who are not yet members, who would like to participate in the conference in this capacity, please encourage them to become an IUSSP member so they can be invited to be a reviewer.

The call for papers will be issued in early 2020 and the deadline to submit an abstract will be 7 January 2021. The Conference itself will take place 5-10 December 2021 at the Hyderabad International Convention Centre.

2019 IUSSP Laureate Ceremony for Alberto Palloni

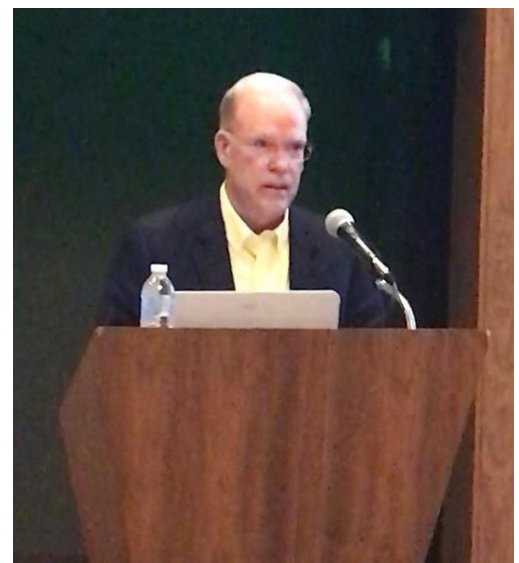
PAA annual meeting in Austin, Texas on Wednesday 10 April 2019

Alberto Palloni was presented with the IUSSP Laureate Award in the presence of his friends, family, colleagues and former students at a ceremony held in his honour during the annual meetings of the Population Association of America in Austin, Texas. The ceremony included speeches by Tom LeGrand, Sam Preston, Hiram Beltram-Sanchez and Jenna Nobles highlighting Alberto Palloni's exceptional contributions to the population field through his research, publications and teaching career that spans over 4 decades. The ceremony was filmed and, for those wanting to learn more about Alberto Palloni's remarkable career as well as his current research, we invite you to view the **videos** (below) and to read his **nomination letter** and **CV**.



Tom LeGrand introduced the IUSSP Laureate award and provided an overview of Alberto Palloni's background and exceptional career. An Italian national raised and educated in Chile, Alberto came to the US for doctoral studies, and received his PhD in Sociology at the University of Washington. He went on to the University of Wisconsin-Madison where he became the Samuel H. Preston and E.T. Young Professor of Population and International Studies and is currently an Emeritus Professor of Sociology. During his career, he has held many visiting professorships at major international universities and received several prestigious awards for his research and contributions to the field on a range of topics in the broad areas of health, morbidity and mortality.

Sam Preston, whose talk was entitled "Alberto Palloni: the man and the myth" began by describing his first encounter with Alberto Palloni as a graduate student. He went on to explain the qualities that made Alberto one of the most productive demographers in the world over the past 4 decades. These include his technical talents as a statistician and demographer, his insistence on rigorous causal reasoning, and his thirst to identify new issues. Alberto's contributions and discoveries led to new developments in many substantive areas including the measurement of mortality, the analysis of interbirth intervals, the study of demographic change in Latin America, the demography and epidemiology of AIDS, household size and structure, the Hispanic "mortality paradox", demographic responses to economic fluctuations and deforestation, biodemography, and early life factors in adult mortality variation.





Hiram Beltram-Sanchez focused on Alberto Palloni's fundamental contributions to our understanding of the demography of Latin America, which no scholar of population change in Latin America can ignore, and the influence he has had on Latin American population research and researchers.

Jenna Nobles focused on Alberto Palloni's impact through his influence on colleagues and students. In preparation for her talk, she conducted interviews with 15 of his former PhD Students. All of them stressed the exceptional scope of Alberto's thinking, describing him as someone who was ahead of his time in pushing the frontiers of research. He possessed a broad view of social sciences that, in turn, broadened the scope of thinking for those who worked with him. His rigor and thirst to identify new issues at times made completing projects a challenge, but all accorded that working with Alberto made them better researchers and led them to make their own important contributions to the field.



After the speeches and presentation of the award, Alberto Palloni took the floor to thank all those who had nominated him, expressing both his surprise at the award as well as thanks for the recognition. He took a moment to respond to some of the memories shared by the presenters about his work as well as recounting his latest endeavor. In his retirement, he has moved away from population studies to pursue a second PhD combining genetics, developmental biology, mathematics and evolutionary biology. He thinks this will help him answer lingering questions about the relationship between the early conditions of human life and subsequent adult health and longevity – a topic that he had approached via demography. Alberto Palloni continues to be ahead of his time, pursuing difficult, big questions.

IUSSP Laureate: new criteria and call for 2020 nominations

Each year the IUSSP honours one of its members by bestowing its Laureate Award. The IUSSP Laureate Award was established in 1991 to recognize the life-time achievements of outstanding IUSSP members. Contributions to the advancement of population sciences and distinguished service rendered to the IUSSP are considered when bestowing the award. The IUSSP membership nominates candidates for this award and the IUSSP Council selects the successful candidate by secret ballot after careful review of each candidate's dossier and testimonials.

New and more inclusive criteria

Considering that the criteria for the Laureate Award were onerous and no longer fully reflect today's realities, the Council decided to adjust the criteria and make them more inclusive. To be eligible for consideration, an individual must now :

- Have been a member of the IUSSP for at least 10 years (*rather than 20 years*) and currently be a member.
- Be nominated by five or more IUSSP members from different countries; self-nominations will not be considered.
- Members of the current Council may not be nominated for the Laureate award, but members of previous Councils, including Honorary Presidents, are eligible (*they used to be excluded*).

Nominated candidates remain eligible for the award for a period of 4 years (*rather than 2 years*).

Nominations for the 2020 IUSSP Laureate Award are invited and should be sent to the Executive Director of the IUSSP **by 1 November 2019**.

Climate Change, Human Migration and Health Mini-Conference:

“Integrating social and environmental data to accelerate innovative science”

CU Population Center, University of Colorado Boulder

Boulder (Colorado), United States, 20-21 May 2019

Forty scholars from across the globe came together in Boulder, Colorado to share research on how climate change is influencing human migration patterns, while also impacting human health. The two-day workshop was organized by the University of Colorado Population Center (CUPC) and IUSSP’s Special Emphasis Panel focused on Climate, Migration and Health. Funding was provided by IUSSP, NICHD, CU Boulder’s Earth Lab, Institute of Behavioral Science (IBS) and Research and Innovation Office.



A central focus of the conversations was the innovations in the integration of social and ecological data that are essential to move forward these critical research frontiers, as well as to investigate other human dimensions of global environmental change.

The conference helped move forward our understanding of successes, challenges and the potential of social and ecological data integration. Participation by both social and natural scientists yielded informative interdisciplinary dialogue.

Since 2008, an average of 26.4 million people per year have been displaced from their homes by natural disasters — an estimated one person every second.[1] Recent **IPCC** reports suggest some extreme events will become more intense as global temperatures warm.[2] Human movement in response to climate extremes have critically important implications for human health in both sending and receiving regions as new health challenges emerge and health systems are increasingly overstretched. Climate change also has documented impacts, itself, on human health such as increased heat-related deaths.

During this 2-day conference, Day 1 opened with inspirational speakers reviewing innovations, challenges and needs in socio-ecological data integration with a focus on climate change as related to migration and human health. Afternoon research panels and a poster reception provided important empirical examples. Day 2 offered flash research sessions as well as topically-focused working groups aimed to set research agendas, build collaborations, and/or work toward high-impact scientific publications.

International Migration Panel activities

The IUSSP Panel on **International Migration: Strengthening the Knowledge Base for Policy** is acting on its terms of reference to encourage population scholars to address conceptual, technical and policy issues concerning international migration, and to engage emerging population scientists in international migration scholarship.

For the **Second Asian Population Forum**, to be held in Shanghai, China, 11-12 October 2019, the Panel is collaborating with the Asian Demographic Research Institute (ADRI), Shanghai University to organize a panel session on "*Priorities for international migration research in Asia*" and to implement a **training workshop on the estimation of migration**. The aim of this workshop is to address the significant weaknesses in international migration data as a route to better understand contemporary and emerging migration patterns and trends. The goal is to adapt this training programme for implementation over the next several years in other regions of the world and concurrently develop training materials for migration measurement, analysis and estimation for inclusion in demographic curricula and the development of a training manual. *[Persons interesting in participating in the workshop should visit: <https://www.surveymonkey.com/r/adri-workshop2019>].*

Engagement of demographers and other social scientists in international migration research will be encouraged through Panel participation in forthcoming international and regional population and migration conferences including the **XV Argentinian Population Conference and II International Congress of the Southern Cone** in San Juan, Argentina, 18-20 September 2019. Interactive sessions and roundtables will critically consider priorities in the conceptualization and empirical analysis of international migration. Proposals for participation will also be submitted to the **2nd International Forum on Migration Statistics** that will take place in Cairo, Egypt, 20-21 January 2020. A centerpiece of these sessions will be the testing of ideas concerning the challenges and opportunities for the implementation of a World Migration Survey. Panel members Philippe Fargues and Marcela Cerrutti are building on the previous work of fellow demographers to make the case for a survey in a proposal that includes, but moves beyond, a call for action by presenting alternative strategies to generate migration and social demographic data that are representative, comparative and policy relevant.

To foster integration of evidence into international migration governance, the Panel has submitted an intervention to UN Member State leadership (Permanent Representatives of Bangladesh and Spain) developing the modalities for the International Migration Review Forum (IMRF). The IMRF will serve as process to monitor the implementation of the Global Compact for Safe, Orderly and Regular Migration. (A useful resource describing the IMRF process is <https://sdg.iisd.org/news/co-facilitators-issue-zero-draft-on-internatio...>) We argue for a formal and sustained role of demographers and migration scholars in the analysis of national and regional implementation of the Global Compact for Migration. Models for participation of the research community in these global commitments include technical expert meetings, commissioned scientific studies of migration and, very critically, institutionalization of an independent scientific group to consider progress towards secure, just, and sustainable processes of human migration.

Roger Schofield (1937-2019)

Roger Schofield sadly died on April 8, 2019. He had joined the IUSSP in 1972 and had participated in two IUSSP Committees on Historical Demography, as a member (1982-1986) and then as chair (1987-1990). The research carried out by these committees was published in two volumes co-edited by Roger Schofield: *The Decline of Mortality in Europe* (1991) and *Old and New Methods in Historical Demography* (1993).



Roger Schofield had gained worldwide recognition for his contributions to the ingenious reconstruction of the population history of England, published in two seminal volumes: *The Population History of England 1541-1871* (1981) and *English Population History from Family Reconstitution 1580-1837* (1997). Both were true products of teamwork at the Cambridge Group for the History of Population and Social Structure, University of Cambridge. These works, whose impact goes far beyond traditional disciplinary borders, have provided inspiration for many scholars ever since they were published. Roger Schofield also played an important role in the international development of historical demography, always encouraging young scholars to develop their skills, and always supportive.

Roger Schofield was born in 1937 and received both undergraduate and PhD degrees in history from the University of Cambridge. Toward the end of January 1966, he happened to listen to a talk on the radio, the famous BBC Radio 3, given by Tony Wrigley. The talk was about how little was known of the population size of England in the past and about the importance of acquiring such knowledge. And the project had a curious relevance to Roger Schofield's problems in research because he was at that stage trying to use the taxation returns of the early sixteenth century to measure the movement in village populations. His doctoral dissertation, performed under the supervision of one Geoffrey Elton, was on the levying of direct taxation in England under Henry VII and VIII. This work was later on published in 2004 under the title *Taxation Under the Early Tudors 1485-1547*.

In 1966 he was appointed as Research Assistant at the Cambridge Group for the History of Population and Social Structure, then only two years old itself. He quickly began to play a major role in corresponding with and encouraging 'le secret weapon anglais': the small army of amateur local historians who collected and counted baptisms, burials and marriages from parish registers around the country in an early crowd sourcing exercise. He played a major role in the analyses of these data, offering important and novel interpretations of the course of British population history, published in numerous journal articles and books. He was Director of the Cambridge Group from 1974 to 1994, and played a significant role in British and international historical demography: among other roles he was President of the British Society of Population Studies, 1985-87, and was elected a Fellow of the British Academy in 1988. He was Fellow of Clare College, Cambridge since 1969, and Fellow of the Royal Historical Society and the Royal Statistical Society. He was editor of the journal *Population Studies* and one of the first Europeans to be on the Editorial board of the journal *Demography*. He was also President of the US Social Science History Association. Earlier this year, the European Society for Historical Demography honoured his scientific contribution by establishing an award in his name to recognize an outstanding young demographer. Roger Schofield was a great example of a bright early stage researcher who reached world scientific recognition.
