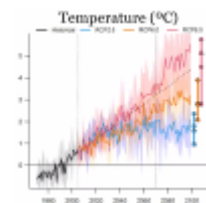

IPC 2021 Scientific Programme

The 2021 International Population Conference will be completely virtual, taking place 5-10 December, with regular sessions starting on 6 December.

The IPC2021 International Organizing Committee (IOC) approved the preliminary scientific programme at its virtual meeting on 7-8 September. The **draft Scientific Programme** includes 181 sessions and 790 papers across 26 themes that conveners created from submissions to the Call for Papers. In addition, 500 papers will be presented as posters, which will be on display in a poster gallery for the duration of the conference and have dedicated poster sessions in a Gather.Town poster hall where participants can meet and discuss with the poster authors and other conference attendees.

The conference will also include **Research Leader Sessions** and a series of invited keynotes, debates, round-tables and panel discussions. Leading researchers will speak on critical issues facing the field and the world, focusing on challenges, such as climate change, where demographic data and analysis will be vital to developing evidence-informed policy.

The conference platform will open before 5 December to allow attendees to review and select sessions to bookmark in their calendar. Live sessions will start on 6 December with over 18 hours of daily programming beginning at 2:00 GMT/UTC and ending at 23:30 GMT/UTC. So, no matter what part of the globe you are joining from, you should find a session taking place at a reasonable hour. Sessions will include pre-recorded (and therefore glitch-free) presentations, followed by live discussion and Q & A. An informal meet-the-author discussion will follow each live session. All sessions will be video recorded and available shortly after and for up to one month after the conference – so if you miss a session or it is not at a convenient time, you can always watch it later.

If you submitted an abstract to IPC2021 and have not received a notice, log in to <https://ipc2021.popconf.org/> and go to the switchboard to see the status of your paper. You should register before 15 October to secure your paper's slot on the programme. As soon as we have confirmed the majority of session chairs, we will schedule the programme.

If you do not have a paper on the programme, take advantage of this first virtual International Population Conference. To encourage broad attendance, the IOC has decided to offer a much-reduced conference registration fee for attendees who are not presenting authors of a paper or poster. The fee ranges from 20 euro for IUSSP student associates and members in low- and middle-income countries and 50 euros for members in high-income countries to 75 euros for non-members; it will be available after 15 October (see **registration**).

Also, consider sharing the experience with students and colleagues. Become a conference hub holding a “watch party” projecting sessions on a large screen for all to follow.

The final programme for IPC2021 will be available after 1 November. The final content will depend on the number of presenting authors who register to confirm their paper's slot on the programme before 15 October. In the meantime, check out the preliminary programme.

We hope you all join the virtual IPC2021 in December.

This webinar honours **Zeng Yi** as **IUSSP's 31st Laureate**. Zeng Yi is Professor of Population Science at the National School of Development and Honorary Director of the Center for Healthy Aging and Development Studies at Peking University and Professor at the Center for the Study of Aging and Human Development and Director of the Center for Chinese Population and Socioeconomic Studies, Duke University. This award recognizes his outstanding contributions to the advancement of population science, in particular his work on healthy aging and family and household demography.

After an introduction by **Frans Willekens**, **Harvey Jay Cohen**, **James Vaupel** and **Lei Xiaoyan** will pay tribute to Zeng Yi's career and achievements. These will be followed by illustrations of the impact of Zeng Yi's research: **Jiehua Lu** will present the **Chinese Longitudinal Healthy Longevity Study** (CLHLS) and its successor, the Chinese Healthy Longevity and Happy Family Study, and **Feng Qiushi** and **Tirza Aidar** will present **ProFamy**, the multistate family household and living arrangement projection model.

Would you like one of your colleagues to be honoured for their decisive contribution to the advancement of demography and population research? Do not hesitate to round up support and propose a nomination for the 2021 IUSSP Laureate award. Your colleague may become the next IUSSP Laureate, following in the footsteps of previous illustrious IUSSP Laureates (see the full list of Laureates on the [IUSSP website](#)).

To be eligible for consideration, an individual must be a current member of the IUSSP and have been a member for at least 10 years. Outstanding contributions to the advancement of population sciences and distinguished service rendered to the Union and the profession are factors that will be taken into consideration by the IUSSP Council in selecting the 2022 Laureate. Members of the current Council may not be nominated for the award. The nomination letter should include a supporting statement and be signed by at least five current IUSSP members of different nationalities. Self-nominations will not be considered. The IUSSP Council members select the winning Laureate candidate by secret ballot, and therefore they should not be contacted to nominate or support individual candidates. The letter of nomination and all supporting documents should be sent to the IUSSP Secretariat in Paris to the attention of the Executive Director, Mary Ellen Zuppan, **by 1 November 2021**.

International Migration Panel activities

July-August 2021

Members of the **IUSSP Panel on International Migration: Strengthening the Knowledge Base for Policy** continue to advance the themes of panel through writing, convenings, conference participation and trainings.

In May 2021, “**The Case for a World Migration Survey**” was published by the IUSSP as Policy and Research Paper No. 25. Authored by Panel members, Marcela Cerrutti, Philippe Fargues, and Mariama Awumbila, the paper sets out the rationale – and timeliness – of reinvigorating the argument for internationally, and regionally, comparable data and measures of international migration and mobilities to address causes and consequences of international migration and population movements. Building on the Panel’s record of engaging population scientists at regional professional meetings, IUSSP Council member Mohammad Jalal Abbasi-Shavazi and IUSSP Panel chair Ellen Percy Kraly coordinated a Round-table discussion, “**Advancing a global survey on migration: Perspectives from Asia**” at the 5th Asian Population Association Conference, 3-5 August 2021. Facilitated by Diego Iturralde (Statistics South Africa) and Ellen Percy Kraly (Colgate University), the roundtable began with a brief summary of the IUSSP Policy and Research Paper by its authors, followed by commentary from by Professor Mohammad Jalal Abbasi-Shavazi (University of Tehran), Professor Yu Zhu (Fujian Normal University) and Frank Laczko (Director, Global Migration Data Analysis Center of the International Organization for Migration). The Roundtable stimulated a broad discussion of priorities in international migration research among attendees, including graduate students, in conversation with session participants.

Also at the APA conference, Professors Abbasi-Shavazi and Kraly made a presentation on “**Refugee and Forced Migration in Asia: Implications for Research and Training**” in the session on International Migration. Relatedly, Panel member Guy Abel continues to deliver trainings on measurement, estimation and analysis of migration including a five-day session for a **Statistics Korea-UNFPA summer seminar series**.

Themes of the Panel concerning national and international policy relevance of demographic research on international migration were also addressed by Ellen Percy Kraly during the **Voluntary National Review (VNR) process of the High-level Political Forum on Sustainable Development (HLPF)**, organized by the United Nations Network on Migration in July. Encouraged by IUSSP Panel member Bela Hovy to articulate a scientific perspective for the VNR Lab on Migration, Ellen Kraly addressed three dimensions of the intersections between the 2030 Agenda for Sustainable Development and the Global Compact for Safe, Orderly and Regular Migration (GCM): (i) linkages between VNR and the Review Forum of the GCM; (ii) thickening the foundation of demographic data regarding migration in relationship to the goals for sustainable development; and (iii) the relevance, role and value of stakeholders within civil society, specifically, academia and scientific organizations, to the VNR process and more generally the implementation of the GCM.

Training Workshop on Geoprocessing and Spatial Analysis

Description:

Space matters. This statement has been increasingly proven by scientific studies in several fields of knowledge, including demography. However, there is still little time dedicated to the training of demographers to incorporate the space into their investigations.

The goals of this online training workshop were to:

- Present an overview of why space matters, showing examples from mortality, fertility and migration studies;
- Introduce attendees to the fundamental elements of the theory of geoprocessing and practice of spatial analysis so that they can, on their own, continue looking for their improvement in the area, in a much faster and more efficient way;
- Expand the use of spatial data in demographic analysis, providing key spatial resources for research projects.

The 90-minute workshop was divided into three components:

1. Short introduction of the workshop structure followed by a pre-recorded lecture on the “Potentialities of Geoprocessing and Spatial Analysis for Demographic Research”;
2. Hands-on training using QGIS, a free software that should be downloaded before the workshop (<https://qgis.org>). The study case will be COVID-19 spatial patterns and their clustering with social vulnerabilities;
3. Q&A session.

Target group: Students/researchers seeking to deepen their knowledge on spatial tools applied to population studies. No prior knowledge about the topic or software is required to be able to follow the training.

Shared Socioeconomic Pathways and population dynamics

The prominent contribution of demography in the field of climate change is in understanding how current and future population size, distribution and composition drive climate changing carbon emissions. More recently, the interest in population dynamics in climate change research has also extended to identification of vulnerable populations and their locations. Whilst much research progress has been made, there is no scientific consensus regarding the direction and the extent to which climate change will influence population dynamics i.e. fertility, mortality and migration.

With the global temperatures on course of rising for a 2 to 5 degrees Celsius by the end of the century, the assumption that there will be no climate feedback on demographic processes needs to be challenged.

This seminar aimed to assess the climate feedback on population trends by considering:

- The direction and the extent to which climate change influences fertility, mortality and migration – the three demographic components underlying population change
- Spatial and demographic heterogeneity in the climate impact on demographic outcomes
- Mechanisms through which climate change influence fertility, mortality and migration
