## Other Announcements

### Major change in Human Mortality Database

The [Human Mortality Database](#) (HMD), a joint project of the Max-Planck Institute for Demographic Research (MPIDR), the University of California, Berkeley, and the French Institute for Population Studies (INED), has undergone a major uplift. Data by cause of death for 18 countries are now available in the HMD. The Human Cause-of-death Data series is now part of the HMD (HCD@HMD) at <https://www.mortality.org/Data/HCD>. Its prior incarnation, the stand-alone Human Cause-of-death Database is thus now discontinued. Like its predecessor, HCD@HMD provides an updated continuous data series with causes of death classified according to a constant (fixed) list/classification, taking into account the periodic changes to the International Classification of Diseases.



### European Doctoral School of Demography

The European Doctoral School of Demography (EDSD) is a fully funded 11-month program for Master's degree students in demography or related fields. Courses are taught in English and focus on developing students' quantitative and programming skills. 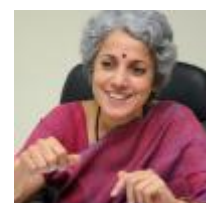

## Call for 2029 IPC Host Country candidates

**The IUSSP invites national population associations and other national institutions to consider hosting the XXXI International Population Conference in 2029.**

If you or other members of your national association or institution are interested in hosting the 2029 International Population Conference, please contact IUSSP Executive Director, Mary Ellen Zuppan ([zuppan@iussp.org](mailto:zuppan@iussp.org)) to ask for additional information and/or let us know of your interest.

Considering four years is now the minimum amount of time required to adequately organize such a meeting and ensure the availability of conference facilities, **formal bid proposals are requested for 15 March 2025**, but in the meantime, expressions of interest are welcome. The host country for the 2029 International Population Conference will be announced at the Closing Ceremony at IPC2025 in Brisbane, Australia on 18 July 2025.

### **Information on hosting the International Population Conference:**

The IUSSP organises the International Population Conference once every four years in collaboration with a host country institution. This is a major international event that draws population specialists, policymakers, academics and government officials from around the world to present the latest population research and discuss pressing global and regional population issues. Typically, between 1500 and 2000 researchers, policy makers, funders and government representatives attend these conferences.

Host country organisers can be governmental or private institutions, a national population association, or a group of institutions. Organisers can also propose a multi-country collaboration. The host country organiser is expected to handle local arrangements and costs for the Conference. Costs range between 2-3 million USD depending on the costs of services and facilities in the host country.

The final proposal should include a description of host country facilities and how the host country will organise the event, making sure to address all host country requirements listed in the guidelines; a budget of host country costs; and, a list of secured and potential donors to support the bid and/or a fundraising plan.

# Request for Proposals: Technical Support for a FAIR Vocabulary of Demography

1 March 2024

**Deadline for proposals: 1 June 2024**

IUSSP seeks partners for the creation of a Multilingual FAIR Vocabulary of Demography. The joint **IUSSP-CODATA Working Group** has recommended the creation of a vocabulary of demographic terms consistent with the FAIR principles (Cox et al., 2021; Wilkinson et al., 2016). The new Vocabulary will provide authoritative definitions of demographic terms in a form accessible by both humans and machines consistent with emerging standards for the semantic web. The IUSSP **Standing Committee on Demographic Terminology** will oversee the content of the Vocabulary. IUSSP seeks partners with the technical capabilities required for creating and sustaining a FAIR online platform for the Vocabulary. Support for the FAIR principles is very strong among national and international research agencies, and IUSSP will favor partners who can seek funding for the work described here.

The project is expected to have two phases, development and long-term services, which may involve different partners.

## 1. Capture and reformat existing dictionaries and thesauri

IUSSP has been publishing definitions of demographic terms in multiple languages since 1954, and most of the content for the FAIR Vocabulary of Demography already exists in electronic form. However, much of this content will need to be reformatted for the new platform.

The Institut National d'Études Démographiques (INED) preserved earlier efforts in two online services: **Demopædia** and **DemoVoc**. Demopædia provides short essays defining demographic terms in 18 languages. Demopædia is built on Wikipages, but terms are also available in an SQL database. DemoVoc is a thesaurus of demographic terms in both French and English, which is built on the SKOSMOS platform. DemoVoc does not include definitions, but it does use SKOS to describe relationships between terms.

Partners in this phase will work with the IUSSP Standing Committee on Demographic Terminology to decide the best way to combine the features of Demopædia (18 languages, definitions) with DemoVoc (SKOS relationships among terms).

## 2. Long-term FAIR vocabulary service

IUSSP seeks a partner who can provide a platform for the Vocabulary with all of the features associated with FAIR (Cox et al., 2021). A model for governance of the Vocabulary is included as an Appendix to the report of the IUSSP-CODATA Working Group. The governance model is intended to simplify coordination between the partner maintaining the technical infrastructure of the Vocabulary and the IUSSP standing committee responsible for the content of the Vocabulary.

IUSSP is especially interested in having its Vocabulary of Demography adopted by the social science research community. As described in the Working Group report, this community relies

upon two metadata standards: Statistical Data and Metadata eXchange (SDMX) and Data Documentation Initiative (DDI). Strategies for reaching out to the SDMX, DDI, and other communities (like PxAXIS) will be very welcome.

Proposals should discuss the technical approach, capabilities and experience with the FAIR principles and commitment to long-term maintenance of the online platform. Please describe potential funding opportunities and plans for long-term sustainability.

## IUSSP Early Career Awards:

The IUSSP Early Career Awards were established in 2023 to acknowledge and honour outstanding contributions to the development of our discipline and the broad field of population studies by early career scholars in the various regions of the world and boost the global visibility of their achievements.

The IUSSP Early Career Awards are made through a unique collaboration between the IUSSP and regional associations, including, in Africa, the Union for African Population Studies (UAPS); in Asia and the Pacific, the Asian Population Association (APA); in Europe, the European Association for Population Studies (EAPS); in Latin America and the Pacific, the Latin American Population Association (ALAP); and in North America, the Population Association of America (PAA). One award is granted per region.

The 2023 competition for the IUSSP Early Career Awards received applications from a strong and diverse field of young scientists from all corners of the world. Some submissions were self-nominations and others were proposed by IUSSP members both from within and outside their region.

The international Jury was composed of representatives of the IUSSP and the regional population associations. Criteria used for judging submissions included: scientific productivity (publications); professional leadership (grant writing); networking (conference/workshop attendance); involvement in the IUSSP; and public engagement (outreach). The IUSSP is grateful to members of the jury and collaborating population associations for their support and hard work in ensuring an excellent set of applicants and making difficult decisions on awardees.

The IUSSP is proud to announce the awardees for the 2023 IUSSP Early Career Awards.

**Early Career Awardee, Africa: Dr Chaimae Drioui** is teaching at the National Institute of Statistics and Applied Economics (INSEA) in Rabat, Morocco. This center opened its doors in 2017, the year that Chaimae graduated as a State Engineer in Statistics and Demography. She joined the Gender, Economics, Actuarial, Statistics, Demography and Sustainable Development Laboratory of INSEA as part of the first class of the PhD cycle becoming the first student to defend her thesis at INSEA and obtain a PhD in demography (in 2022) from a Moroccan institution. Chaimae is a prolific demographer and statistician already listed as the lead author of four peer-reviewed journal publications. Her research is on gender, social inequalities and women's empowerment. Her PhD thesis examined fertility in the context of Middle Eastern and North African (MENA) countries and Morocco: an analysis through the diffusion of innovations and gender approaches. She is active on several UAPS panels and a member of several scientific associations in Morocco. She has published her research in high-quality indexed journals and presented at national and international conferences. The selection committee reviewing her achievements and active engagements in research and teaching noted that she is “a rising star in the demography of Africa”.





**Early Career Awardee, Asia and the Pacific region:**

**Dr Aude Bernard** is a senior lecturer at the University of Queensland, Australia. Aude has established a regional and international reputation as an innovative migration scholar. Her research has led to conceptual and methodological shifts in the field, created new substantive knowledge, and generated benefits both to the discipline and the region. Aude's research lies at the cutting edge of the field of internal migration and straddles formal and social demography. Her methodological contributions include developing measurement and estimation techniques that facilitate large-scale international comparisons of internal migration, their spatial patterns, and selectivity. Aude's work is an excellent example of cross-fertilization in demography. She has successfully applied concepts and methods from fertility – such as tempo effects and parity analysis – to migration to generate new insights into the dynamics of human mobility. Aude has demonstrated leadership capability in several research projects, contributed to capacity building in the region, and also has an impressive track record of service to our discipline.



**Early Career Awardee, Europe: Dr Heini Väisänen** is

a tenured researcher at the French Institute for Demographic Studies (INED). Heini is an exceptional early career researcher whose research and career have gone from strength to strength since her PhD in Demography from the London School of Economics. Her research output is substantial with publications in top journals. Heini has tackled under-researched areas in high- and low-income countries and has worked in interdisciplinary groups from different institutions. Through her work on abortion, she has gained a network of international colleagues in Europe, the United States, and Africa. Her most recent research addresses methodological and substantive questions around social inequalities that expose women to the risk of miscarriage and its adverse consequences. She was recently awarded the prestigious European Research Council (ERC) Starting Grant, which acknowledges her rising profile, the quality of her work, as well as her international networks. Heini is one of those rare researchers who applies advanced statistical methods without losing sight of the policy implications of the results.



**Early Career Awardee, Latin America & the Caribbean:**

**Dr Raquel Zanatta Coutinho** is a sociologist and demographer whose research interests focus on women's reproductive decisions and the sexual and reproductive contexts and inequalities that mediate the relationship between fertility intentions and outcomes. She is an Assistant Professor and a researcher at the Center for Regional Development and Planning (Cedeplar) at the Universidade Federal de Minas Gerais (UFMG), Brazil. Raquel received her PhD from the University of North Carolina at Chapel Hill with a dissertation on "The Transition to Low Fertility in Brazil." Raquel has extensive teaching experience both at the undergraduate and graduate



levels. She was the principal investigator in 2021 for projects on “Women's perception of obstetric care received in Belo Horizonte and its consequences for women's and children's health” and “Sexual and Reproductive Health, Gender and Conjuality in Minas Gerais in times of Covid-19”. Raquel has published in prestigious journals, such as *Demography*, and holds the distinguished Brazilian National Council for Scientific and Technological Development (CNPq) Fellowship for Research Productivity. Raquel's research has documented Brazilian women's lack of reproductive rights, as well as the effects of the Zika and Covid-19 epidemics on the number of live births and fertility rates in Brazil.

**Early Career Awardee, North America: Dr Amanda Stevenson** is an assistant professor at the Department of Sociology at the University of Colorado Boulder. Amanda has established an outstanding record of research on fertility leading a research project that has shown the population-level socio-economic impacts of increasing women's access to contraception. Although early in her career, she is recognized as a national leader in this area. She has an outstanding publication record and has also communicated her research results beyond the scientific community to the public through opinion pieces and by



providing expert testimony in court cases. In addition to her research accomplishments, Amanda is an outstanding teacher. In her research and other activities, Amanda takes seriously our collective scientific responsibility to study and communicate the ways that society and policy impact women's reproductive lives. It is this commitment to the highest standards of population science and to real people carrying out their individual reproductive lives that underlies the work of this remarkable young scientist.

## Assessing approaches to demand-side FP measurement with a reproductive justice and rights framework

*Mombasa, Kenya 5-7 March 2024*

The **IUSSP Panel on Rethinking Family Planning Measurement with a Reproductive Justice and Rights Lens**, in collaboration with Population Council-Kenya, organized an **Expert Meeting on Assessing Approaches to Demand-side Family Planning Measurement with a Reproductive Justice and Rights Framework** in Mombasa, Kenya 5-7 March 2024.

This expert group meeting brought together 54 researchers, programme implementors, policymakers, advocates and civil society representatives from diverse regions of the world to examine measures and measurement approaches to family planning and contraceptive use from a reproductive rights and justice perspective. The meeting included representatives of USAID, the Bill and Melinda Gates Foundation (BMGF provides funding for the Panel), DHS, UNFPA, WHO, the Guttmacher Institute, Population Council country offices in Kenya and India, PMA, African Population and Health Research Center (APHRC), and individuals from diverse institutions (academic and non-academic) working on gender, human rights, and person-centered approaches using innovative methods and data to measure contraceptive decision making, method preference, and reproductive agency and autonomy.

The objectives of the meeting were to: a) Convene and examine measures and measurement approaches with a reproductive rights and justice lens; b) Identify measures that can be used to assess family planning progress, opportunities, and gaps in a way that is reflective of individuals' self-identified needs and goals (i.e., person-centered); and c) Discuss ways forward to advance global family planning measurement in preparation for a post-2030 measurement agenda.

The 3-day meeting began with an overview of frameworks and terminology for family planning measurement with a reproductive rights and justice perspective, including a deep dive into explaining **reproductive justice**, human rights-based family planning and person-centered measurement. These frameworks underlay the three days of discussion, reflecting on how to build measures that are respectful of and responsive to individuals' own expressed values, needs and preferences, as well as measures that reflect the full range of reproductive choices, and that bring a lens of analyzing power and shedding light on marginalization.

The meeting then considered the pros and cons of current measures such as “intention to use contraception” and discussed the general dissatisfaction with “unmet need” as a global measure of family planning need. The meeting followed with presentations of research using new approaches to measure family planning needs and preferences, including method preferences and novel data and indicators to measure contraceptive and reproductive autonomy, as well as a discussion of their relevance to the post-2030 measurement agenda and the Sustainable Development Goals (SDGs).

The meeting included afternoon breakout sessions to build on the morning's presentations with discussion and reflections from all participants to generate ideas and recommendations on person-centered focused data sources, insights and measures and ways to move forward. The discussion greatly benefited from the participation of experts from diverse regions – Africa, Asia and Latin America– who brought to the discussion the importance of context, community and the role governments will play in the adoption of any new measures at the country level for monitoring contraceptive use.

It was a lively meeting with much discussion and input from all participants. A report will be soon forthcoming, and the panel will be working towards the development of recommendations over the coming year.

The Panel plans to hold meetings at upcoming regional population conferences to present the lessons learned from this meeting and continue discussions with those working on family planning monitoring and measurement around the globe. The first presentation will take place on **Wednesday 17 April from 3-6pm at the PAA Annual Meeting in Columbus, Ohio in room Franklin D.**

This meeting was organized in collaboration with Population Council -Kenya and with the support of a grant from the Bill and Melinda Gates Foundation, and with additional support from USAID through the Carolina Population Center at the University of North Carolina at Chapel Hill. We thank these donors and all the participants for their enthusiastic participation and thoughtful contributions to this meeting and to the IUSSP Panel Steering Committee members for their thoughtful selection of presentations and participants and the overall organization of the meeting agenda.

## Measuring abortion in restrictive settings: applying global lessons to the United States after the fall of Roe

18 March 2024

**Description:** As a result of the United States Supreme Court’s June 2022 decision in *Dobbs v. Jackson Women's Health Organization*, the landscape of reproductive health care in the US is in the midst of seismic and rapid change. Abrupt changes in access to abortion in the US are without precedent in terms of the number of individuals who are affected, the number of states in which there remains substantial uncertainty around abortion policy changes in the near future, and the scale of potential effects on the lives of pregnant people. This presentation will discuss a new project underway to assess the impact of state abortion restrictions on the health of pregnant people, as well as the need for high quality estimates of abortion incidence both within and outside of the formal health care system as these restrictions are implemented. This includes the newly launched Monthly Abortion Provision Study and, drawing from lessons learned measuring abortion in restrictive settings globally, an adaptation of the Abortion Incidence Complications Method. This new work is aimed at establishing estimation approaches that encompass both facility-based and self-managed procedures and are designed for a context in which the legal status of abortion is hybridized and subject to rapid, ongoing changes, laying the foundation for a new surveillance infrastructure that will be needed for the foreseeable future in the US.

**Elizabeth Sully** is a Principal Research Scientist at the Guttmacher Institute, where her research focuses on abortion measurement, family planning, and assessing the cost and benefits of sexual and reproductive health services. Dr. Sully co-chairs the IUSSP Scientific Panel on Rethinking Global Family Planning Measurement, serves on the editorial committee for *Studies in Family Planning* and is a member of the FP2030 Performance Monitoring and Evidence Working Group. She earned her MA in public affairs and her PhD in public affairs and demography from the Princeton School of Public and International Affairs and the Office of Population Research.



# IUSSP Webinar: Innovations in data infrastructure for the longitudinal study of international migration

*7 March 2024*

Organized by: **IUSSP Scientific Panel on Lifetime Migration**

## Description

Data collection practices in migration studies have traditionally been limited to observations before migration in origin countries or after migration in destination countries. These practices have importantly shaped the conceptualization of migration – leading to enduring dichotomies between migrants and non-migrants or first- and second-generation migrants – and have often failed to recognize complex patterns of repeat migration and the diversity of migration experiences. Among others, this undermines our knowledge by constraining our capacity to ascertain and accurately measure migration rates (owing to multiple movements by migrants), uncover the intricacy and variety of migration trajectories (owing to intricate patterns of repeat, return, and circular mobility), and comprehend the selectivity of migration (owing to the recursive and reinforcing role of migration, even in earlier life stages).

This webinar spotlights an emerging data infrastructure that offers a distinct chance to initiate a transformation in how we approach the study of migration, shifting from viewing it as the result of a one-off event to understanding it as a lifelong trajectory that spans across countries.

The webinar addresses the imperative of investigating international migration trajectories alongside accomplished migration researchers who have played pivotal roles in gathering, assembling, or utilizing innovative migration datasets with longitudinal elements. These datasets encompass cross-national administrative records, digital traces, and survey data. The panelists share insights from their experiences in collecting and harnessing these pioneering datasets, offering recommendations for future data collection endeavours that support the examination of migration trajectories and the analysis of connections between various forms of population movement overtime.

### **Digital trace data: the Scholarly Migration Database (SMD)**

The Scholarly Migration Database (SMD) provides detailed data about the mobility of scholars. Scientists, journalists and policy analysts who are interested in the movements of published researchers can access high-quality datasets and estimates via this website. The SMD fills a gap in high-resolution and longitudinal data on the migration of scholars worldwide by using the unprecedented opportunity to repurpose scientific publications' metadata that spans more than 25 years.

### **Panel surveys: the GERPS project**

GERPS is a longitudinal survey that examines individual consequences of international migration from a life course perspective. The survey follows a nationally representative sample of recently emigrated and returned German citizens aged between 20 and 70 years. The panel covers the period Nov 2018 to Jan 2022, captured by five waves.

### **Linked cross-national register data: the Swedish-Finnish population register data**

The linked Swedish-Finnish population register data were constructed by integrating records of Finnish immigrants in Sweden from population registers in both Sweden and Finland. The two data sets were linked by the identification of migrants based on their unique personal identity numbers (PIN). The linkage allows identifying migrants who move back and forth between Finland and Sweden. Migration is measured by registration and deregistration from the population registers in each country. The linked data allow us to assess the reliability of the records by verifying that migrants who deregister in Finland appear in the Swedish register and vice versa. Comparing the month of exit from Finland and entry in Sweden, we find that for 98% of all moves, the timing of the migration in each country's register differs by less than 2 months.

### **Multi-sited surveys: the World Migration Survey (WMS)**

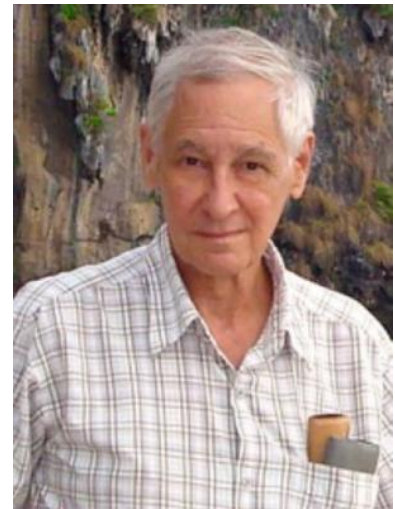
The proposed World Migration Survey (WMS) aims to generate comparative information on the levels, characteristics and dynamics of migration, its determinants and impacts particularly across the global South, collecting information from both migrants and non-migrants to better understand migrant selectivity. Employing a uniform methodology in all countries, the WMS will serve many purposes, including providing retrospective and biographical information to reconstruct migration trajectories, generating information that traditional migration data sources fail to fully capture.

## John Edwin Knodel (1940-2024)

*John E. Knodel died on January 10, 2024, in Ann Arbor, Michigan at the age of 83. He had joined the IUSSP in 1968 and participated in many of IUSSP's activities and numerous International Population Conferences. He was a member of two IUSSP committees - the Committee on Comparative Analysis of Fertility and Family Planning (1981-1985) and the Committee on Historical Demography (1987-1990) - and more recently, when IUSSP launched the weekly news magazine N-IUSSP, John volunteered to serve on its Editorial Committee.*



John was born on July 25, 1940, in Mt. Vernon, New York, to Henry and Edna Knodel. John had one sibling, Richie, who died in 2005. John's first marriage, to Erica Wessling, ended in divorce in 1984. John was married to his second wife, Chanpen Saengtienchai, from 1992 until his death. John had no children.

When John was about 10 years old, the Knodel family embarked on a European vacation. Connecting with their German roots was a central focus. The trip ignited John's lifelong passions for Germany and for what he would later come to know as historical demography. These early enthusiasms were fueled by his undergraduate experience at Duke University, where he was more formally introduced to the discipline of demography. He graduated in 1961 Phi Beta Kappa and summa cum laude with a degree in psychology.

John earned his Ph.D. in sociology from Princeton University in 1965 (at 25 years of age). He worked closely with Dr. Ansley Coale on the demographic history of Europe. Following his graduation from Princeton, John pursued a one-year post-doctoral fellowship at Free University, Berlin, immersing himself in the literature and data relevant to the decline of European fertility during the 18th, 19th, and 20th centuries. This research resulted in the publication of two classics in the field of historical demography: *The Decline of Fertility in Germany, 1871-1939* (1974) and *Demographic Behavior in the Past: A Study of Fourteen German Village Populations in the Eighteenth and Nineteenth Centuries* (1988). Evoking that summer vacation as a 10-year-old boy, John dedicated his first book to Henry and Edna: "For my parents, to whom I owe my interest in Germany".

Upon his return from Germany, John accepted an invitation to join the sociology faculty at Rutgers University and renewed his association with Princeton as a Research Scientist in the Office of Population Research. He continued his studies of historical European fertility but around this time he was introduced to a different part of the world that altered his academic path and shaped the rest of his life. In 1971, the Population Council and the Institute of Population Studies at Chulalongkorn University offered John a position in Bangkok. We have never heard a compelling explanation of why he accepted the offer and made such an abrupt shift in his research. We do know that after his first visit, he was hooked. John quickly became one of the foremost experts on the demography of Southeast Asia (especially Thailand) - a region that was experiencing in real time some of the same seismic shifts in fertility that Europe had undergone hundreds of years earlier and that John had studied so masterfully. John's substantive interests also rapidly expanded from fertility to include mortality; migration; intergenerational relations; aging; the interactions between the HIV epidemic and demographic processes; education; and research methods.

After two years with the Population Council in Thailand, John spent a year at Brown University before joining the Sociology Department and the Population Studies Center at the University of

Michigan, where he remained from 1975 to 2004 as regular faculty and afterwards as emeritus until his death. During this extremely productive period of his career, John solidified his relationships with his collaborators and with the major institutions focusing on demographic change in Southeast Asia, especially the College of Population Studies at Chulalongkorn University. He also pioneered research on demographic change (and many related topics) in Vietnam, Cambodia, and Myanmar, and created many opportunities for his U.S.-based colleagues and students in these difficult-to-access countries. Influential books from this period include *Fertility in Thailand: Trends, Differentials and Proximate Determinants* (1982) and *Thailand's Reproductive Revolution: Rapid Fertility Decline in a Third World Setting* (1987), co-authored with Thai colleagues Aphichat Chamrathirong and Nibhon Debavalya.

Major recognition for John's scholarship, teaching, and institution building includes the LS&A Excellence in Education Award from the University of Michigan; an honorary doctoral degree from Chulalongkorn University; election as Vice President of the PAA; and being named an Honored Member of the PAA.

Following John's formal retirement in 2004, he remained deeply engaged in research, mentoring, and institution building. John maintained an active affiliation with the Population Studies Center at the University of Michigan and with the College of Population Studies, Chulalongkorn University. John and his wife - and decades-long collaborator, Chanpen Saengtienchai - continued their long-established yearly migration between Ann Arbor and Bangkok (and the nearby beach town of Hua Hin, where they kept a condo for what John would call "weekend getaways" but the rest of us would refer to as "short work trips."). John so loved his Michigan and Thailand friends and colleagues that he could never imagine permanently decamping for one location or the other.

Perhaps John's most enduring legacy is his mentorship and his commitment to institution building, especially in low resource settings. John was especially generous to students, postdoctoral fellows, and junior faculty, including several he mentored from the University of Michigan and from many other U.S. based institutions. He frequently collaborated with scholars from other countries. A comprehensive list of students and junior colleagues John mentored from Southeast Asia would be vast. Many joined John as co-author on one or more of his multitudinous publications (see: [John Knodel CV](#)). Most of all, John loved Chanpen: collaborator, confidant, North Star, best friend, and love of his life.

## Michel Loriaux (1940-2024)

*It was with great sadness that we learned of the death of Professor Michel Loriaux on 12 February 2024. Michel Loriaux joined the IUSSP in 1969.*



A graduate in social sciences (1962) and economics (1965) from the University of Liège, Michel Loriaux joined the demography team at the Catholic University of Louvain in 1969, where he completed his doctorate.

He was appointed lecturer in 1994 and promoted to professor in 2002, after an already busy career at our University. From the 1970s onwards, he contributed to the development of several large-scale projects, including the demographic survey in Western Zaire (EDOZA) from 1975 to 1979, research on the demographic situation in Wallonia (POLIWA) between 1976 and 1979, and the International Centre for Training and Research in Population and Development (CIDEP) from 1987 to 1995. Throughout his career, he also conducted innovative and visionary research into demographic aging and intergenerational relations.

Michel Loriaux was a multi-faceted intellectual. A fine methodologist, a fervent advocate of systemic approaches in the social sciences, a man of fieldwork, a man of convictions and debates, he was also a captivating teacher, capable of taking his students into technical, theoretical, and political territory. An outstanding writer, Michel Loriaux has left us with a wealth of scientific articles, columns, and other stimulating writings. In 2005, after the tributes he received at his emeritus ceremony, Michel Loriaux wrote: "The discomfort of being praised is sometimes more difficult to overcome than the displeasure of being criticized or disputed." His words were in his image, a blend of wisdom, piquancy, and humor.

Michel Loriaux also had a great sense of service. In addition to his activities at the University, he chaired the Belgian Demography Society and the Association Générations, which focuses on intergenerational issues. Still very active after leaving the University, he remained faithful to his commitments to the causes that were close to his heart.
