Introduction

The International Union for the Scientific Study of Population (IUSSP), with over 2,368 members and 729 student associates from 138 countries on 31 December 2009, is the largest international professional association for individuals interested in population studies. The IUSSP is internationally recognized for its role in identifying emerging and critical population and development issues, encouraging scientific research on these topics, and sponsoring seminars, workshops, conferences, training sessions, and Internet forums at which critical issues can be discussed and debated.

The most important event in 2009 was the XXVI International Population Conference, organized in Marrakech, Morocco, 27 September-2 October 2009, which attracted 2,300 participants from all over the world, making it the best attended conference in IUSSP history.

In addition to the Conference, the IUSSP also sponsored nine other scientific activities in 2009, held its 26th General Assembly, and held elections for the 2010-2013 Council. Two special issues of peer-reviewed journals devoted to papers from IUSSP seminars and three IUSSP Policy & Research Papers were published. The IUSSP continues to update and improve its website where it makes its seminar reports and other information of interest accessible to the population community and the interested public. Seminar papers are made available to IUSSP members on the password protected portion of the website and all seminar reports are available to the general public on the IUSSP website (www.iussp.org).

In 2009, the IUSSP increased its focus on capacity building and training for developing country population scientists, organizing several expert meetings on this topic, setting up a scientific panel on Strengthening Demographic Training in Francophone Africa, organizing a training workshop and a weeklong summer school, and sending out a call for proposals to develop distance-based training materials on demographic estimation techniques.

In 2009, 414 new members and 422 new student associates joined the IUSSP. Membership increased for Africa, Asia, and Latin America.

XXVI International Population Conference

The IUSSP organized its XXVI International Population Conference in Marrakech, Morocco, from 27 September to 2 October 2009. The Conference was an enormous success with over 2,300 participants in attendance surpassing the record set at Tours. Participants of 116 nationalities attended the Conference. Forty-one countries had 10 or more participants in attendance. All regions were well represented among the participants (see Table 1, based on region of residence for 2,104 participants listed in the data base).

Participants were relatively young: 54% of participants were under 49 years of age and 18% of participants were students. Women made up just under half of the participants attending the conference (48%).

The Conference programme was organized around 219 regular sessions and 5 poster sessions. A total of 865 papers and 565 posters were presented in the regular and poster sessions covering 22 major themes. The regular programme also included 2 training sessions, 5 sessions organized by regional population associations from Latin America, Africa, Asia and Europe, and by the International Statistical Institute, and 10 sessions organized by the Moroccan National Organizing Committee (NOC) on population issues in the Arab world.

In addition to the regular and poster sessions, there were also 4 plenary sessions, 44 side meetings and 41 exhibit booths set up by a diverse array of institutions working in the population field and 2 special exhibits: one on the history of IUSSP International Population Conferences from 1959 to 2009, which was organized by the Vienna Institute of Demography, and one on the demography of Marrakech. The NOC also offered visits to local organizations working on population, health and development issues in the Marrakech region and generously organized two official gala dinners for all delegates of the Conference.

Thanks to funding from UNFPA, the William and Flora Hewlett Foundation, the Wellcome Trust, the Moroccan government, the French government and the French National Committee of the IUSSP, the IUSSP and the Moroccan National Organizing Committee provided support to 481 participants from 69 countries (23%). The number and proportion of funded participants for each region is indicated in last two columns of Table 1.

Due to high demand—a record 770 requests for travel support—the IUSSP and the Moroccan NOC could offer funding only to 71% of those requesting assistance. The IUSSP drew on reserves and registration fee income to supplement donor funds in order to offer support to 447 participants and the NOC offered support to 100 participants. Priority was given to sole and first authors of papers presented in regular sessions. Only one author per paper was offered

funding. A total of 481 accepted this support and attended the Conference. Almost half of the funded participants were women and 133 were students.

An evaluation of the Conference was carried out in October-November 2009. Over 60% of Conference participants responded to the on-line questionnaire and the results as well as a full report of the Conference will be made available on the IUSSP website by June 2010.

26th General Assembly

The 26th General Assembly of the IUSSP was held during the International Population Conference in Marrakech on 30 September 2009. Approximately 350 participants attended the meeting. Nico van Nimwegen, Secretary General and Treasurer, reported on the Union's activities and financial situation. Jacques Vallin, Honorary President of the IUSSP, presented the report of the 2006-2009 Committee on Nominations, which had prepared the slate of nominations for the 2009 elections. The list of candidates proposed by Council for the 2010-2013 Committee on Nominations, which will prepare the slate of nominations for the next Council elections in 2013, was presented to the membership in attendance and approved. The 2010-2013 Committee on Nominations includes Alaka Basu, Jean-Christophe Fotso, Kathleen Kiernan, Alan Simmons, Peng Xizhe and Maria Cosio Zavala and will be chaired by the outgoing President John Cleland. Council Elections

In 2005, the IUSSP Constitution was modified to permit voting by Internet. The IUSSP contracted with an Internet vote provider, eBallot (Votenet Solutions), to enable members to cast their vote via the Internet for the 2009 Council elections reducing the need for paper ballots and postage. Internet voting also made it easier for members to participate in the election and eliminated the problem of slow mail delivery and lost ballots. Members who preferred to receive their ballot by regular post were still able to do so. Approximately 100 postal ballots were sent to members who had requested postal ballots or who did not have a functioning email address. The Elections Committee, which included John Casterline (USA), Therèse Locoh (France), and Huda Zurayk (Lebanon), oversaw the entire electoral procedure.

The 2009 election had the highest rate of participation for a recent election: 49% of IUSSP members voted in 2009 compared with 41% in 2005. A total of 1,117 members cast their vote by Internet and another 27 voted by mail-in ballot. The increase in voter participation rates was particularly marked for members based in Asia, Africa and Latin America.

In addition to Peter McDonald (Australia), who as 2006-2009 Vice President will automatically become the next President, the 2010-2013 Council will include: Vice President Anastasia Gage (Sierra Leone/USA), Secretary General and Treasurer Emily Grundy (United Kingdom), and Council members Eileen Crimmins (USA), Alex Ezeh (Nigeria), Véronique Hertrich (France), Shireen Jejeebhoy (India), Fátima Juárez (Mexico), Marwan Khawaja (Lebanon), Tom LeGrand (Canada), Cheikh Mbacké (Senegal), Alberto Palloni (USA) and Catherine Rollet (France).

Awards

19th IUSSP Laureate Award

Each year the IUSSP honours one of its outstanding members by bestowing its Laureate Award. Outstanding contributions to the advancement of population science and distinguished service rendered to the IUSSP are taken into consideration in making this award. In 2009, Dr.

Jane Menken, Director of the Institute of Behavioural Science and Distinguished Professor of Sociology at the University of Colorado received the 19th IUSSP Laureate Award during a ceremony that took place on Wednesday 30 September at the International Population Conference in Marrakech, Morocco. Mattei Dogan Award

In 2005, the Mattei Dogan Foundation offered to establish an IUSSP-Mattei Dogan Foundation Award for Comparative Research in Demography to be bestowed every 4 years to an IUSSP member during the IUSSP International Population Conference. The Award honours a mid-career scientist of international renown for the contribution of his or her work to the development of studies of population that draw on perspectives of different disciplines and for the importance that this work has accorded to international comparisons. In 2009, the award was bestowed to Wolfgang Lutz (Austria), during the IUSSP General Assembly held on Wednesday 30 September. Wolfgang Lutz works for the International Institute for Applied Systems Analysis (IIASA) as Leader of the World Population Program and is also Director of the Vienna Institute of Demography (VID) of the Austrian Academy of Sciences. Wolfgang Lutz was selected for the importance of international comparison in his publications and the interdisciplinary nature of his work on population-development-environment issues. As part of this award he gave a presentation during the IUSSP Plenary on “Population and Climate Change”, on Thursday 1 October. Scientific Meetings in 2009

One of the IUSSP’s most important activities is the organization of scientific seminars and workshops where experts can discuss and debate research findings and programme initiatives. IUSSP seminars, conferences, and workshops advance knowledge on population issues and foster international and cross-disciplinary networks of scientists and policy makers working on critical population issues. Seminars and workshops are organized by IUSSP Scientific Panels and draw experts from a wide range of disciplines—demography, economics, sociology, epidemiology, medicine, history, anthropology, and statistics—thereby bringing diverse perspectives and approaches to a common problem. To encourage broad geographic participation in these seminars, the IUSSP may provide some travel subsidies to scholars from developing countries and elsewhere. IUSSP seminars contribute to the creation and strengthening of international networks of scholars and policy makers working on population issues.

In addition to activities which took place at the XXVI International Population Conference in Marrakech, the IUSSP organized 4 seminars and 1 cyberseminar in 2009:

- Seminar on Gender and Empowerment in the 21st century in Africa, Nairobi, Kenya, 24-26 August 2009, organized by the Panel on Gender

- Seminar on Equity Oriented Health Policies: Approaches and Strategies, London, UK, 2-4 November 2009, organized by the Panel on Health Equity and Policy in the Arab World

Cyberseminar on Theoretical and Methodological Issues of the Analysis of Population Dynamics and the Environment, 2-13 February 2009

This cyberseminar was organized by the Population-Environment Research Network (PERN) in collaboration with the Institute for Social-Ecological Research (ISOE), Frankfurt/Main, Germany to examine the theoretical and methodological aspects of research into the population-environment nexus. A total of 530 people registered to participate in the cyberseminar and 51 postings were made. The major goal of the cyberseminar was to conduct a critical evaluation of existing theory and methodology in the field of population-environment-development (PED) studies, one which seeks to bring the impact of theory on policy and praxis into focus. Secondly, this cyberseminar introduced a new social-ecological perspective to PED studies, which is the Population & Supply Systems approach. This is an interdisciplinary approach that structures the nexus of population, environment and society in theoretically and methodologically novel ways. Through the cyberseminar, the applicability of this approach was discussed by comparing it with other perspectives such as sustainable livelihoods, carrying capacity, IPAT/STIRPAT, ecological footprint and political ecology. This was PERN's first seminar focused on the theoretical and methodological foundations of PED research. A background paper by Diana Hummel, Alexandra Lux, Alex de Sherbinin, and Susana B. Seminar on Demographic Responses to Sudden Economic and Environmental Change, Kashiwa, Chiba, Japan, 21-23 May 2009

This seminar was organized by the IUSSP Scientific Panel on Historical Demography and hosted by Reitaku University. The seminar received support from Reitaku University and was held in cooperation with Lund University and the Population Association of Japan. Twenty-one participants attended the meeting, from various fields including demographers, economic historians, sociologists, statisticians, physicians and epidemiologists. The fourteen papers presented at the seminar examined the effects of sudden or unexpected economic or environmental change on the demographic behavior of individuals and families across a wide range of time—the seventeenth century to the present—and space—including Europe, Asia, the United States and Africa. Studies looked at the external changes stemming from natural as well as political and economic origins. Changes included economic stress, political turmoil, harvest failure, famine, spread of disease, earthquakes, droughts and climate change. Many of the studies applied new methods such as combined event-history and time-series analysis to novel historical and contemporary datasets with individual level information, and thereby yielded new insight into the processes by which economic and environmental pressure translate into changes in demographic behavior. The seminar was followed by a public symposium “Lessons from History: Climate, Disease, and Famine” for an audience that included 245 scholars, students and the general public. Seminar on Policy Use of Quantitative and Qualitative Indicators of Integration, Paris, France, 25-26 May 2009

This seminar was organized by the IUSSP Scientific Panel on the Integration of Migrants with the financial support of the Institut National d'Etudes Démographiques (INED), which hosted

the meeting. The seminar brought together 30 participants, mainly social scientists, working in the area of population studies, migration or integration studies. The aim of the meeting was to discuss the relationship between policy and scientific approaches to integration from the point of view of their reciprocal influences. Twelve papers and two keynote speakers explored the contrasting relationship between research designs on integration and their contribution to policy-making. Case studies in Germany, Spain, China, Australia, the United States, France, Italy and Central European countries brought to light many similarities, which were analyzed in a comparative way during discussion and in a final contribution on “The Symbolic and Instrumental Uses of Migration Data.” One of the most crucial conclusions from the seminar is that scientific studies can be policy-relevant only if they are developed in complete independence from political agendas. Seminar on Gender and Empowerment in the 21st Century in Africa, Nairobi, Kenya, 24-25 August 2009

This seminar was organized by the IUSSP Scientific Panel on Gender and the African Population and Health Research Center (APHRC), with financial support from the Dutch Ministry of Foreign Affairs. The meeting brought together researchers, policy makers, programme managers, and other development partners to share experiences on innovative policies and programmes that have pushed the region forward in promoting gender equality and women’s empowerment in some countries, as well as highlight experiences that have undermined such efforts in other settings. Sixty-three people participated in the meeting and 25 papers were presented. Papers presented at the meeting were diverse in their disciplines as well as areas of focus. A wide range of papers addressed theoretical and methodological issues while others presented empirical case studies, or analyzed policy or programme gaps on gender equality and women’s empowerment. Although a majority of the papers focused on Africa, there were also papers from other regions such as Asia for comparative insights. Substantive areas covered by the papers included methodological and measurement issues, reproductive health, HIV/AIDS, civil/armed conflicts (including sexual and gender based violence), political participation and the labour market participation, (including access to resources, poverty and education). Seminar on Social and Health Policies for Equity: Approaches and Strategies, London, UK, 2-4 November 2009

This seminar was organized by the IUSSP Scientific Panel on Health Equity and Policies in the Arab World in collaboration with the Social Research Center of the American University in Cairo and University College London, with financial support from the Dutch Ministry of Foreign Affairs. The seminar was attended by 30 participants, who represented a variety of disciplines including demographers, sociologists, health professionals and public health academics. A total of 23 papers were presented. The papers covered a wide array of social and health equity issues that explored areas such as conceptualization issues and policy implications, policy approaches in health equity, health policies and systems and equity, health information systems, and social approaches and policies for health inequity. The seminar aimed to achieve three main objectives: a) Initiate and facilitate a dialogue and collaboration among researchers, policy makers and planners in the area of health inequity, b) Exchange current knowledge on equity-oriented health policy approaches and strategies, c) Develop and evaluate new approaches and methodologies in the area of priority-setting; and d) Develop and evaluate new approaches in building health information systems. Training Activities in 2009

The 2006-2009 IUSSP Council deemed training a high priority during its mandate. In addition to continuing a policy of providing support for graduate students and junior demographers to attend IUSSP Conferences and Seminars, the Council considered other initiatives to improve the state of demographic training, particularly in developing countries. In September, the IUSSP in collaboration with UNFPA disseminated a call for proposals to create distance-based training materials on demographic estimation from limited and defective data to provide support for developing countries to analyze and use census data collected in the 2010 census.

The IUSSP includes junior demographers in its meetings as a means to contribute to their training and help them develop professional networks. In 2009, 419 junior demographers participated in the training and scientific activities sponsored by the IUSSP: 47 junior participants attended seminars and training activities and 372 attended the International Population Conference.

The IUSSP created a new panel entitled Strengthening Demographic Training in Francophone Africa which received two years of funding from the William and Flora Hewlett Foundation.

In 2009, the IUSSP organized 2 expert meetings on training issues, 1 training workshop and 1 summer school:

- Expert Meeting on Applied and Technical Demographic Training in Developing Countries: Towards an Agenda for Re-vitalisation, The Hague, The Netherlands, 26-28 March 2009, organized by the IUSSP
- Workshop in Geospatial Analysis for Attaining the Millennium Development Goals and Sustainable Development, Bonn, Germany, 20-24 April 2009, organized by The Center for International Earth Science Information Network (CIESIN) and the Population-Environment Research Network (PERN).
- Summer School on the Frontiers of Formal Demography, Rostock, Germany, 2-10 June 2009, jointly organized by the IUSSP and the Max Planck Institute for Demographic Research (MPIDR)
- Follow-up Meeting on Applied and Technical Demographic Training in Developing Countries: London, UK, 21-23 June 2009, organized by the IUSSP

Expert Meeting on Applied and Technical Demographic Training in Developing Countries: Towards an Agenda for Revitalisation, The Hague, The Netherlands, 26-28 March 2009

This meeting was organized by the IUSSP and hosted by the Netherlands Interdisciplinary Demographic Institute (NIDI), with funding from UNFPA. A group of thirty academic demographers and researchers, together with representatives from Central Statistical Offices, regional population associations, and demographic training centres met to discuss measures to improve the training of technical demographers in the developing world. The IUSSP has organized several meetings to discuss the issue of demographic training. Participants at previous meetings have concluded that the dwindling number of technical demographers and programmes that offer training in technical demography was constraining the ability of developing countries to monitor progress towards achievement of the Millennium Development Goals (MDGs), make full use of census and other data sources and incorporate demographic components into government planning. As both the 2010 census round and the 2015 deadline for achievement of the MDGs approach, the

practical importance of these constraints increases. The central purpose of this meeting was to identify cost-effective ways in which training in technical demography can be improved so that trained demographers can contribute more usefully to monitoring, evaluation and planning in developing countries. The meeting resulted in proposals for future action which will be communicated in the coming months. Training Workshop in Geospatial Analysis for Attaining the Millennium Development Goals and Sustainable Development, Bonn, Germany, 20-24 April 2009

In conjunction with the 2009 Open Meeting of the International Human Dimensions Programme on Global Environmental Change (IHDP), the Center for International Earth Science Information Network (CIESIN) at Columbia University held a five-day training workshop in geospatial data analysis techniques. The training was customized to help staff from census bureaus, health ministries, and non-governmental organizations in developing countries learn to use and apply geospatial tools to support efforts to meet the Millennium Development Goals (MDGs) and promote sustainable development. The training consisted of an overview of Geographical Information Systems (GIS) and techniques in spatial analysis, use of spatial statistics, and integration of national census and survey data with global hazards data sets. Participants from India, Philippines, Uganda, Thailand, Vanuatu, Cameroon, Benin and Chile attended the workshop, led by CIESIN geospatial applications associate director Mark Becker. Joint IUSSP-MPIDR Summer School on the Frontiers of Formal Demography, Rostock, Germany, 2-10 June 2009

Twenty students participated in the third Joint Summer School held at the Max Planck Institute for Demographic Research (MPIDR) in Rostock, Germany. The school took place over 7 days with a programme of lectures, discussion and workshops on the following topics: Modelling Human and Animal Life Histories (Shripad Tuljapurkar), Recent Advances in the Theory of Heterogeneity (James Vaupel), Analysis of Mortality Surfaces (Elisabetta Barbi), Biodemography (Annette Baudisch), Decomposition Methods (Vladimir Canudas Romo), Matrix Population Models (Hal Caswell), Demographic Life Cycle Events: Time-Plotting and Tempo Effects (Griffith Feeney), and Models of Fertility and Nuptiality (German Rodriguez). The IUSSP provided fellowships for 5 students to attend the summer school.

Expert Meeting on Applied and Technical Demographic Training in Developing Countries, London, United Kingdom 21-23 June 2009

In a follow-up to a March meeting in The Hague on this topic, a small group of experts met to draw up the terms of references for two calls for proposals to develop training materials for demography targeting developing countries. The first Call for Proposals will focus on developing a suite of resources that covers the wide variety of methods available to estimate demographic parameters from census and survey data where data is limited or defective. The call for proposals was sent out to members in August with a deadline for proposals set for 24 November 2009. A second Call for Proposals on distance-based training for population analysis is forthcoming shortly. Both projects are to be funded by UNFPA. Publications

The IUSSP disseminates scientific papers through its website and publications. Future Activities

In addition to the 26th International Population Conference and seminars held in 2009, the IUSSP and IUSSP panels were actively preparing 2010 seminars and activities. Activities in preparation include:

- Seminar on The family, the Market or the State? Intergenerational Economic Support in an Ageing Society, Geneva, Switzerland, 22-23 June 2010, organized by the IUSSP Panel on the Impacts of Population Ageing

- Seminar on the Health, Social and Economic Consequences of Unsafe Abortion, Antigua, Guatemala, 10-12 November 2010, organized by the IUSSP Panel on Abortion
- Seminar on Youth Migration and Transitions to Adulthood in Developing Countries, Rio de Janeiro, Brazil, 8-10 December 2010, organized by the IUSSP Panel on Adolescent Life Course in Developing Countries
- Seminar on the Lifespan Extension and the Biology of Changing Cause-of-Death Profiles, Rauischholzhausen, Germany, November-December 2010, organized by the Panel on Evolutionary Perspectives on Demography

Management and Finances

In 2009, the XXVI International Population Conference considerably increased IUSSP expenses as well as revenue. In addition to funding a large number of participants to attend the Conference, the IUSSP was able to set aside some registration fees from the XXVI International Population Conference in the IUSSP Reserve Funds to support future activities including preparations for the 2013 International Population Conference. As the IUSSP only holds this conference every four years, it is one of the Union's rare opportunities to raise funds to support future projects that are decided upon by the Council.

The IUSSP operating budget for 2009 was 1,330,583 € Expenses include: 608,909 € to directly support IUSSP scientific activities, including the organization and travel assistance to participants to attend the XXVI International Population Conference; 42,807 € for publications; 348,316 € spent on salary costs; 51,390 € to pay for accounting and auditing services, office furnishing and supplies, depreciation on assets and other office expenditures; 45,665 € to cover expenses for IUSSP Council and Bureau meetings, the General Assembly and reception, elections, and staff travel; and 9,415 € to cover membership subsidies for low-income country members. Additional funds for scientific activities, amounting to 181,533 € are dedicated for the expenses of scientific activities occurring in 2010. The IUSSP also incurred 31,563 € in exchange rate and exceptional losses.

In 2009, IUSSP income totaled 1,595,594 € Income sources include grants from private foundations and governments to support scientific activities and operational costs, registration fees for the XXVI International Population Conference, membership dues, and income from interest earned on investments and exchange rate gains. In addition to the direct support the IUSSP receives from donors for operations and scientific activities, the IUSSP leverages additional funds through IUSSP Panel members and their institutions. In 2009 institutions collaborating with the IUSSP reported leveraging 1,478,895 € in direct financial support from other donors for IUSSP sponsored activities, which do not appear in our accounts but give an additional indication of the scope of our activities. The Moroccan government reported contributing 1,450,000 € for the International Population Conference. This leveraged support does not include individual participants' travel expenses and, last but definitely not least, the valuable time donated by the many individuals involved in the organization of IUSSP activities

The IUSSP was able to add 265,011 € in registration fee income from the XXVI International to its reserves. As of 1 January 2010, IUSSP reserves stand at 1,804,685 € of which 763,463 € are held in general reserves, 243,883 € are in a reserve for contingencies, and 797,339 € have been set aside in special project reserves. The special project reserves include funds set aside for the 2013 International Population Conference (529,205 €), the 2013 IUSSP General Assembly (30,000 €), IUSSP Policy and Research Papers (43,134 €), a Teaching Materials Project (10,000 €), Scientific Activities (100,000 €), Technological Innovations (60,000 €) and US 501(c) Status (25,000 €). The new Council decided to set up the last three special project reserve funds: the first one to support planned scientific activities should they fail to get donor

support; the second to support technological innovation such as improvements to the IUSSP website; and the third to enable the IUSSP to obtain 501(c)3 status in the United States, which would loosen restrictions on the spending of grant funds received from US foundations and make it easier for IUSSP to apply to US-based foundations for grants.

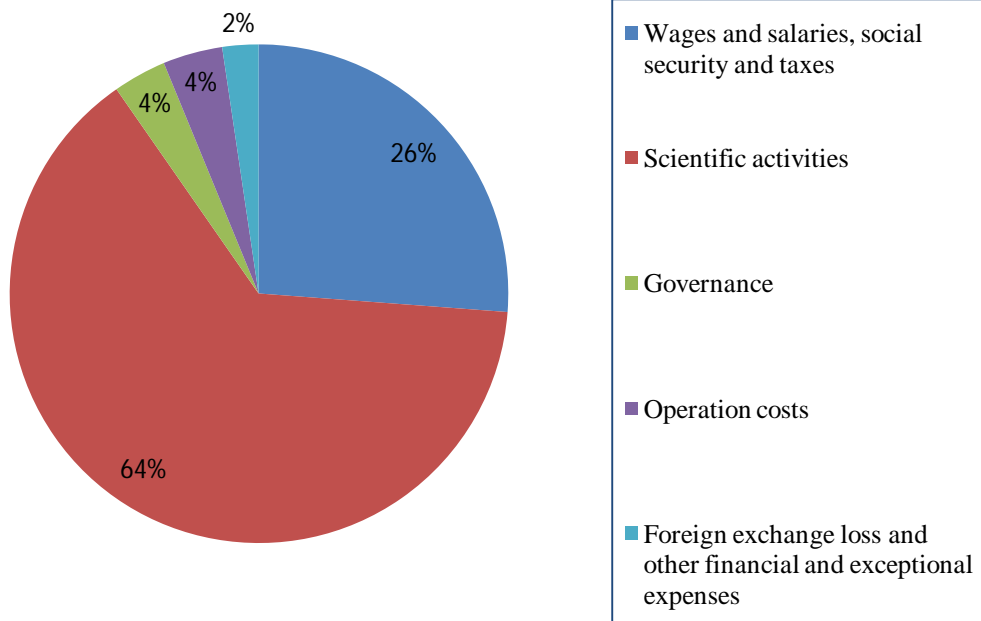
IUSSP assets are held in a secure tax-free money market account in Euros at Banque Transatlantique. The IUSSP also has interest bearing accounts in US dollars with Banque Transatlantique and with Tompkins County Trust Bank in New York, USA. The Secretariat currently has five permanent staff members who coordinate IUSSP scientific activities and publications, communicate with IUSSP members, donors and the public, maintain a website, and coordinate fundraising and reporting to IUSSP donors. In 2009 the temporary full-time Conference Assistant who was hired to handle the tasks associated with the organization of the XXVI International Population Conference was hired on as a Programme Officer to help with scientific panels. The Programme Officer, Paul Monet, was promoted to Deputy Executive Director. A temporary part-time assistant was also hired for 6 months in 2009 to help with travel awards for the XXVI International Population Conference.

The IUSSP 2009 audited accounts were prepared by the accounting firm ARICE and approved by auditors Mazars & Guérard. For further details on IUSSP revenue and expenses in 2009 see the Statement of Activities and Change in Net Assets for the Year Ended 31 December 2009 below. Comparable data for 2005-2009 are shown in that statement. The Statement of Financial Position as of 31 December 2009 shows IUSSP total assets and liabilities at the end of 2005-2009. In compliance with article D.441-4 of the French *Code du Commerce*, a table showing the balance of debts to suppliers for 2008 and 2009 can be found on page 18.

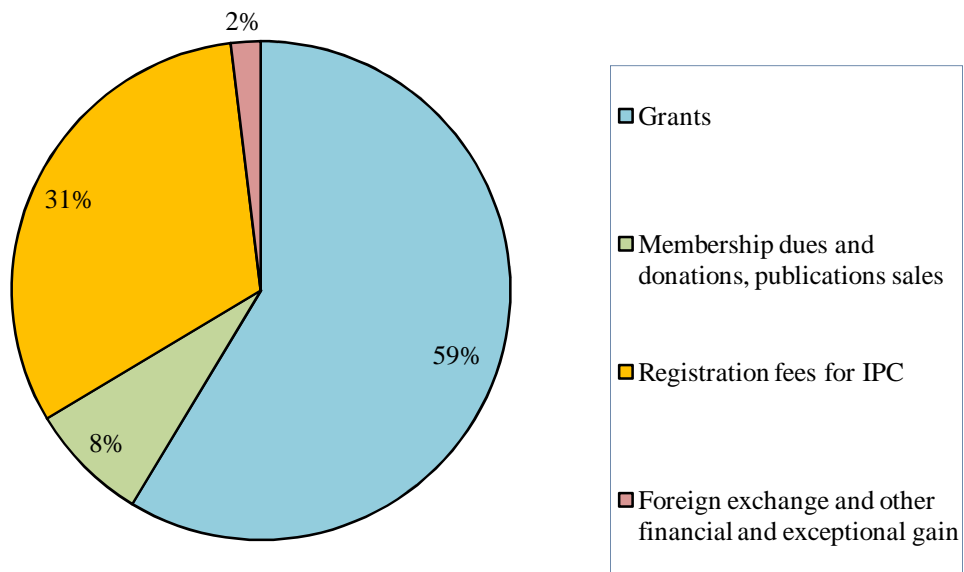
