Introduction

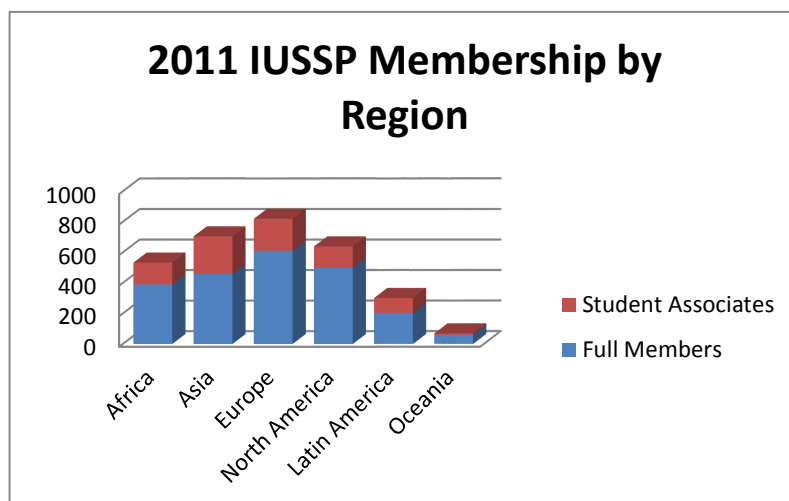
In 2011 the International Union for the Scientific Study of Population continued its work to promote population science, foster international networks of population scientists worldwide and support interaction between research and policy. The IUSSP is internationally recognized for its role in identifying emerging and critical population and development issues, encouraging scientific research on these topics, and sponsoring seminars, conferences, and training workshops at which critical issues can be discussed and debated. In recent years the IUSSP has expanded its activities to encompass more on demographic training and has sought to improve its use of the Internet as a means of communicating with members and the public. This annual report highlights recent outcomes of training activities and investments in the website and provides information on IUSSP scientific panels and seminars and the organization of the 27th International Population Conference, which will be held in Busan, Korea 26-31 August 2013.

Membership

As an association based on individual membership, the IUSSP's principal strength is its members. The majority of IUSSP activities are carried out through members' voluntary contributions of their expertise and time. At the end of 2011, IUSSP included over 2,200 full members and 846 student associates from 132 countries around the world. In 2011, 84 new members and 84 new student associates joined the Union. Women comprise 40 per cent of full members but 54 per cent of student associates, suggesting that the gender gap will narrow in the future

The IUSSP membership includes leading scholars in the field of population research. IUSSP members work for research institutes and universities in diverse disciplines—public health, economics, statistics, sociology, and the health sciences. Many provide scientific and policy expertise to governments, international organizations, businesses, and non-governmental organizations on a range of population issues including reproductive health, population ageing, pensions, health care, labour and family policy, and economic development.

Each year the IUSSP honours one of its outstanding members by bestowing its Laureate Award. The 2011 IUSSP Laureate Award was presented to Professor Donald J. Bogue. He first joined the IUSSP in 1955 and attended his first International Population Conference in 1965 in Belgrade. Donald Bogue's active and outstanding career has spanned more than six decades.



One of the prominent demographers of the last half century, he has been a strong advocate of survey research, contributing to the development of survey research tools such as the World Fertility Survey and the Demographic and Health Survey and he founded the journal *Demography*.

Scientific Panels

Scientific Panels play a key role in the planning and organization of IUSSP scientific and training activities. The current Council has adopted a policy of asking the membership for suggestions for new Panels which are then reviewed by the Council. Nine new scientific panels were approved by the IUSSP Council in 2011 along with approval for the continuation of 11 Panels. IUSSP Panels are led by a small group of international members selected for their expertise in the Panels subject area to advance research on the panel's topic. Panel Chairs were invited to select members and started preparing a programme of activities to be carried forward in 2012-2013.

IUSSP Seminars, meetings and training activities

In 2011 IUSSP Scientific Panels and their institutions organized twelve scientific meetings including seven seminars, four training workshops and a cyber-seminar. Approximately **415 individuals directly participated in IUSSP scientific activities delivering 129 papers and communications** (See Annex 6 pg. 17). Another 610 registered for PERN cyberseminars and received cyberseminar postings by email. In order to facilitate the participation of students and scholars from developing countries the IUSSP provides some travel support when funding is available. In 2011, the IUSSP provided **direct support for travel to 62 IUSSP members from developing countries** to attend an IUSSP seminar or training workshop.

Training activities

IUSSP has increased its focus on training, driven by the concern that demographic training in developing countries has weakened over the past decades as major donors withdrew support for population training programmes. Though overall financial support for training has declined, the need for professional training in demographic methods has increased as countries are asked to measure the impacts of development programmes and policies at local and national levels on health and other population indicators or report on progress towards achieving the Millennium Development Goals.

The IUSSP has embarked on three major projects to address the issue. The first two projects, both funded by UNFPA, will develop Open and Distance Learning materials on demographic estimation and population analysis. A third project, funded by the William and Flora Hewlett Foundation, focuses on strengthening training in Francophone countries in sub-Saharan Africa through a combination of short workshops and ongoing mentoring.

Open and Distance Learning Projects

In 2007 the IUSSP and UNFPA began preliminary research and meetings to explore how the IUSSP could mobilize the expertise of its members to find a cost-effective way to improve demographic training particularly in the South. After consultation with members and surveys of training institutions in Latin America, Africa, and Asia, it was decided the most cost-effective approach would be the development of distance-based training materials for classroom use by professors and for self-study by students and professionals needing to apply and understand demographic methods. Two specific projects were identified. The first project updates and creates an interactive version of the United Nation's manuals on demographic estimation for limited and incomplete data (Manual X) to facilitate the analysis of the 2010 Census Round. Following a competitive application process, a consortium based at the University of Cape Town in South Africa was chosen to undertake this project in 2010. A first draft of the manual was completed in November 2011 and is currently being reviewed and revised, and is available on line at <http://demographicestimation.iussp.org/>. The second UNFPA supported project will create web-based course materials in Population Analysis for Policy and Programmes. A contract was signed with the London School of Hygiene and Tropical Medicine in late 2011 following an open and competitive call for tender. This project should be completed in late 2012 or early 2013 and will provide approximately 130 course-work hours of interactive learning material.

Strengthening Demographic Training in Francophone Africa

The William and Flora Hewlett Foundation provided support from 2009 to 2011 to an IUSSP Panel on Strengthening Demographic Training in Francophone Africa. The impetus for the project was concern that Francophone Africa has lagged behind Anglophone African countries in key population indicators and Francophone research and training institutions in the region are not producing enough of the kind of research that could help policy makers in those countries better understand and address population issues relevant to the region. The Panel implemented an approach that combined short intensive training workshops on relevant methods not currently taught at the region's institutions with writing workshops. The objective of the workshops is to mentor a promising group of scholars (these include graduate students as well as junior faculty) to produce publishable policy relevant research on population issues of pertinence to the region. The long term objective is to improve the curriculum, teaching and research at two core institutions in Francophone Africa: the Institut de Formation et de Recherche Démographiques (IFORD) in Cameroon and the Institut Supérieur des Sciences de la Population (ISSP) in Burkina Faso. In 2011, two workshops were funded and additional training activities were held during the 6th African Population Conference in Ouagadougou, Burkina Faso. Additional support for travel and other expenses were provided by the Population Association of America and UNFPA.

The workshops proved popular, with IUSSP receiving up to 140 applications from population students and professionals in the region for each training workshop for 20-30 openings. Over the two years the Panel members provided training to over 100 participants from 18 countries in the region. Preliminary results are promising: new methods introduced have been incorporated into the curriculum at IFORD and ISSP. Participants in the seminar have applied the methods in their theses and in papers prepared for conferences and publications. Given the success of the preliminary project, the William and Flora Hewlett Foundation has agreed to fund an expanded version of the project for 2012-2013 increasing the budget to 750,000 USD.

The IUSSP disseminates the scientific results of its activities through its website, in scholarly peer-reviewed journals and in the IUSSP-Springer series International Studies in Population (ISIP). In 2011, one edited volume was published in the ISIP collection and two special issues of peer-reviewed journals were devoted to papers from IUSSP seminars. Seminar papers are made available to IUSSP members on the password-protected portion of the website and all seminar reports are available to the general public on the IUSSP website (www.iussp.org).

Website developments

Increasingly, the IUSSP communicates information on developments and opportunities in the population field to its members through its website, regular email announcements and its Bulletin enabling members to keep abreast of recent research and methodological developments and communicate their research to the scientific community, policy makers, and the interested public. The IUSSP also makes all reports from IUSSP seminars available to the public on the IUSSP website. Individual papers from seminars are available on the website to members, who must use their individual password to access the papers. In 2011, the IUSSP website received an average of 167 visits per day. The current website however lacks functionalities which would make it easier for the Secretariat or members to post new information on the website and make it easily searchable.

In early 2011, the IUSSP Council decided to invest reserve funds in a project to update the IUSSP's membership database and website and develop new software to manage abstract paper submission and review for IUSSP seminars and conferences. The new website will make it easier to post content and provide more valuable and timely information to IUSSP members and the public. It will include new features such as an events calendar where forthcoming IUSSP activities as well as other meetings and events of interest to the members will be posted; a fully searchable website and membership directory; population issues in the news; and an annotated list of links to resources and institutions in the population field. Members will have their own personal profile page which they can easily update. The new website will also make it easier to publicize research and career opportunities and in the future provide other means of interacting through cyberseminars, online forums, and email list serves. Importantly the new structure of the website and underlying databases will also enable IUSSP staff to undertake office procedures relating to, for example, payment of membership dues more efficiently.

2013 Conference in Busan, Korea

Planning continued in 2011 for the 27th International Population Conference to be held in Busan, Korea in 2013. The first meeting of the International Organizing Committee (IOC) took place in Seoul, Korea, from 10 to 11 February 2011. During this meeting, the IOC members approved the dates for the Conference (26-31 August 2013) and drafted a preliminary scientific programme for the call for papers. The Call for Papers includes 22 themes and approximately 170 sessions. Organizers and theme conveners were recruited in 2011 and a complete list of themes and sessions will be announced in 2012. The deadline for submission of papers for the conference has tentatively been set for 15 October 2012.

The IUSSP Council visited Busan and the BEXCO Conference Centre, which will provide space for 15 parallel sessions, a large auditorium for plenary sessions, and plenty of open space for exhibits and poster sessions. Korean organizers believe the conference will stimulate discussion on critical population issues facing the region—population ageing and low fertility—as well as provide an opportunity to examine Korea’s rapid transition from one of the world’s poorest countries with very high fertility to a wealthy country with very low fertility in the space of 25 years.

Management and Finances

In 2011, IUSSP income totalled 743,595 €. Income sources include grants from private foundations and governments to support scientific activities and operational costs, membership dues, and income from interest earned on investments and exchange rate gains. In addition to the direct support the IUSSP receives from donors and institutions for operations and scientific activities, the IUSSP leverages additional funds through IUSSP Panel members and their institutions, which are not included in our accounts.

The IUSSP operating budget for 2011 was 782,507 €. Expenses include: 280,307 € to directly support IUSSP scientific and training activities; 83,382 € for publications and the IUSSP website; 312,529 € spent on salary costs; 63,791 € to pay for accounting and auditing services, office furnishing and supplies, depreciation on assets and other office expenditures. This amount also includes a provision of 22,063 € for exchange rate losses as of 31 December 2011 concerning a contract in USD with the London School of Hygiene and Tropical Medicine; 20,981 € to cover expenses for IUSSP Council and Bureau meetings. Additional tied funds from donors for scientific activities, amounting to 4,953 € are dedicated for the expenses of scientific activities that will take place in 2012. The IUSSP also incurred costs of 14,609 € in exchange rate and exceptional losses. Finally as IUSSP is required to pay the corporation income tax on investments (10% of investment earnings), a debt for corporation income tax has been recorded related to IUSSP 2010 capital investments and a 2011 investment in a bond subscription.

The IUSSP operating budget exceeded IUSSP income by 38,959 €. This was due to the addition of several new projects for which the Council authorized the use of reserve funds: the development of the IUSSP website, membership and Conference abstract submission software, which included hiring a web development company, Actualys, and expenses associated with the planning for the 2013 International Population Conference. The IUSSP covered these expenses by drawing on special reserves set aside for the International Population Conference (11,141 €) and for Technological Innovations (27,818 €).

As of 1 January 2012, IUSSP reserves stand at 1,710,695 €, of which 563,463 € are held in general reserves, 243,883 € are in a reserve for contingencies, and 903,349 € have been set aside in special project reserves. The special project reserves include funds set aside for the 2013 International Population Conference (481,821 €), the 2013 IUSSP General Assembly (30,000 €), IUSSP Policy and Research Papers (43,134 €), a Teaching Materials Project (10,000 €), Scientific Activities (93,543 €), Technological Innovations (219,851 €) and US 501(c)(3) Status (25,000 €).

The assets of the IUSSP are held in several secure investments. In 2011, the IUSSP subscribed to a bond issued by BFCM for a total of 250,000 €. This bond has an annual coupon of 4,10% and a maturity of 5 years. In addition, the capital investment subscribed at the end of 2010 (500 000 Euros) resulted in interest earnings in 2011 of 17,377 Euros. The remaining assets have been placed in a tax exempt Euro SICAV account with Banque Transatlantique. The IUSSP also has U.S. dollar account with Banque Transatlantique and with Tompkins County Trust Bank in New York, USA.

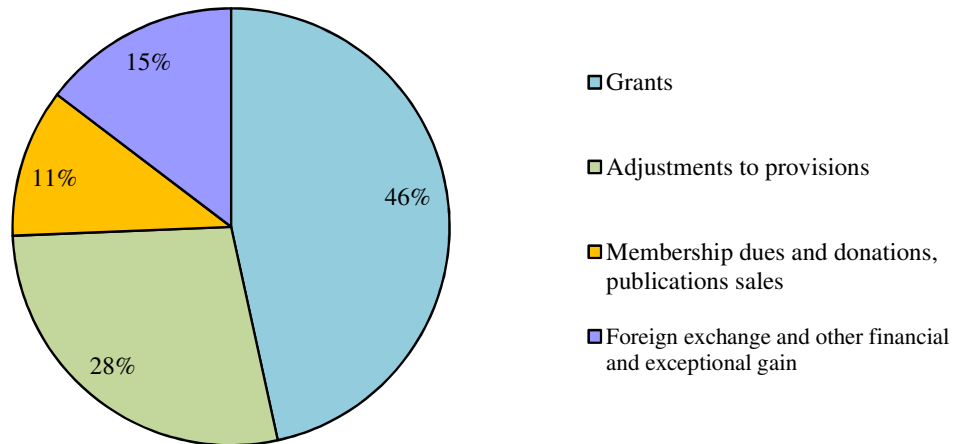
The Secretariat currently has four permanent staff members who coordinate IUSSP scientific activities and publications, communicate with IUSSP members, donors and the public, maintain a website, and coordinate fundraising and reporting to IUSSP donors.

The IUSSP 2011 audited accounts were prepared by the accounting firm ARICE and approved by auditors Mazars & Guérard. For further details on IUSSP revenue and expenses in 2011 see the Statement of Activities and Change in Net Assets for the Year Ended 31 December 2011 below. Comparable data for 2008-2011 are shown in that statement. The Statement of Financial Position as of 31 December 2011 shows IUSSP total assets and liabilities for the period 2008-2011. In compliance with article D.441-4 of the French *Code du Commerce*, a table showing the balance of debts to suppliers for 2011 can be found on page 15.

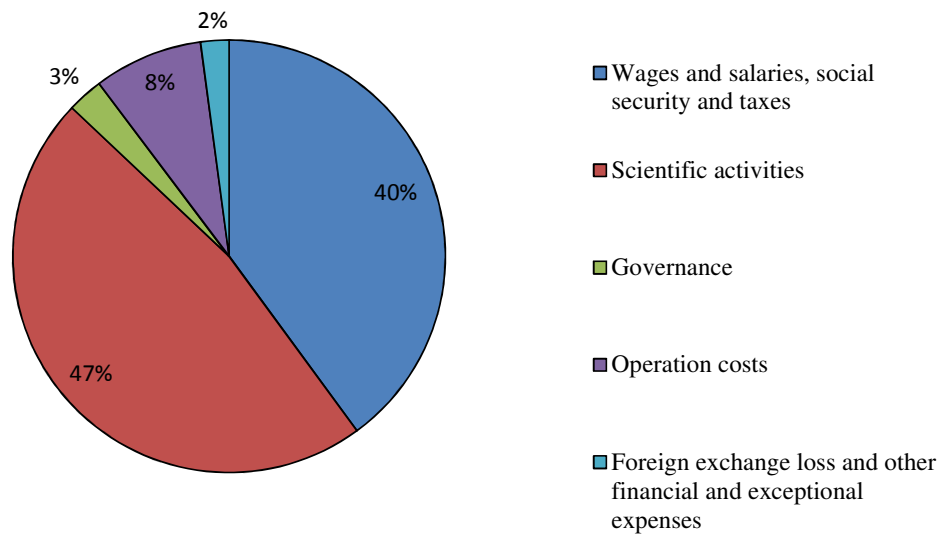

Annex 7: Summaries of 2011 Scientific Meetings

More detailed information on meetings and workshops organized by the IUSSP in 2011 is presented below by date of occurrence.

Seminar on Lifespan Extension and the Biology of Changing Cause-of-Death Profiles: Evolutionary and Epidemiological Perspectives, Rauischholzhausen, Germany, 13-15 January 2011.

This meeting was organized by the IUSSP Scientific Panel on Evolutionary Perspectives in Demography in collaboration with the University of Marburg and with financial support from the German National Science Foundation. The workshop brought together 18 participants, experts and observers from different disciplinary backgrounds to discuss changing morbidity and changing cause-of-death profiles over the life course in stable or varying environments. Fourteen research papers were presented at the workshop. A selection of the papers should be published in *Biodemography and Social Biology* in 2012. Seminar on New Challenges in Population and Development, Belo Horizonte, Brazil, 14-15 June 2011.

This seminar was jointly organized by the IUSSP Scientific Panel on New Challenges in Population and Development and the Center for Regional Development and Planning of the Universidade Federal de Minas Gerais (CEDEPLAR), with financial support from UNFPA, the State of Minas Gerais Research Council (FAPEMIG) and the Federal Agency for Tertiary Education (CAPES). This seminar was preceded by a one-day seminar on Current Issues and Frontiers in Demographic Methods to honour Professor Jose Alberto de Carvalho for his retirement and new position as Emeritus Professor of Demography at CEDEPLAR. He was also honoured as former President of the IUSSP. The following two days were devoted to the IUSSP seminar, which was attended by 44 participants. Fifteen presentations were made by some of the main international experts in the field of population, including scholars in demography and economics, and policy makers. The aim of the seminar was to highlight new issues in population and development and contribute to the debate on the new agenda for the next ten years. The seminar addressed four main themes: Population Growth and Economic Growth Models; Age Structure and Economic Growth; Demographic Transition and Economic Development; and the Demography of BRICS and New Challenges for Developing Countries in Advanced Demographic Transition Stage. Both seminars were broadcasted live by Cedeplar on a web-link also made available on the IUSSP website. Seminar on Demography in the 20th Century: Concepts, Methods and Uses, Geneva, Switzerland, 26 September 2011.

This meeting was organized by the IUSSP Scientific Panel on Historical Demography, in collaboration with the Société de démographie historique and the Swiss National Centre of Competence in Research “LIVES” (overcoming vulnerability: life course perspectives). The one-day Francophone seminar, open to students, brought together 18 participants to discuss demography in the twentieth century, its concepts and tools as well as the scholarly and non-scholarly uses that were made of its results. A long-term approach was deliberately chosen in order to show the discipline’s evolution over time and highlight how certain concepts were used at certain times and sometimes abandoned. Eight papers were presented in two sessions. The first session was devoted to the main types of surveys that were conducted between 1950

and 2010. The second session focused the evolution tools, concepts and methods used by demographers. A final round-table discussed the issue “Why and How to Teach Demography?” The seminar report and programme (in French) are available at: <http://www.iussp.org/Activities/his4-index.php>.

IUSSP Seminar on Global Perspectives on Marriage and International Migration, Seoul, South Korea, 20-21 October 2011.

This seminar was organized by the IUSSP Scientific Panel on the Process and Dynamics of Cross-Border Marriage in cooperation with and with financial support from Statistics Korea and the Korea Institute for Health and Social Affairs (KIHASA). A total of 72 participants attended the seminar from various fields including scholars in demography, anthropology, economics, sociology, history, statistics and health science, as well as a welfare policy expert under the Prime Minister’s office in Singapore and 16 policy makers in the Korean government. The aim of the seminar was to gather cutting edge papers on issues related to the relationships between marriage and international migration. A total of 17 papers were presented, including papers providing a national or regional overview, specific case studies, quantitative analyses, and small-scaled qualitative studies from various perspectives. A documentary video filmed by a marriage immigrant from Japan was also presented. The seminar was covered by various domestic newspapers and magazines and by a journalist working for *The Economist*. The seminar proceedings will be published by a Korean publisher and four of the papers using a qualitative approach will be published in *Asian and Pacific Migration Journal*. Workshop on The b Hypothesis and the Modal Age at Death, Rostock, Germany, 24-25 October 2011

This workshop was organized by the IUSSP Scientific Panel on Social and Biological Determinants of Longevity, with financial support from the Max Planck Institute for Demographic Research (MPIDR). A group of 19 researchers, including demographers, bio-demographers, mathematical demographers, and biologists, were invited to discuss new ideas and findings and deep knowledge on the rate of ageing, selective survival and compression of mortality. Eleven research papers were presented at the workshop. These papers included empirical studies on historical and contemporary populations as well as methodological papers. The first day of the workshop was devoted to research on the “b-hypothesis”, that is on the rate of ageing of the human population (b is usually used as symbol for the slope parameter of a Gompertz curve). The second day of the workshop was devoted to the modal age at death and mortality compression. Cyberseminar on Preparing for Population Displacement and Resettlement Associated with Climate Change and Large Climate Adaptation and Mitigation Projects, 1-14 November 2011.

This cyberseminar was organized by the Population-Environment Research Network (PERN) to address population displacement and the potential need for organized resettlement owing to climate change and associated adaptation and mitigation projects. The seminar was based in part on discussions that took place at a November 2011 Bellagio Conference on the same topic. A background paper by Alex de Sherbinin and 7 experts statements were made available for discussion before the seminar. Forty-seven researchers posted contributions, which were accessible to the 610 subscribers to the PERN-Seminars list. To view postings,

Seminar on Internal Migration and Urbanization and Their Socioeconomic Impacts in Developing Countries: Challenges and Policy Responses, Fuzhou, China, 10-12 December 2011.

This seminar was organized by the IUSSP Scientific Panel on the Impact of Internal Migration and Urbanization in Developing Countries, in collaboration with Fujian Normal University and the University's School of Geography and Center for Population and Development Research. The seminar was funded by the International Development Research Center of Canada (IDRC), United Nations Population Fund (UNFPA), Asian Development Bank (ADB), and Fujian Normal University. The seminar provided a forum for demographers, sociologists, geographers, economists, and public health specialists from both academic and policy fields to discuss cutting-edge issues concerning internal migration and urbanization and their socioeconomic impacts in developing countries. Forty-six participants from 16 countries and 3 major international organizations attended the seminar. Some 36 papers were presented at the seminar, covering a wide range of themes. Presentations and discussions at the seminar highlighted the increasingly important roles of internal migration and urbanization in the population and socioeconomic changes being experienced in developing countries, the diversity and complexity of their patterns and consequences, and their roles in individual and household livelihoods, and in connecting people and places of origin and destination. Seminar discussion also called for greater efforts to accurately measure and conceptualize migration and urbanization processes, to generalize relevant findings from different contexts and spatial settings, to build theory and to translate research results into effective policies. Seminar on New Approaches to Urban Health and Mortality during the Health Transition, Seville, Spain, 15-16 December 2011

This seminar was organized by the IUSSP Scientific Panel on Historical Demography, in collaboration with the Instituto de Estadística y Cartografía de Andalucía (IECA) and the Consejo Superior de Investigaciones Científicas (CSIC). The event was also supported by the Asociación de Demografía Histórica (ADEH), the Grupo de Dinámicas Demográficas del CSIC and the Grupo de Estudios de Población y Sociedad (GEPS). Financial support was provided by the Institute of Statistics and Cartography of Andalusia (IECA), the Spanish National Research Council (CSIC), and the Ministry of Science and Innovation (MICINN). The seminar brought together 37 participants from different regions of the world and with various disciplinary backgrounds, principally demography, epidemiology, history and statistics. The general aim of the meeting was to address two priority axes of the IUSSP Panel on Historical Demography: the renewal of urban historical demography and revisiting of the demographic transitions with longitudinal data and methods. The 20 papers presented at the meeting tried to shed a new light on the variety of the urban population mortality experience and health related behaviours, making use of individual micro-level longitudinal data. Longitudinal historical databases were linked with present data material to analyse aspects such as intergenerational inheritance of certain demographic behaviours and interactions between, on one side, individual trajectories leading to survival or death, and on the other side, institutional activities and policies that explain the transition from an urban over-mortality to an urban under-mortality. Annex 8 : Summaries of 2011 Training Workshops

Training workshop on Designing Fertility Analyses in the Context of Low Fertility, Honolulu, USA, 4-18 June 2011

This training workshop was organized by the IUSSP Scientific Panel on Below Replacement Fertility: Causes, Consequences and Policy Responses at the East-West Center (Honolulu, Hawaii) as part of the 42nd Summer Seminar on Population. The workshop agenda consisted of four main components. (1) Overview of fertility decline to very low levels in different parts of the world; (2) discussion on key factors associated with this trend; (3) introduction of new methodologies for analyzing fertility decline and its causes, and (4) individual work and presentation of research designs. Three sets of topics were covered: analysis of postponement and recuperation of childbearing; multidimensional life table analysis of the total fertility rate and its components; and methods for measuring and analyzing the influence of community-level variables. Participants were asked to do three presentations, one on the trends and pattern of fertility decline in one or more countries; one on data availability for fertility analyses in their countries, together with a critical evaluation; and one on the design of a fertility survey or an analysis of below replacement fertility. Training workshop on Writing and Policy Communication, Yaoundé, Cameroon, 10-15 January 2011.

This training workshop was organized by the IUSSP Scientific Panel on Strengthening Demographic Training in Francophone Africa, with the collaboration of the Institut de formation et de recherche démographiques (IFORD) and Cornell University (USA) and with funding from the William and Flora Hewlett Foundation. The workshop included eleven participants, all of whom were the group leaders from the previous Training Workshop on Advanced Statistical Methods held at IFORD in October 2010. They came to the workshop with drafts of their team papers based on the data analysis they had completed in the Advanced Statistics Workshop, applying decomposition methods to regional data on several socio-demographic indicators. The workshop resulted in 9 papers to be submitted for presentation at Conferences, in particular the African Population Conference in Ouagadougou, in December 2011 or to be submitted for publication to the *African Population Studies* Journal. Training workshop on Decomposition Methods, Multilevel Analysis and GIS, Marrakech, Morocco, 19-25 September 2011.

The IUSSP Panel for the Strengthening of Demographic Training in Francophone Africa organized a Training Workshop on Decomposition Methods, Multilevel Analysis and GIS, which was held in Marrakech, Morocco, 19-25 September 2011. The workshop was organized in collaboration with Cornell University, and with financial support from The William and Flora Hewlett Foundation, UNFPA and the Population Association of America (PAA). Originally planned to take place in Ouagadougou in June 2011, the workshop was postponed due to political instability at the time and relocated in Marrakech, which enabled organizers to increase the number of Moroccan participants. In the end, 37 participants attended the workshop, from 15 countries in the region. Participants included 25 junior scholars (graduate students and junior faculty and researchers) and 12 senior researchers and faculty. The aim of the workshop was to provide a general introduction to decomposition methods, multilevel analysis and Geographic Information Systems (GIS) and enable participants to apply these methods to the study of recent changes in Africa on one of the following research topics:

mortality/health, marriage, fertility, education/schooling, gender relations, environment and migration. Participants were able to apply the methods to the specific data they had brought for the workshop, usually based on DHS datasets from their countries. Training workshop on Presenting Demographic Research Findings, Ouagadougou, Burkina Faso, 3-4 December 2011.

This third training workshop was organized by the IUSSP Scientific Panel on Strengthening Demographic Training in Francophone Africa just before the Sixth African Population Conference held in Ouagadougou, Burkina Faso, 5-9 December 2011. The workshop included 26 participants and consisted mainly of authors of papers that were written using the advanced statistical methods learned during previous training workshops. The aim of this workshop was to help authors presenting their papers at the UAPS conference improve their presentations and presentation techniques. The 2nd day of the workshop was organized by the Population Reference Bureau (PRB) for a larger group of participants with the same general objective and was conducted in English.
